Biographical Information for Philip L. Dubois

Philip L. Dubois has been Chancellor at UNC Charlotte since July of 2005. He is the UNC System's longest serving Chancellor. Previously, he served as President of the University of Wyoming (1997-2005).

Since 2016, Dubois has served as a member of the Board of Directors of Division I of the NCAA and its executive committee. While at Wyoming, Dubois was also a member of the Division I Board (2004-2005).

He has served as a director of four Division I athletic conferences, including the Western Athletic Conference, the Mountain West Conference, the Atlantic 10, and Conference USA. Dubois was one of the five founders of the Mountain West Conference, and was elected to lead the conference as its first Chair (1998-1999).

Dubois has been actively engaged with several advisory committees related to the governance of intercollegiate athletics, including the NCAA Presidential Advisory Group (2008-12), the NCAA Fiscal Responsibility Oversight Group (2008-2012), and the NCAA President's Task Force on the future of Division I (2005-2006). In 2013-2014, Dubois chaired the UNC President's Athletics Financial Transparency Working Group which resulted in financial reporting standards adopted by the UNC Board of Governors.
