Overview

- Overlapping Federal Coronavirus Relief
 - Elementary and Second Schools Emergency Relief Fund (ESSERF)
 - Governor's Emergency Education Relief Fund (GEERF)
 - Higher Education Emergency Relief Fund (HEERF)
- Coronavirus Relief Fund (CRF)
 - K-12 Public Schools (SBE and DPI)
 - North Carolina Community Colleges System (NCCCS)
 - University of North Carolina System (UNC)



Elementary and Secondary School Emergency Relief Fund (ESSERF)

- CARES Act (ESSERF I) \$396M
 - Given directly to LEAs based on Title I funding
 - SBE allowed to withhold 10%
 - Broad allowable use
- Consolidated Approps. Act (ESSERF 2) \$1.6B
 - Same distribution
 - Similar uses, although can also be used on ventilation systems and learning loss

Governor's Emergency Education Relief Fund (GEERF)

- CARES ACT (GEERF I) \$96.5M
 - K-12 Spending:
 - \$40M for health support services for students
 - \$20M for instructional support for at-risk students
 - Higher Ed Spending:
 - UNC: \$6.6M
 - Private Colleges/Universities: \$4M
 - NCCCS: \$15M
- Consolidated Approps. Act (GEERF 2) \$42.9M
 - Plus \$83M for non-public schools



Higher Education Emergency Relief Fund (HEERF)

■ CARES Act (HEERF I) - \$466.2M

■ UNC: \$248.9M

■ NCCCS: \$126.6M

Private: \$90.8M

 For most schools, half of the funds had to be used for direct student aid, while the other half could be used for institutional support (including lost receipts).

- Consolidated Approps. Act (HEERF 2) \$790M (est.)
 - Distribution formula modified from CARES Act
 - Estimate: \$398M UNC, \$246M NCCCS, \$145M Private

K-12 COVID-19 Policy Changes

- Transportation allotment flexibility
 - S.L. 2020-97 gave LEAs the flexibility to use transportation allotment funds for school nutrition, child care, sanitizing schools and buses, PPE, or remote instruction.
- Virtual charters
 - Student enrollment cap increased by 3,800 students, from 5,537 students to 9,337 students

- ADM hold harmless
 - FY 2020-21
 - If an LEA's ADM decreased from what was allotted this year, no change was made to their funding
 - FY 2021-22 (TBD)
 - Definition of Allotted ADM
 - Projection of students returning
 - General Assembly action
