
### **NORTH CAROLINA – SRRMS OVERVIEW**

- In 2015, the General Assembly established the School Risk and Response Management System (SRRMS). The statewide system is designed to enable the efficient gathering, communicating, and displaying of data to assist school officials and first responders in preventing, preparing and responding school safety hazards.
- The SRRMS is comprised of five key components:
  - Digital Building Floorplan Schematics and Asset Identification; Complete
  - School Risk Management Planning (SRMP) Application; Complete
  - Anonymous Student Safety Tip Application (SPKUP); Complete
  - State Emergency Response Application (SERA); and, Complete
  - Digital Panic Alarm Application. Legislatively required, not funded



### **NORTH CAROLINA – SRRMS PANIC ALARM PILOT**


- The 2017, the General Assembly tasked the North Carolina Department of Emergency Management (NCEM) to perform a proof-ofconcept pilot on a statewide panic alarm program.
- Legislative direction was to leverage the pilot program to select a solution for a statewide mobile panic button program
- Extensive vendor interviews and tests conducted in across the state
- NCEM released a report in April 2018 and testified in November of 2018 with their Panic Button recommendation




### **NORTH CAROLINA'S SERA APPLICATION**


- SERA is a web-based application designed to assist emergency responders and public safety as they respond to hazards and threats at K-12 and Higher Education facilities.
- SERA Leverages data and information documented in School Risk Management Plan (SRMP) and Higher Education Risk Management Plan (HERMP).
- SERA presents profile and process information and spatially displays school floorplans, key assets, and vulnerabilities.



### STANDARDIZED SCHOOL SAFETY RESPONSE PLATFORM



Providing ubiquitous coverage through a scalable option that can be deployed across all facilities quickly and effectively



Cost effective, and the ability to implement without the need for construction or building upgrades and can be deployed by start of school year



Non-intrusive security that arms individuals with technology providing tools on the ground



Does not require costly hardware installations that must be maintained and replaced over time



Standardized communication tool to enhance interoperability that allows first responders from multiple jurisdictions to communicate during multiagency response
