

PROJECTED U.S. POPULATION INCREASES, 2000 TO 2030

By 2030, the U.S. population is expected to increase by 29.2 percent, with most of that growth occurring in the Southeast and West. At 52 percent, North Carolina's projected growth is the seventh highest in the country.


- Population decrease

- More than 100 percent increase



SEHSR Corridor Development Plan

- Charlotte to Washington, DC 475 miles
 - Charlotte to Raleigh 90 mph
 - Raleigh to Richmond 110 mph
 - Richmond to Washington 90 mph
- Eight daily train pairs:
 - 4 Charlotte to Raleigh & 4 to Charlotte to Washington, DC
- Final design, ROW and construction Raleigh to Richmond
- Safety projects 500+ miles of highway & 125 bridges
- Positive Train Control (PTC) by 2015
- New Stations in Cary, Charlotte & Raleigh





SEHSR Corridor Development Plan

- ARRA and PRIIA
- Competitive, discretionary grants
- January 28, 2010 ARRA Award of \$545M
- Annual appropriations process for PRIIA
- MOUs with Amtrak, Norfolk Southern, NCRR and CSX Transportation
- Synergy; safety, capacity, corridor services
- Letter of Intent (LOI)





NCDOT Approach

- \$\$\$ larger than staff capacity => draft NCDOT project managers
- Meanwhile
 - Extend existing LSAs for 1 year
 - Initiate qualifications process to grow LSA capability
- Use SEHSR experience for QA/QC
- Use ARRA \$ to get folks to work (peanut butter is good!)
- Use ARRA to build partnerships
- Encourage growth in minority and women-owned businesses
- Build upon existing expertise and use SEHSR to transform





What kinds of work?

- Environmental, PE, ROW
- Detailed property surveys, final design, grading
- Construction management
- Highway and railroad work both design and construction
 - Both off-line and force account railroad work
- Bridges
- Accounting, auditing, reporting
- Public relations & communications






Jobs
