

Hurricane Matthew Impacts



Hurricane Matthew Damage



- 31 fatalities
- 50 Counties declared
- Estimated \$4.8 billion in damage
- Nearly 100,000 homes impacted
- Over 4,000 evacuees in shelters
- 660+ roads closed
- 20 dams breached
- 815,000+ power outages
- 2 airports closed
- Over 3,000 families stayed in FEMA transitional sheltering. NCEM assumed responsibility for remaining need

Recovery Progress



Over \$632 million already on the ground

- \$98.9 M in grants to help individuals with home repairs and immediate needs- 26,000 families
- \$141.9 M to repair critical public infrastructure
- \$102.5 M in loans to help homeowners & business owners repair & rebuild
- \$195.9 M for flood insurance payouts
- \$85.9 M in state funds to support homeowner, small business and infrastructure recovery
- \$4.5 M for disaster case management
- \$2.2 M for crisis counseling



Hazard Mitigation Grant Program

HMGP funds help homeowners avoid future storm damage through elevation, relocation or reconstruction.

- Largest HMGP program since Floyd
- Enhanced HMGP earned additional \$25M, or 210 more homes
- 2,987 survivors applied, 800 submitted with expedited progress
- Expedited process after Matthew
2011 - 300 applications in 18 months
2016 - 3,000 applications in 12 months
- Currently, \$115 M will be available for the HMGP including state matching funds
- *Map represents losses avoided*





Community Development Block Grant-Disaster Recovery

- CDBG-DR is long-term disaster recovery funding for states following major disasters
- This is NC's first CDBG-DR program on this scale
- CDBG-DR money doesn't arrive in a lump sum to states
- NC draws down, case-by-case, \$236.5 M
- An additional \$168 M expected
- Before states can draw down funds, multiple steps must be completed including the development of an Action Plan

reimburses the county*




*Commerce draws down CDBG-

CBDG-DR 8-Steps

1. **Application** – submit required documents
2. **Eligibility** – verify primary residence, non-foreclosure, etc.
3. **Duplication Check** – verify assistance provided already, review receipts, determine amount available
4. **Inspection & Environmental Review** – coordinate inspection, verify damage types
5. **Grant Determination** – configure award amount
6. **Contractor Selection** – bid scope of work, finalize construction agreement
7. **Construction** – ensure home meets HUD standards
8. **Completion** – secure flood insurance, verify construction finished



Background Information



CBDG-DR Start-up

- ✓ Developed & submitted federally required State Action Plan
- ✓ Held federally required public meetings
- ✓ Received approval of State Action Plan
- ✓ Developed sub-recipient agreements with local partners
- ✓ Expedited timeline by using state funds to open 4 Application Centers in most impacted counties
- ✓ 2-1-1 making appointments and checking status
- ✓ Currently receiving applications and moving applicants through the 8 steps

The Road Ahead



First Checks and Awards Delivered

- First CDBG-DR reimbursable check has been delivered to a homeowner in Robeson County.
- First reimbursement check from state DRA-17 funds delivered to a homeowner in Johnston County.
- 5 HMGP grants for a total of \$2.2 M are approved for Nash County, Moore County, Camden County and City of Fayetteville.
