Due to the word limits on this public web portal, we will submit a more detailed version of this letter to you via email with the specifics of this proposal.</p> <p>The 76 undersigned organizations from across North Carolina deeply appreciate your service in a time of crisis, and your proactive response by convening the House Select Committee on COVID-19. Together we urge you to act swiftly to enact policies that will ensure the well-being of our state's children and their families, and help us all to recover as quickly as possible once the crisis is over.</p> <p>While our state has certainly experienced challenging times before, we have never been asked to rise to a challenge of this magnitude. We are in a time of unprecedented danger, to our health and economy, and we ask that your legislative actions be proportional to the dire challenge before us.</p> <p>We respectfully submit the following priorities for children and families, and urge you to enact them as quickly as possible:</p> <ol style="list-style-type: none"> <li>1. Enact a \$125 million Child Care Emergency Economic Support Package, put forth by the NC Early Education Coalition, to assure the availability of emergency child care and prevent the collapse of North Carolina's early education system.</li> <li>2. Ensure that children and families are not hungry by appropriating emergency funding, and waiving restrictions for food relief programs during this public health crisis.</li> <li>3. Enhance North Carolina's technology infrastructure to enroll and provide relief services virtually and efficiently. This includes allocating funding for NCDHHS to strengthen the online application process for public benefit programs, and eliminating state restrictions on the ability of local governments to invest in broadband infrastructure.</li> </ol>

As members of the North Carolina Anti-Hunger Coalition, we appreciate the opportunity you have provided for us to submit suggestions to the House Select Committee on COVID-19.</p> <p>As you know, hunger was a pressing issue across our state long before the COVID-19 public health crisis. According to the USDA's 2017 report on food insecurity, one in five children in North Carolina struggled with hunger, and nearly 590,000 North Carolina households did not have enough to eat each day. Due to the widespread economic disruption this crisis is causing, we expect this number to grow dramatically in the coming weeks, as some emergency food providers report an increase of up to 70% in the number of clients served in just the past three weeks.</p> <p>During this time of great uncertainty and stress, it is paramount that we work together to lift the barriers to food access faced by these families and prevent additional North Carolinians from going hungry. We applaud the swift action you have taken to mitigate the harm this crisis will have on the people in our state.</p> <p>We recognize that the situation on the ground is continuously changing, and that these recommendations may need to be updated and revised. We offer the following initial recommendations to complement emerging policy and fill damaging gaps as the COVID-19 response is operationalized.</p> <p>We ask the State to provide an additional \$6 million in immediate funding to the North Carolina Feeding America food banks. This funding must be flexible to allow food banks to purchase the additional food required to respond to the crisis due to the closing of schools and layoffs caused by the appropriate government-required closings. In addition, these funds should help support the management, storage, and transportation of these critical food resources as well as additional labor required to manage the growing need and the loss of community volunteers (a large pool of which are older adults) resulting from social distancing requirements.</p> <p>To support our farmers, we ask the State to:</p> <ul style="list-style-type: none"> <li>work with local officials to ensure farmers markets remain open;</li> <li>allocate additional resources to help farmers comply with CDC recommendations to</li> </ul>
