I was honored to serve the people of North Carolina in the General Assembly for twenty years. I have no doubt that they are resilient, and that they will rise to the challenge that this public health emergency presents. However, in my nearly four decades of public service, North Carolina has never faced a challenge a great as it will face if this disease is not properly managed. President Trump has called on all political leaders to stop the partisanship and come together to confront the coronavirus pandemic. As you know, the coronavirus is a life or death crisis, not a partisan crisis.

It is my responsibility and honor to lend my support to help citizens in North Carolina in times of individual and family crises and to continue to promote economic and social mobility within the 12th Congressional District and across our state. During this public health crisis, we must assist every resident in taking preventative measures. I will continue to work in Congress to support and pass legislation that will swiftly address this crisis and save lives in Mecklenburg County, North Carolina, and across the country.

However, there is work that can be done at home in the Old North State. We already have identified hundreds of confirmed cases of the coronavirus in North Carolina. The threat is here and must be addressed faster than the usual speed of government. While Governor Cooper correctly declared a state of emergency, taken decisive action to limit the spread of the virus, and has acted swiftly to address the crisis, a special session of the North Carolina General Assembly could improve our public health resilience by:

- Suspending utility disconnections and reconnecting affected households: The Centers for Disease Control recommends hand-washing as the number-one preventative measure to take to stop the spread of disease. With the recognition that hygiene is a public health priority, now more than ever, The State of North Carolina should work with our public utilities to reconnect or restore water service for residents, and suspend disconnections for 90 days. This is not a unique idea. The City of Detroit has released a "Coronavirus COVID-19 Water Restart Plan" in which the State of Michigan pays their \$25 reactivation fee and resumes service at no fee to the customer. Mayor Keisha Lance Bottoms of Atlanta has halted disconnections for 60 days. Charlotte Mayor Vi Lyles and other mayors across the state have done the same.
- Suspending foreclosures and evictions and/or mortgage and rent assistance: Due to the likely economic impacts of this virus, many families are expected to experience cash flow issues. They should not be forced to leave their houses, especially if they are self-quarantining. The State of North Carolina should work with lenders, landlords and local authorities suspend foreclosures and evictions for 90 days, as well as investigate ways to provide mortgage and rent assistance that is not subject to source of income discrimination. Already, Mecklenburg Sheriff Garry McFadden has said the Sheriff's department will no longer enforce eviction orders during this crisis, and the State Courts have effectively suspended foreclosures and evictions; however, these should not immediately resume when the crisis is over and residents are getting back on their feet.
- Expanding Medicaid: Insuring as many people as possible is vital during a public health crisis. Citizens should not be afraid to seek medical attention if they can not afford it.

			Please do not forget 1099 workers, contract employees, and others who do not have traditional relationships with employers and/or whose income fluctuates. Means testing or thresholds to qualify for individual support, tax breaks for companies, and payroll tax cuts leave these workers out. For example, I am a "small business owner," but I am an independent consultant who relies on contracts with businesses. The potential clients in my pipeline are currently pumping the brakes on our project conversations due to economic uncertainty, yet I would not qualify for unemployment, the money I made in previous years would not accurately reflect my current financial situation, and support plans aimed at traditional employment arrangements would not reach me—but the detriments to both my livelihood and my ability to provide for my family are just as real.
			Secondly, please keep in mind that while businesses are struggling and many workers are without their regular income, bills are still coming due rent and mortgage payments, utilities, mobile phones and other line items in the family budget are getting bigger with more people at home all day, including groceries and food delivery services. Yes, businesses need help; that is obvious. But the people of this state need direct and immediate help keeping the lights on at home.
			Lastly, I would ask that you also consider the impact that income loss - in whatever form - will have on people's access to health insurance. While it is never a good time to toy with people's health or ability to afford the care they need, now is certainly not the time.

I am extraordinarily concerned about my ability to effectively serve my clients while keeping them, myself, and my staff safe during this pandemic. All wills, healthcare powers of attorney, and advance directives require 2 witnesses (who are not family members or healthcare providers) and notarization of the signatures of the signer and both witnesses. All durable powers of attorney also require notarization. The current notarial regulations
			require in-person verification of signatures, which is risky during this time. Some states, like New York, have suspended the in-person requirement during the pandemic to protect everyone's safety. (See https://www.governor.ny.gov/news/no-2027-continuing-temporary-suspension-and-modification-laws-relating-disaster-emergency.) I would encourage our North Carolina legislature to consider similar protections for attorneys and notaries, at least temporarily. Thank you.

Here are six policy solutions that would be immensely helpful to the nonprofit sector. The Center will make additional suggestions for policy solutions as we continue to learn more about the hardships nonprofits are facing during the pandemic. State grants and contracts. The state is a critical partner to many nonprofit service providers. Significant disruptions in state grants and contracts could permanently shut down organizations providing health services, child care, food assistance, senior care, and many other essential services in our state. Nonprofits may have difficulty fulfilling their deliverables on state grants and contracts due to the necessary public health response to this emergency and the impact it is will have on all parts of the economy. Policy solutions: The General Assembly should pass legislation requiring that, if a nonprofit cannot fulfill its deliverable on a state contract due to circumstances related to the COVID-19 pandemic, then the contract will be based on intended deliverables without penalty for inability to meet deliverables. In addition, we encourage the NC Office of State

Management and Budget to consider following the lead of the federal Office of Management and Budget (OMB) in temporarily loosening grant and contract reporting, application, and renewal requirements.

Unemployment insurance. Businesses and nonprofits throughout North Carolina are making (and will continue to make) difficult decisions in light of the economic challenges that are resulting from the public health response to the pandemic. For more details about nonprofit-specific issues related to unemployment insurance (UI), see this blog post.

Policy solution: To the extent that the General Assembly makes temporary changes to unemployment insurance (UI) benefits, it is important to consider that nonprofits have the option of self-insuring rather and reimbursing the state for UI claims rather than paying SUTA based on experience rating. The Center would certainly support legislative efforts to hold harmless businesses and nonprofits for UI claims resulting from this pandemic by not charging temporary benefits to their experience rating. However, it would be essential for any such legislation to have a parallel provision ensuring that nonprofits that elect to reimburse are also held harmless. The current version of stimulus legislation in Congress would provide federal funding for half of the UI claims of the reimbursing nonprofits. Unless the state can pick up the other half of the cost of these UI claims, nonprofits that have elected to self-insure for UI – including healthcare providers, food banks, housing providers, and senior care facilities – may have to close their doors or significantly reduce services at a time when access to healthcare, food, housing, and other basic needs are more essential than ever.

Policy solution: Two types of charitable nonprofits are exempt from UI laws: (1) churches and other religious nonprofits; and (2) small nonprofits with fewer than four employees. That means that employees working for these types of nonprofits are ineligible for UI benefits if they lose their jobs because of COVID-19. These workers should have access to Disaster Unemployment Assistance if President Trump declares as major disaster in North Carolina, as Governor Cooper has requested. However, if there is no major disaster declaration, it would be extremely helpful for the General Assembly to provide some type of temporary UI benefits for these workers at churches, faith-based organizations, and small nonprofits.

Extending small business assistance to nonprofits. Like many small businesses, nonprofits are suffering significant financial losses as a result of the necessary public health response to the COVID-19 pandemic. Policymakers are rightly seeking to help mitigate the financial harm to small businesses. However, any assistance to employers through a corporate or income tax mechanism will likely leave out nonprofit employers.

Policy solution: Any employer benefit should be available to nonprofit employers, either by making the tax mechanism relate to taxes that nonprofits pay (such as payroll taxes or unrelated business income taxes) or by using a grant mechanism for nonprofits.

Support for charitable giving. Nonprofits have seen a decline in private giving the past two year, and widespread closures and cancellations of public events have eliminated important sources of earned income revenue (tickets for performances, registration for

			Policy solution: If the General Assembly is considering any tax changes to respond to the pandemic, it would be extremely helpful to consider adding a targeted, temporary giving incentive (whether a credit or a deduction) that would be available to all North Carolinians to encourage them to support the work of charitable organizations in their community that are responding to, or suffering from, the COVID-19 pandemic. It is our understanding that the current version of the stimulus bill being considered by Congress includes a limited non-itemizer tax deduction for charitable contributions (capped at \$300 per year and not applicable retroactively on 2019 taxes). Many in Congress (from both parties) are trying to amend the bill to strengthen this temporary universal charitable deduction provision. If these efforts are unsuccessful, it will be important for the General Assembly to help encourage private giving by including a more meaningful state tax deduction or credit for charitable contributions.
			Extension of charitable solicitation filing deadlines. Most charitable nonprofits are required by state law to have charitable solicitation licenses, which are issued annually by the NC Secretary of State. Many of these nonprofits will need to file for renewal of their licenses on May 15 and will need an extension due to workplace disruptions stemming from COVID-19 and social distancing practices.
			Policy solution: Currently, state law (NCGS § 131F-5(d) only grants the Secretary of State the authority to grant filing extensions of up to 60 days. It would be extremely helpful for the General Assembly either: (1) to provide for automatic six-month extension of these filing deadlines; or (2) to expand the Secretary of State's authority to allow it to grant extension of up to six months.
			In most cases, nonprofits now have fewer resources to meet greater needs, since most organizations are suffering financial loss, significant reduction in the availability of inperson volunteers, and the reduction in staff capacity as nonprofit employees are sick, at home with children who are unexpectedly out of school, or having to work remotely to avoid in-office interactions.
			Policy solution: It is essential that state government leaders consult with nonprofits as the state of North Carolina continues to proactively respond to this crisis. If the General Assembly or the executive branch of state government are putting together task forces or commissions to help advise the state on COVID-19 response, leaders at the North Carolina Center for Nonprofits are ready and able to participate.

			With prevention efforts in place for the COVID-19 pandemic, the Department of North Carolina Veterans of Foreign Wars has been following suit with all of the executive orders and guidelines issued by Governor Cooper. Our Posts have been canceling Bingo and Hall Rentals, closing our private, members-only, canteens (bars) as well as finding ways to host meetings electronically (which is quite challenging for some of our older members). Nonetheless, we are weathering the storm just like everyone else and adapting new and

creative ways to continue our mission of helping veterans and their families through this pandemic. We have been following all of the precautions and advice from the State Health Agencies, CDC, and the White House at a significant blow and financial hardships to our local organizations. The canteens at our Posts across the state are the lifeline to financial independence for many of our affiliates. The income from sales is how they pay their bills, how they fund their relief programs to provide financial grants to veterans and military families in need, and how they stay engaged as an integral part of their local communities. We have already received phone calls from Posts from across the state that if this ban lasts more than 2 weeks, they will be forced to close their doors. We are quite possibly looking at the end of VFW Posts in some communities where they have been a mainstay for over 50 years, some 75. With them goes all of our community outreach programs, our scholarships for the local students, and even more importantly, a place where veterans can come home from war and their time in service and meet with like minded individuals. The VFW has supported the communities of our state as well as state agencies for over 100 years. Most notably in recent history, VFW Posts jumped to action with the recent hurricanes by setting up distribution points, getting thousands of pounds of relief aid and over \$125,000 in cash into our communities to not only help veterans but everyone. We didn't go searching for the news trucks, maybe we should have, but that is the nature of our organization. The eagerness to serve never ends.

To continue that trend, we want to offer up our Posts as possible meeting and distribution sites for either drive-thru testing and/or food, water and relief materials distribution sites. The VFW has 138 Posts across our state, with some of them on very large properties ideal for handling cases like this. Not to mention thousands upon thousands of members eager to serve. We encourage you all to reach out to our Department Headquarters and let us know how we can help. We know that the Governor's decision to close all bars and restaurants was a tough one to make and we are truly sorry that it has had to come to this; just know that the VFW stands behind it for the safety of everyone in North Carolina. As we mentioned above though, this is going to create hardships that we don't know if we will be able to bounce back from. Communities all over the state are looking at possibly losing their VFWs and that will be a sad day for not only our veterans but everyone in those communities.

As veterans, we are usually last to step up to the plate and ask for help. We want to try and fix everything ourselves but this is something we don't think we will be able to do without your help.

Therefore the Department of North Carolina Veterans of Foreign Wars is requesting the following from the North Carolina General Assembly in regards to our Posts:

- 1. That all ABC permit renewals that are due by April 30th be waived or postponed to a later date to allow our Posts to regain lost revenue due to the closures.
- 2. That utilities and mortgage payments be waived or postponed until after Posts are allowed to reopen.

To that end, I offer some information about a resource that will be helpful to K-12 students across the state who are at home for an extended period.
			In 2017, the NCPLDA launched the NC Kids Digital Library, which provides access to children's e-books, e-audio books and video primarily for children in K-4th grades. Working with Overdrive, we were able to secure permission for the first digital library in the United States available to children statewide. This was made possible through funding provided by the General Assembly. Non-recurring support provided in FY18 and FY19 enabled NCPLDA to build and maintain the collection. The FY2020 budget included a \$200,000 recurring appropriation for NC Kids Digital Library, as well as an increase to State Aid for Public Libraries. Unfortunately, because the budget was not passed, NC Kids Digital Library went unfunded and overall library funding remained flat. NCPLDA has sustained the NC Kids Digital Library permanent collection of one copy-one user titles, but a number of simultaneous-unlimited access contracts that ensure every child has access have expired. NCPLDA has also been unable to provide access to new content offered by publishers due to limited funds.
			Due to the Coronavirus school closure, public libraries across the state have received calls from school systems asking about access to NC Kids Digital Library and requesting that NCPLDA not only add additional fiction titles, but include non-fiction to help support at home schooling.
			With this week's announcement that schools will remain closed through May 15th, NCPLDA wants to make sure that children have access to content that they need. The NC Kids Digital Library is already positioned to help meet reading needs across the state if additional funding can be secured. Many county libraries have provided the digital access through school partnerships using student ID numbers. For school systems that did not already have partnerships in place, local libraries are offering temporary digital access cards for students to use.
			NCPLDA expects to see public library/school partnerships grow next year, especially if access to needed content is secured. Digital content is not cheap. Securing access to a

			digital library with a vast collection of materials can be challenging for individual school systems. NCPLDA has received permission from publishers to provide statewide access; thus, the simultaneous use purchases made can save thousands of dollars for individual schools, counties and the state.
			While the ratified budget contains an appropriation of \$200,000 recurring for the NC Klds Digital Library, an increase to \$400,000 would allow NCPLDA to renew expired contracts, meet holds requests and metered usage demands AND expand the collection to include additional simultaneous use and single use non-fiction resources that are being requested by school districts.
			NCPLDA is preparing carts so when funding is received, orders can be expedited and NCPLDA can have the additional materials ready within 24-48 hours. Steve Potash, CEO/ President of Overdrive (digital content provider for libraries and schools) is also working to secure temporary extensions on a few key simultaneous access contracts, which is extremely helpful for now. NCPLDA is working diligently to ensure that North Carolina school children do not experience the biggest "summer reading slide" ever; however, funding is critical!

Parenting itself is a challenge. And, circumstances, undoubtedly, determine just how difficult it can be as a parent – even without the added stress of uncertainty, social isolation, job loss or reduction in wages, or inadequate food and shelter. Reports of child abuse and neglect have increased 29 percent over the past 19 years in NC, and it costs the state \$2 billion a year in downstream consequences1. A November 2019 Vital Signs Report2 from the Centers for Disease Control and Prevention (CDC) found that 5 of the top 10 leading causes of death in the US are correlated to Adverse Childhood Experiences like child abuse and neglect, including heart disease, diabetes and depression. It is imperative that our response to the COVID-19 crisis recognizes that the response requires not only addressing immediate needs, but to strategically address the long-term consequences by investing upstream NOW in prevention. Recommendations that prevent child abuse and neglect from the CDC include3: strengthen economic supports for families, enhancing parenting skills to promote healthy child development, and providing quality care and education early in life. The Center for the Study of Social Policy uses the Strengthening Families Protective Factors Framework4 and we encourage you to use this framework in your policy deliberations. These

Protective Factors are: Children's Social and Emotional Competence, Knowledge of Parenting Skills and Child Development, Social Connections, Parental Resilience and Concrete Supports in Times of Need. As families are becoming more isolated due to the pandemic, we fear that there will be a spike in unreported and preventable neglect, physical abuse, and sexual abuse. The people who encounter families and report many suspected cases of abuse and neglect – educators and child care providers – no longer have regular face to face contact with families.

We request that as you make decisions about how our state will move forward, that you support essential services to families that will aid in reducing the stress and anxiety associated with this pandemic, and ensure the safety and well-being of our state's children.

Parenting education classes such as Incredible Years, Triple P, and Circle of Parents must continue as a lifeline for families, and the organizations that are providing these services need resources in order to continue through telehealth, including investments to purchase software platforms that are HIPAA compliant. Some parents who receive these services need access to equipment and broadband services. Home visiting programs offered in NC have strong evidence to prevent abuse and neglect. These programs need the same type of support in order to continue to provide much needed consultation, education, physical, and mental well-checks for families.

Concrete supports will also help reduce stress – a risk factor for abuse – during these difficult times. NC must expand upon the paid family and medical leave and unemployment insurance benefits covered in the most recent Federal relief packages to strategically fill gaps in coverage for families not covered by the federal legislation. This could include, but not be limited to, employers with over 500 employees, the self-employed and those who work 100% on sales commissions. This will provide financial relief and ease the worries that families have in how they will take care of their family. Assuring all families can access the medical care they need should they develop COVID-19 symptoms is also essential. A study has shown that every \$1 increase in the minimum wage can lead to a reduction in the number of reports of neglect by almost 10%5. Offering North Carolinians additional cash assistance that increases the amount offered through the federal legislation is an investment in prevention, in our economy, and in our future.

Another critical concrete support is child care for emergency and essential service workers, as well as financial support for child care providers who have had to close or have lost business. Quality child care is both a key strategy cited by the CDC to prevent child maltreatment and it is critical to the infrastructure of our economy. We support investments in quality, increased access and supports for the early childhood education workforce.

North Carolinians are resilient, and we will come through this even stronger. However, as we prepare for children to return to school, we must invest in our schools becoming a trauma informed place of learning and support. Educators are a lifeline for many students and provide a critical social connection for families. Educators must have the knowledge and skills to appropriately respond to children who have experienced trauma during the

We ask the State to provide an additional \$6 million in immediate funding to every Feeding the Carolinas food bank in North Carolina. This funding must be flexible to allow food banks to purchase the additional food required to respond to the crisis due to the closing of schools and layoffs caused by the appropriate government required closings. In addition, these funds should help support the management, storage, and transportation of these critical food resources along with additional labor required to manage the additional need and loss of volunteer resources created by required social distancing and the protection of older adults (a large pool of community volunteers) from exposure.

The Feeding the Carolinas network typically provides food to 2.6 million North Carolinians facing hunger each year. The COVID-19 pandemic is expected to, and already has, significantly increased the number of North Carolinians experiencing food insecurity. It is critical that the State provide Feeding the Carolinas with immediate and flexible funding to allow them to continue to provide food to those who need it.

Farmers and Farmers Markets

To support our farmers, we ask the State to:

- work with local officials to ensure farmers markets remain open;
- allocate additional resources to helping farmers comply with CDC recommendations to ensure the health and safety of farmworkers;
- advocate for a federal disaster declaration and do so based on revenue losses rather than production losses;
- utilize funds for a Disaster Loss Program similar to the one instituted for losses caused by Hurricanes Michael and Florence, and allow emergency payments to be based on documentation of revenue for farms that do not have crop reports on file with FSA;
- · buy down interest rates for federal emergency loans;
- · create no-interest loan pools to cover the interest of FSA emergency loans; and
- · create bridge loan programs.

Social distancing strategies are necessary to control the spread of this dangerous virus. Small and mid-sized farms that sell directly to consumers, restaurants, and farm-to-school are losing business as a result, pushing many to the edge of failure. The conventional farm safety net does not help these producers or the food hubs and other local food businesses they work with. Meanwhile, thousands of people have been laid off, and the need for emergency support—including food— is growing daily. These farms and businesses can play an important role in ensuring and expanding access to fresh, healthy foods during this public health crisis. But it can't happen without emergency support.

SNAP and WIC

We request that the State:

- provide emergency supplemental SNAP benefits to any participating SNAP household;
- provide meal-replacement benefits through SNAP for households with children who would otherwise receive free- or reduced-price meals through P-EBT;
- submit any other waiver requests to USDA and take advantage of any flexibility as permitted by future federal relief packages;
- take steps and provide funding to implement the Ederly Supplemental Assistance Project (ESAP) as soon as possible.

Nearly 1.3 million North Carolinians receive SNAP. Of those, almost 63% are in families with children and more than 29% are in families with elderly or disabled members. These are also the North Carolinians being most impacted by the COVID-19 pandemic. As businesses continue to close and schools remain shuttered, the number of North Carolinians who qualify for and rely on SNAP and WIC for food will continue to grow. The State must take every step to provide maximum benefits and flexibility and expand access to these critical programs.

Child Nutrition Programs

Now, more than ever, child nutrition programs across the state are a critical way to ensure our children have access to food. Child nutrition programs are utilizing the seamless summer meal program waiver which allows some flexibility, but the federal funding is inadequate for the cost of food, labor, and transport. Lack of funding necessitates that the programs offer fewer meal sites and methods of delivery and is particularly challenging for rural communities. School closures have also left these programs without income from paid meals, sales of a la carte items, and fee for service opportunities.

Access to Care

Too many North Carolinians living in the coverage gap will be disproportionately impacted by Covid-19. If they become sick, they will lack insurance to cover their medical costs. The Families First Coronavirus Response Act does not cover treatments, so people living in the coverage gap may be deterred from seeking treatment or face crippling medical bills. Many of those who are uninsured work in public-facing professions, with higher risks of contracting or transmitting the virus. There will also be a greater burden on North Carolina health providers as they work to provide necessary medical treatment without receiving compensation, particularly those in rural areas.

Broadband and Access to Technology

We ask the State to:

- amend funding for the GREAT Program to provide \$30 million over 5 years;
- pass the FIBER NC Act to remove barriers that prevent or inhibit local governments from partnering with private providers;
- · ensure all students have access to a computer; and
- increase access to technology for small businesses, including farms, who are adjusting to provide virtual services.

High-speed internet is critical now, more than ever, to allow employees to work from home, students to continue their studies, businesses to transition their operations, and patients to receive telemedicine. It is imperative that the State remove barriers that prevent or inhibit local governments from partnering with private providers to bring better service to residents and businesses. The State must allow local governments to accept federal and nonprofit grants to make broadband-related investments, which they cannot receive under current law. These would include grants from the USDA and Golden LEAF Foundation. Additionally, these needs are urgent, so funding is needed immediately to allow this infrastructure to be put into place.
