We have a relatively small number of cases, and the most we have added in one day is 5, although most days are zero to one. Of those we have had, most are recovering well, and we have had one death. The death was an elderly patient who had been confined to a skilled care facility and had been unresponsive for a long period of time due to Alzheimer's. I also own a second home at Oak Island, and of those infected there, only 4-5 active cases remain in the entire county. I realize that more urban areas are in a slightly different situation, and they may require additional mitigation strategies. We can still isolate and trace locally, both here and in Brunswick, and it seems to me that allowing a different set of circumstances (such as moving to Phase One immediately in such areas, by using county by county approach as suggested by Dr. Birx, and progressing through the subsequent "phases" more rapidly as we meet required criteria) would not only be beneficial to our local communities, but also both help jump-start our state's economy and produce some "test" cases from what might be considered

			"experimental groups" that could provide insight as to how a larger urban population might be affected should the same measures be applied therein. Let's allow the President's phased approach to be our "floor" and consistently apply those measures and criteria/ benchmarks statewide. Employing this strategy may also necessitate funneling more of the antibody/serology and rapid testing resources to those areas early on, in part since, if they prove to be scarce, it would likely take less of them, buying more time to procure a sufficient quantity for urban populations as they prepare to move through the gateway into Phase One. Our state is so diverse that I believe it would not only be unwise but also unfair to apply the same measures uniformly to all. Truly, one size does not fit all here. Another consideration is reporting of cases. Until we know how many cases actually exist, we are basing decisions on incomplete data. For example, just because we have reported 5000+cases statewide, we cannot assume we still have that many. Many have recovered, and sadly, some have perished. We should not mislead the public into thinking we still have that many active cases because that is how people are reading the data that is being released and what they are hearing from the media. That is fueling the panic I see among so many people. I am a minister, and our parents and elderly are terrified by the optics that people catch the virus and never recover. The count rises daily on the news, and that is to be expected, Even in a near flatline of cases, a few will still contract it. If we only report case counts, we will never show less than what we have today or tomorrow, People do not understand that, and it scares them. They need hope and encouragement, not fear and panic. Likewise, when outbreaks are contained in nursing homes and prisons, these should be considered and reported separately from the cases in a county and separate from the general populations' progress and case count. These populations are self-contained and pos
