Notaries MUST be in the physical presence of the affiant under current law, as is the case with Will witnesses. Those sorts of transactions are now becoming difficult or impossible at a time when many are concerned with "getting their affairs in order." Since the COVID-19 outbreak, the NC Senior Living Association has been vigilant with regards to informing both members and non-members of information that will assist providers in protecting their residents and staff including following CDC, CMS and NCDHHS guidelines for prevention and transmission of the virus. The NC Senior Living Association is playing a key role in collecting and reporting information to NCDHHS about real time challenges adult care homes and family care homes are facing during this national and state emergency. In turn, the NC Senior Living Association is reporting back to its members and other providers about actions NCDHHS and other state and federal authorities are taking to address concerns identified. Challenges that Adult Care and Family Care Homes are Facing 1. Cashflow and funding – Especially for homes that receive public funding such as State/County Special Assistance (SA) and Medicaid, cashflow is becoming a serious issue. As a result of the budget impasse, homes have not received much needed temporary SA funds for nearly a year now and it is creating a significant financial strain on providers. In
			addition, stagnant Medicaid PCS reimbursement rates have made it difficult to find and retain qualified direct care staff that provide personal care, medication administration and other duties. 2. Staffing – as a result of child care centers and K-12 schools closing, many employees are calling out in order to stay home with their children. Although homes are doing their best to rearrange employee work schedules to accommodate these employees, the call outs are making it more difficult to maintain staffing levels needed to care for residents. 3. Identifying and purchasing Personal Protective Equipment (PPE) – We realize this is a worldwide problem; however, our providers are beginning to run out of PPE and their suppliers are telling them that hospitals have priority and therefore, cannot supply them with PPE. Without adequate supplies of PPE, providers are at a disadvantage when it comes to protecting their residents from the virus and also containing the virus in the event a resident within a home becomes infected. Needed Assistance 1. Retroactively fund the \$34/resident/month temporary State/County Special Assistance (SA) payments that have not occurred since June 30, 2019. Per H966, also fund the

Frontline veterinary practitioners and staff are among the healthcare professionals who provide surveillance for diseases deemed reportable by state and federal governments, including zoonotic diseases, such as rabies, influenza and Lyme Disease. They are also responsible for issuing certificates of veterinary inspection that are required for the movement of animals between states and countries, including those entering the food supply.
- 2. Veterinarians are an integral part of our nation's food and fiber industries. Veterinary care is critical to ensure that only healthy animals enter the food supply. While primarily housed on farms, food animals are also present in urban areas. Commissioner Troxler praised Homeland Security's position that agriculture is "critical infrastructure" during COVID-19. Troxler Release
- 3. Veterinary practices provide medical and surgical care daily for critically ill and injured animals.
- 4. Veterinarians provide care for service and therapy animals, supporting both animal and human welfare.
- 5. Veterinarians (and shelter personnel) provide care for shelter animals housed in facilities across the state.
- 6. Veterinarians also oversee the care of laboratory animals, which are critical to research that leads to the development of pharmaceuticals and biologics, including vaccines such as those currently being developed to combat COVID-19.
- 7. Veterinarians care for rare, threatened, and endangered animals in zoos, aquaria, wildlife rehabilitation clinics, and wildlife facilities. Even if such entities need to be closed to the public for COVID-19 mitigation, veterinarians and animal care staff must continue to care for these animals.
- 8. Veterinarians and our support staff are trusted professionals involved in disaster situations. While perhaps different from a statutory and regulatory perspective, the training, education, and experience of veterinarians and our staff in disasters are clearly transferable skills in whatever COVID-19 risk mitigation is deemed necessary.

			As the father of a young toddler, the son of two senior parents in the at-risk age group, and the chef/partner of a restaurant that up until recently employed a few dozen people and fed hundreds on any given night, knowing what is and isn't safe in the current environment is of the utmost importance to me, especially as it relates to food and dining.
			Like many densely populated metropolitan areas, the Bay Area is now on complete lockdown. All non-essential businesses are closed, gatherings of large groups of people are banned, and residents have been told to leave their houses only if necessary. Among the businesses still running—at least in limited capacity—are supermarkets and restaurants, the latter of which are solely allowed to operate as take-out and delivery venues. I expect more cities will follow suit in the coming days and weeks.
			Even so, plenty of folks—myself included—have been confused or curious about the safety of allowing restaurants to continue preparing and serving food. Is it actually safe? Should I reheat the food when I get it home? Is it better to support local businesses by ordering food, or am I only putting workers and delivery people at risk? And if I'm cooking my own food, what guidelines should I follow?
			To answer these questions, I referenced dozens of articles and scientific reports and enlisted the help of Ben Chapman, a food safety specialist from the North Carolina State University and cohost of Risky or Not and Food Safety Talk.
			Whether you managed to stock your fridge and pantry, or were left staring at empty supermarket shelves, there's good news: you can still eat safely, even from restaurants,

However, there is work that can be done at home in the Old North State. We already have
			identified hundreds of confirmed cases of the coronavirus in North Carolina. The threat is here and must be addressed faster than the usual speed of government. While Governor Cooper correctly declared a state of emergency, taken decisive action to limit the spread of the virus, and has acted swiftly to address the crisis, a special session of the North Carolina General Assembly could improve our public health resilience by:

- Suspending utility disconnections and reconnecting affected households: The Centers for Disease Control recommends hand-washing as the number-one preventative measure to take to stop the spread of disease. With the recognition that hygiene is a public health priority, now more than ever, The State of North Carolina should work with our public utilities to reconnect or restore water service for residents, and suspend disconnections for 90 days. This is not a unique idea. The City of Detroit has released a "Coronavirus COVID-19 Water Restart Plan" in which the State of Michigan pays their \$25 reactivation fee and resumes service at no fee to the customer. Mayor Keisha Lance Bottoms of Atlanta has halted disconnections for 60 days. Charlotte Mayor Vi Lyles and other mayors across the state have done the same.
- Suspending foreclosures and evictions and/or mortgage and rent assistance: Due to the likely economic impacts of this virus, many families are expected to experience cash flow issues. They should not be forced to leave their houses, especially if they are selfquarantining. The State of North Carolina should work with lenders, landlords and local authorities suspend foreclosures and evictions for 90 days, as well as investigate ways to provide mortgage and rent assistance that is not subject to source of income discrimination. Already, Mecklenburg Sheriff Garry McFadden has said the Sheriff's department will no longer enforce eviction orders during this crisis, and the State Courts have effectively suspended foreclosures and evictions; however, these should not immediately resume when the crisis is over and residents are getting back on their feet.
- Expanding Medicaid: Insuring as many people as possible is vital during a public health crisis. Citizens should not be afraid to seek medical attention if they can not afford it. However, while the Trump Administration has committed to removing barriers to testing, the costs of treatment still fall upon our citizens. The financial solvency of our private and public health infrastructure depends on this. The State of North Carolina should expand Medicaid for 90 days or permanently.
- Providing emergency food and unemployment assistance: economic disruptions should not exacerbate the hunger crisis faced by hundreds of thousands of North Carolinians, including children and students. Already, over 100,000 North Carolinians have applied for unemployment insurance due to the coronavirus crisis. We must act sooner rather than later.

This is not an exhaustive list. There are good ideas from both parties to address this crisis. We have an abundance of tools and resources, but what we do not have is time to wait. Now is not the time for partisanship; now is the time for leadership. I hope you will seriously consider this request.

For example, I am a "small business owner," but I am an independent consultant who relies on contracts with businesses. The potential clients in my pipeline are currently pumping the brakes on our project conversations due to economic uncertainty, yet I would not qualify for unemployment, the money I made in previous years would not accurately reflect my current financial situation, and support plans aimed at traditional employment arrangements would not reach me—but the detriments to both my livelihood and my ability to provide for my family are just as real.
			Secondly, please keep in mind that while businesses are struggling and many workers are without their regular income, bills are still coming due rent and mortgage payments, utilities, mobile phones and other line items in the family budget are getting bigger with more people at home all day, including groceries and food delivery services. Yes, businesses need help; that is obvious. But the people of this state need direct and immediate help keeping the lights on at home.

We submit the following legislative requests, as well as information about community health centers' experiences, promising practices, and challenges on the ground, as public comments for consideration by the Health Care Working Group. We humbly recommend the Working Group consider the following requests: 1. An emergency state appropriation of at least \$10,250,000 to community health centers to ensure they remain fully operational and able to absorb the financial strain caused by this pandemic. An independent estimate suggests that nearly 1 in 3 NC health centers could exhaust their operating reserves due to this pandemic. 2. Increased availability of personal protective equipment and supplies across the state, if lawmakers can identify measures to address this. 3. Extension of health coverage to the uninsured in the coverage gap so that patients seek out care and so that community health centers are reimbursed for this care, especially as the uninsured population is likely to grow due to the economic impact of the outbreak and containment measures. In response to the COVID-19 outbreak, our members have nimbly adapted their practices and operations in the following ways in order to promote appropriate access to timely care and mitigate the spread of the virus: 2. Collaborated with health care partners in the community to conduct COVID-19 testing on-site or at drive-up sites; 3. Set up patient triage and screening stations at clinical entrances and in parking lots, established separate waiting rooms for sick and well patients, and reduced, rescheduled, or canceled all in-person well-care visits, annual physicals, and non-emergent dental care; 4. Migrated more and more services to be provided remotely via telephone and telemedicine, especially to th

difficulties. Many of these limitations are due to supply chain restrictions; if there are any creative actions the General Assembly can take to alleviate these shortages, we strongly recommend them.

However, some of these shared challenges present a particularly potent strain on community health centers. While they rely on federal funding streams (70 percent of which is set to expire on May 22 absent congressional action), community health centers also depend heavily on reimbursements for patient care—largely through Medicaid, Medicare, and some commercial insurance—as a major source of revenue. Like other providers, health centers have had to suspend some service lines, like non-emergent dental, and move away from in-person visits for many routine and well-patient care services.

While NC Medicaid recently announced positive developments to its telehealth policies, health centers need further action from Congress to be reimbursed adequately, if at all, for virtual care modalities like telephonic services and telemedicine video conferencing for their Medicare patients. Even then, because of historical policy obstacles to reimbursement for these modalities, many health centers are having to invest now in technology solutions and new workflows in a short period of time to make virtual care a reality. While we're encouraged to move high-risk patients out of the clinic and into virtual care settings, we still face policy obstacles to getting paid for that care.

Currently, health centers are suffering significant financial strain, revenue reductions, and limited cash flow due to these factors. Many are wrestling with affording the costs of leave for their staff who may need to care for children at home due to school closures and lack of affordable childcare options. Others are exploring creative solutions to plan for maintaining capacity and even ramping up surge capacity, such as recruiting volunteer clinicians. As nonprofit or public entities, North Carolina's community health centers are particularly vulnerable to these pain points. However, some health centers are already considering staff furloughs or layoffs as they wrestle with sustaining operations under these circumstances.

This pandemic exacerbates our existing challenge of having a large uninsured population. North Carolina community health centers cared for over 245,000 uninsured patients in 2018, many of whom fall into the coverage gap. We know that lack of health insurance coverage deters people from seeking out care due to cost concerns. We also know that a large and perhaps growing uninsured population will put a strain on the already strained primary care safety net. We hope that lawmakers continue to explore ways to close this coverage gap whether through a traditional Medicaid expansion or through another approach that provides affordable health coverage.

In order to mitigate these harms and protect access to care for the nearly 600,000 North Carolinians who rely on community health centers, we ask the Health Care Working Group to recommend a state appropriation of at least \$10,250,000 for community health centers in support of their response to the novel coronavirus COVID-19 pandemic. This amount is based on an early estimate of the normal cost of caring for the uninsured over the next two months. It is a conservative estimate based on 2018 data for our uninsured population, which we expect could surge in the coming weeks and months. However, as
