Stay at home. It sounds simple enough. But for many North Carolinians, it will be hard to comply with Governor Cooper's May 30th "stay-at-home" order unless state and local government take action to ensure they have homes to stay in.

Before COVID-19 reached North Carolina, renters and homeowners were already experiencing housing instability and unaffordability. US Census estimates show that 1 in 5 homeowners and half of all renters across the state are housing cost-burdened, spending 30% or more of their monthly income on mortgage payments or rent. Homelessness is also major issue affecting North Carolina, with more than 9,000 people experiencing homelessness in 2019 according to the NC Coalition to end Homelessness.

As businesses begin to close and reduce operations due to the stay-at-home order, layoffs and reduced salaries will limit North Carolinians ability to afford their mortgage and rent. The economic impacts of the COVID-19 pandemic will also ripple through other parts of life, as housing expenses may force families to live paycheck to paycheck and dip into their savings to stock up on food, medicine, and other necessities.

The Federal \$2.2 trillion stimulus package will help, but likely not enough to stabilize housing across the state. Many forecasts predict widespread foreclosures, increasing unemployment and underemployment, rising poverty, and – if the pandemic lingers – an economic downturn worse than the Great Recession.

The extent of the COVID-19 pandemic will indeed require state and local government action. One advantage North Carolina has over other states is past experience with disasters. Much of Eastern North Carolina has yet to recover from the destruction caused by Hurricanes Matthew, Florence, and Dorian. Thousands of families were displaced from their homes, neighborhoods, and support networks by these hurricanes. These recent disasters have taught North Carolina that the hardest hit communities are also those that are the most socially and physically vulnerable.

As the COVID-19 crisis worsens, state and local government must apply lessons from disaster preparedness and mitigation to this current threat and take five broad steps to stabilize housing:

- 1. The State should institute a moratorium on evictions and foreclosures for the duration of the State of Emergency and an additional 60 days.
- On March 16th the NC Supreme Court paused eviction and foreclosure hearings for 30 days to mitigate the spread of COVID-19, however, this was motivated by concerns about overcrowded courtrooms, not about keeping families in stable housing. Families should not be evicted from their homes during this crisis.
- There is currently a Federal moratoria on Federal Housing Authority, Fannie Mae, and Freddie Mac mortgages, however, there are other mortgages not covered by the moratoria, including homes on personal property, such as mobile homes. The state should announce a moratoria on foreclosures on all mortgages.

- 2. Increase awareness of federal and private housing aid programs.
- The State should also disseminate information about existing mortgage forbearance programs, which temporarily suspend or reduce required loan payments, for "qualified buyers" such as those from Ally Bank, Bank of America, CitiBank, Quicken Loans, Fannie Mae, and Freddie Mac. The State could set up a mortgage counseling hotline and website in order to provide technical assistance to homeowners.
- 3. Halt utilities shut off for non-payment.
- The State should impose a statewide moratorium on water, electric, gas, and oil shutoffs during the period of the State of Emergency and an additional 60 days. Also, late fees and interest should we waived during this period. While some utility companies have notified clients that they will not shut off utilities for non-payment during this crisis, it is unclear how long this will last.
- 4. Additional support for the homeless is needed.
- The State must eliminate homelessness during this epidemic at all cost.
- Homeless shelters are in need of additional operational support and shelter that is in compliance with public health recommendations for social distancing and sanitation. The State can help to identify temporary shelters for the homeless, such as motels and hotels, that are not currently in use. Providing the homeless with safe, sanitary, and private shelters will mitigate the spread of COVID-19.
- 5. Financial assistance to public and assisted housing providers.
- Local and State governments should provide emergency financial assistance to local public housing agencies that administer housing assistance.
- If residents are unable to pay their rents during this crisis period due to lost wages or unemployment, housing providers will lose revenue for operational expenses and necessary maintenance and repair will be deferred. Many public housing developments, such as McDougal Terrace in Durham, already have deferred maintenance due to a lack of sufficient funds and will fall into further disrepair if rent revenues decline even further.

Keeping families in safe and stable housing is central to Governor Cooper's stay-at-home order. Swift and decisive actions by state elected officials is needed to address this once-in-a-lifetime public health and economic crisis. Just as the stay-at-home order can help stop the spread of COVID-19 and lessen its impact on the state, so too can safe and stable housing.

The Board of Elections could hire staff to count the ballots, and much money could be saved by the counties by not having to support several hundred polling sites and pollworker salaries. It would also lessen the danger of a resurgence of the Coronavirus, which is considered by health experts to be a distinct possibility. Initiating a ranked choice system of first, second, and third choice would also avoid any costly runoffs and give voters the opportunity to vote for their first, second, or third choice of candidates. Voters would have to be informed well in advance about the benefits of this so they understand the process, but I believe it would be well worth using this election as a pilot program. Secure elections- save money- avoid runoffs- give voters choices to rate candidates- and maybe save the State.
