Healthcare workers across the nation, and here in North Carolina, are coming together to fight COVID-19. Many are facing circumstances never witnessed before in their clinical practice. In this unprecedented time, CRNAs may be called upon for their unique skill sets, as healthcare CEOs, administrators and other decision-makers seek to optimize the workforce.

In our roles as advanced practice registered nurses (APRNs), CRNAs practicing in our state can fill an important role in providing life-saving critical care management for patients impacted by the COVID-19 virus. CRNAs are qualified to make independent judgements based on our training, licensure, and certification.

CRNAs function in various areas of the hospital, including emergency room and critical care units and can bridge the gap, providing expertise in the areas of rapid systems assessment, airway management, ventilatory support, vascular volume resuscitation, triage, emergency preparedness, and resource management to support hospitals. Additionally, intensive care providers may become consumed with multiple body system failure related to the lung pathology that is so uniquely elegant to the COVID-19 virus. As direct ordering providers we can lend expert recommendations or can even assume the tasks of ordering ventilator parameters, respiratory treatments, and weaning protocols as patients pull through.

With the expanding pandemic occurring across the United States, several states have identified the unique skillset possessed by CRNAs and removed unnecessary restrictions which allow CRNAs to practice to the fullest degree allowable according to state scope of practice laws.

As you may be aware, the North Carolina Board of Nursing (NCBON) is the sole regulator of CRNA practice in NC as established through the Nursing Practice Act NC G.S. 90-171 and NC Administrative Code 21 NCAC 36.0226. A licensed CRNA in North Carolina may perform nurse anesthesia activities in collaboration with a physician, dentist, podiatrist, or other lawfully qualified health care provider as noted in 21 NCAC 36.0226. Collaboration is codified in 21 NCAC 36.0226 as a process by which the CRNA works with one or more qualified health care providers, each contributing his or her respective area of expertise consistent with the appropriate occupational licensure laws of the state and according to the established policies, procedures, practices, and channels of communication that lend support to nurse anesthesia services and that define the roles and responsibilities of the qualified nurse anesthetist within the practice setting. There is no statutory requirement for a written collaborative agreement between the CRNA and the collaborating, qualified healthcare providers.

Even President Trump recognizes the importance of removing unnecessary and restrictive barriers to practice with his executive order to help the U.S. healthcare system address the COVID-19 patient surge. However, although North Carolina law is clear that CRNAs do not require supervision but rather work collaboratively with other advanced providers and physicians, insurance companies including Palmetto Medicare refuse to acknowledge these facts. They also refer to the Board of Medicine when questioning CRNA scope of practice and supervision instead of the Nursing Board. Therefore, even with President Trump's removal of supervision and unnecessary practice restrictions at the federal level, certain insurance companies will continue to deny payment at the state level for coverage by CRNAs who are unsupervised as they are misinterpreting NC law. CRNAs will be limited in their capacity and unable to practice to the fullest extent possible.

I am asking for your immediate support and assistance by issuing a statement clarifying CRNA practice. Specifically, I am requesting your support in writing to confirm what already is listed in statute: that the NC Board of Nursing is the sole entity to regulate CRNA scope of practice; that CRNAs work collaboratively with other qualified healthcare providers; and most importantly, that no supervision requirements exist for CRNAs in

			Multiple sclerosis is an unpredictable, often disabling disease of the central nervous system. There is currently no cure for MS. Symptoms vary from person to person and range from numbness and tingling, to mobility challenges, blindness and paralysis. An estimated 1 million people live with MS in the United States.
			MS is an expensive disease that lasts a lifetime. Direct medical expenses for people with MS may be 5 times greater than people without MS. Adhering to a treatment plan including prescribed disease-modifying medication is the best possible strategy to manage MS. Lack of access to continual health care may result in disease progression and loss of function.
			As you deliberate, the Society strongly urges you to consider the following actions: Close the coverage gap. Close the health insurance coverage gap by expanding access to Medicaid would help us overcome three of the key obstacles we face: slowing the spread of the virus, supporting our healthcare systems, and lessening the economic hardship many North Carolina families will now face. Maximize the ability to access telemedicine. Telemedicine has the potential to offer individuals and families access to health care services from the safety of their own home. The state should expand access to and availability of, telemedicine services during the COVID-19 pandemic to ensure that patients with pre-existing conditions can easily access health care expertise while simultaneously practicing safe social distancing—allowing patients to avoid being exposed to COVID-19 in provider waiting rooms, exam rooms, and during associated travel. North Carolina should ensure that telemedicine services are covered at no higher cost-sharing than in-person visits, and that bureaucratic hurdles do not prevent health care providers from participating. Ensure access to essential medications and medical products. Health plan restrictions (refill limits, prior authorization. step therapy protocols) should be suspended at this time. 			As you know, hunger was a pressing issue across our state long before the COVID-19 public health crisis. According to the USDA's 2017 report on food insecurity, one in five children in North Carolina struggled with hunger, and nearly 590,000 North Carolina households did not have enough to eat each day. Due to the widespread economic

disruption this crisis is causing, we expect this number to grow dramatically in the coming weeks, as some emergency food providers report an increase of up to 70% in the number of clients served in just the past three weeks.

During this time of great uncertainty and stress, it is paramount that we work together to lift the barriers to food access faced by these families and prevent additional North Carolinians from going hungry. We applaud the swift action you have taken to mitigate the harm this crisis will have on the people in our state.

We recognize that the situation on the ground is continuously changing, and that these recommendations may need to be updated and revised. We offer the following initial recommendations to complement emerging policy and fill damaging gaps as the COVID-19 response is operationalized.

We ask the State to provide an additional \$6 million in immediate funding to the North Carolina Feeding America food banks. This funding must be flexible to allow food banks to purchase the additional food required to respond to the crisis due to the closing of schools and layoffs caused by the appropriate government-required closings. In addition, these funds should help support the management, storage, and transportation of these critical food resources as well as additional labor required to manage the growing need and the loss of community volunteers (a large pool of which are older adults) resulting from social distancing requirements.

To support our farmers, we ask the State to:

work with local officials to ensure farmers markets remain open;

allocate additional resources to help farmers comply with CDC recommendations to ensure the health and safety of farmworkers;

advocate for a federal disaster declaration and do so based on revenue losses rather than production losses;

utilize funds for a Disaster Loss Program similar to the one instituted for losses caused by Hurricanes Michael and Florence, and allow emergency payments to be based on documentation of revenue for farms that do not have crop reports on file with FSA; increase funding and capacity for the Farm to School program to serve children and families and explore additional public procurement policies that would increase markets for local farmers;

buy down interest rates for federal emergency loans;

create no-interest loan pools to cover the interest of FSA emergency loans; and create bridge loan programs.

We ask the State to continue to supplement SNAP and WIC funding and take other actions to expand access to SNAP and WIC. Specifically, we request that the State provide emergency supplemental SNAP benefits to any participating SNAP household.

We ask the State to provide the support necessary to fully operationalize the flexibility and expansion afforded by the federal COVID-19 response to safely and effectively distribute food assistance in alignment with social distancing requirements, including: provide funding to operationalize P-EBT by providing meal-replacement benefits through

SNAP for households with children who would otherwise receive free- or reduced-price meals, including working with the Department of Public Instruction to provide the benefit to children who are not currently SNAP recipients;

provide funding to ensure the capacity each county needs to process new applications and fully administer SNAP and WIC programs while employees work remotely, and funding for frontline employees to continue service while limiting face-to-face contact with the public;

support School Nutrition feeding sites to provide infant-and-toddler appropriate meals and whole milk for children who rely on meals provided at their childcare center, including those who are on the waiting list for the childcare subsidy; and remove state-level barriers to the elimination of asset tests,

We ask the State to provide funding to child nutrition programs, with maximum flexibility for the funds to be used to purchase food or for general operational needs.

We ask the State to close the health insurance coverage gap to ensure all North Carolinians have access to care.

We ask the State to take steps to ensure all North Carolinians have access to broadband and technology so they may access food assistance programs and purchase groceries online, or continue to work or study from home. Specifically, we ask the State to: amend funding for the GREAT Program to provide \$30 million over 5 years; pass the FIBER NC Act to remove barriers that prevent or inhibit local governments from partnering with private providers;

ensure all students have access to a computer; and

increase access to technology for small businesses who are adjusting to provide virtual services.

We appreciate your urgent attention to reducing hunger & food insecurity, and implore you to take immediate action to implement the recommendations outlined in this letter. Medicaid expansion is the quickest way of increasing health care coverage during this public health crisis, and it would require no increase in state taxes. Moreover, many of the workers we deem essential do not receive pay or benefits that reflect their importance many have no paid sick leave, and no health insurance. Medicaid expansion would help keep our state running by ensuring that these essential workers can access medical care if they become ill. And lastly, Medicaid expansion would also support healthcare workers on the front lines of this crisis, because hospitals and Federally Qualified Health Centers would be compensated for more of the life-saving care they provide. COVID-19 doesn't care about personal political ideologies, and to seriously combat this pandemic, lawmakers should set theirs aside as well and implement common sense solutions to protect the health of all constituents.
