			PAC commends the North Carolina General Assembly on the appointment of the Health Care Working Group on COVID-19.
			In the last few weeks, as North Carolina has responded to the pandemic, behavioral health providers have stepped up to serve our state. Our providers have helped ease anxiety, depression, and helped patients get access to needed medication to address their mental health conditions. Behavioral health providers are essential in combating this crisis. We have advocated with the state and various insurance companies to recognize our work in

the same way that primary care and other healthcare workers have been recognized, by providing reimbursement rates the same for telehealth as for in-person care, and by providing the same coverage for behavioral health care as for primary care.

To date, Blue Cross NC, other insurers, and NC DHHS have done a phenomenal job moving the needle so our providers can keep working via flexible telehealth options. Telehealth services will need to continue into the foreseeable future during our state of emergency. After the pandemic, our patients will want to be able to continue to utilize telehealth as individuals and communities try to put their lives back together. In order to do this, we need to continue the flexible telehealth options that have been put into place during this pandemic.

We would like the committee to be aware of needed and ongoing reforms from behavioral health providers as efforts are made to address healthcare concerns as a result of the pandemic:

- Behavioral health providers must be paid for telehealth visits at the same rate as inperson visits across all insurers. This will help providers keep their doors open and will incentivize more telehealth visits rather than in-person visits during the pandemic.
- Allow providers to accept verbal consent to participate in treatment with patients via telehealth or telephone services at this time.
- Insurance companies must be required to continue coverage of telehealth for behavioral health provider visits in the same way that they do primary care providers.
- Insurance companies must be required to cover telephone-only services when a patient lacks access to the internet or has other issues connecting to a video platform to do a video telehealth visit.
- Beyond this crisis, the State of North Carolina must take action to enact the telehealth legislation that the House passed to the Senate in 2019. This will ensure HIPAA compliance and will allow for different types of behavioral health providers to bill for telehealth moving forward.
- For providers to continue their work, provider licensure laws must be updated for the duration of the state emergency disaster declaration. The following needs to be allowed for behavioral health licensees: Video or telephonic licensee supervision, temporarily online Continuing Education for licensure renewal, and licenses to not be suspended as they meet the work demands.
- Only allow the use of other licensees practicing in our state while under a state disaster declaration. Otherwise, we will not be able to monitor who is providing services in our state nor be able to best protect the public.
