Achieving the greatest economic boost from UI requires that the NC General Assembly increase the number of workers able to access the program and improve the adequacy of the benefits to replace lost wages. Legislators should also return the provision that allowed people to access the system if they face illness or must care for a sick family member. Taken together, a comprehensive set of changes to the state's UI policy can ensure that workers aren't disproportionately hurt in this moment and the future. Such changes should include:</p> <ul style="list-style-type: none"> Use the highest quarter or the average of the two highest quarters in the calculation of UI benefits for every worker; Remove the cap of \$350 on maximum UI benefits to calculate based on the average weekly wages in the state; Eliminate the waiting week so that dollars are immediately available to workers without earnings from work; and Ensure workers can receive UI for 26 weeks, which is the national standard. <p>To avoid worsening the recession we're heading into, these changes will benefit the economy for all of us and help to support workers who have lost jobs due to COVID-19 due to no fault of their own.
