			1. IMPROVE AND EXPAND VOTING BY MAIL. This is the most effective way to allow voters to cast a ballots without risking the health of themselves and others. a. This can be done while also maintaining the security and integrity of the election process (perhaps even reducing the opportunity for fraud). b. Best option: eliminate the application process and automatically send every ACTIVE voter a ballot. Send every INACTIVE voter a card informing them of their right to request a ballot. c. If the application process is maintained, provide online portal that provides an application that auto-populates all voter information. Make it as user-friendly as possible. d. Eliminate witness/notary requirement and instead use signature comparison to verify voter identity. Many (if not most) people do not live with two other adults, and leaving the witness requirement as is would require people to violate social distancing guidelines and risk their health. All registered voters have signatures on files at their County BOE. These can be cross-checked to verify a voter's identity. In other states where this is used, software can verify up to 75% of voter signatures against signature on file at County BOE. Other 25% should be reviewed/approved by a bi-artisan panel. This would be arguably more secure than the current witness requirements. e. County boards will need funding to implement, mainly for postage (for mailing ballot to voter and for return ballot from voter).

As you deliberate, ACS CAN strongly recommends you consider the following actions:

- Close the coverage gap. Close the health insurance coverage gap by expanding eligibility for the state's Medicaid program. Expanding Medicaid eligibility would help slow the spread of the virus, by providing low-income North Carolinians who are uninsured especially those who are newly unemployed and/or no longer able to afford their health insurance coverage access to comprehensive and affordable care, including COVID-19 testing and treatment services. In the midst of this pandemic, Medicaid coverage can provide countless state residents, reassurance that their family will not go bankrupt, should they need to seek medical care or need to go to the hospital. Further, Medicaid expansion can help support our hospitals and health systems by providing them much needed revenue to help them provide care for current and anticipated COVID-19 patients.
- Close the chemotherapy coverage gap. Prioritize passage of North Carolina's Oral Chemotherapy Fairness legislation (HB 480). It is more important than ever to ensure that cancer patients can access chemotherapy in the safety of their homes. Cancer patients in some areas are having difficulty keeping their chemotherapy appointments because of the shelter at home order, transportation challenges, and shortages of personal protective equipment, as well as concerns about exposure to the virus.
- Ensure access to essential medications and medical products. Suspend health plan utilization restrictions (refill limits, prior authorization, step therapy protocols) at this time. It is critically important that patients be able to access life-sustaining medications and products without putting themselves at risk with frequent trips to the pharmacy. Plans must allow patients to follow CDC recommendations to secure an appropriate amount of backup supplies of essential medications and medical products.
- Protect patients from surprise medical bills. As we look to a future of economic
 uncertainty, protecting patients from medical debt is of critical importance. We urge you to
 prohibit surprise bills from out of network providers for laboratory testing as well as
 treatment for COVID-19. This financial protection should include all providers, settings,
 and insurance types to ensure that everyone who needs testing and treatment is able to
 receive timely and affordable care. Fear of surprise bills should not keep patients and
 consumers away from care during this critical time.

ACS CAN thanks you for your efforts to protect vulnerable patients, and we urge Members of the Health Care Working Group of the House Select Committee – COVID-19 to adopt our recommendations. If you have questions, or would like to discuss further, please contact me at 919-270-4428.
