At present, voters must provide their own postage for mailed ballot request forms and ballot returns. Under normal circumstances, this is a burden for voters who want to vote by mail. However, the COVID-19 pandemic makes this a significant barrier to voting for two reasons: (1) many voters, but particularly the elderly and other who are most vulnerable to COVID-19, may be unable to procure postage in-person and (2) post offices are likely to have reduced in-person operations. In order to mitigate this problem, the Board should provide prepaid postage for both mailed-in ballot requests and ballot return envelopes.  2. Allow voters to request mail-in ballots by email, fax, online form, or over the phone and honor requests submitted by the one-week deadline. The current mail-in ballot request process is onerous and outdated. In order to request a ballot, voters must either have access to a printer and be able to procure an envelope and postage, or have the ability (or ability of a close relative or legal guardian) to submit their request in-person. Voters who submit their request by mail more than two weeks before the election may, by virtue of imperfections in the postal system, be denied the right to vote if their form does not arrive on time—irrespective of when their request was postmarked.  Given that millions of North Carolinians may request mail-in ballots by mail this fall, the current system has the potential to disenfranchise hundreds of thousands of voters. However, the legislature can make two simple changes to prevent this from happening. The legislature should (1) empower the Board to accept mail-in ballot requests over the phone, and via email, fax, and online fillable form, and (2) require the Board to honor all mailed ballot requests received by the Friday before Election Day.  3. Allow near relatives and legal guardians to request mail-in ballot at polling locations during One-Stop Early Voting and on Election Day. At present, near relativ

made prior to 6:30 p.m. on Election Day.

4. Allow persons other than near relatives and legal guardians to assist voters with requesting, completing, and returning ballots. At present, only near

relatives, legal guardians, and multi-partisan assistance teams (MPATs) may make inperson ballot requests on behalf of voters, assist voters with the completion of ballots,

and return those ballots. Given the limited amount of resources available for MPATs, this disenfranchises vulnerable voters who either have no near relatives or a legal guardian or whose near relatives or legal guardian are unable or unwilling to assist them with voting.

Because a large number of voters, but particularly those who are vulnerable to COVID-19, who will be reluctant to vote in person due in the midst of a deadly pandemic, local

Boards do not have the resources to ensure that every voter receives the help they need. The legislature should empower community organizations and/or individuals to assist

voters with ballot requests, help those voters complete their ballots, and submit those ballots to local Boards.

- 5. Allow voters to register by mail up to the mail-in ballot request deadline, allow voters to "one-stop" register to vote and request a mail-in ballot, and restore same-day registration. Voter registration drives and other efforts to register new voters have been hampered by COVID-19 and will likely be impacted through the fall. In order to combat the suppressive effect that the virus is and will continue to have on voter registration efforts, the legislature should move the voter registration deadline so that voters can "one-stop" register to vote and request as mail-in ballot and restore same-day registration on Election Day.
- 6. Allow voters to certify their ballot by providing the signature of one witness or confirming their intent to submit the ballot in-person or over the phone. At present, a voter must vote a mail-in ballot in the presence of two witnesses or a notary public. This requirement is already onerous for voters who live alone or have limited interactions with others. If the COVID-19 pandemic extends into the fall, the witness/notary requirement is likely to prevent thousands of voters who are most at risk from the virus from being able to cast a ballot.

The purpose of the witness/notary requirement, confirming the voter's identity and intent, can be achieved just as easily by obtaining the signature of one witness or allowing voters to confirm their identity and intent to an election official directly. By reducing the witness requirement, voters who are isolated at home or in a hospital or care facility, will be more likely to be able to vote. Voters who, because of social distancing, are unable or unwilling to have their ballot witnessed by others, should be able to certify their ballot by speaking with an election official. This could be done either in-person at a curbside drop-off site or over the phone with the voter providing some identifying information to confirm their identity.

7. Allow voters and those assisting voters to return mail-in ballots at One-Stop Early Voting sites and Election Day polling places (including curbside). At present, voters and their near relatives and legal guardians may only return mail-in

			ballots in-person at local Board offices. In order to lessen the burden on voters, those helping them vote, and local Board staff, the legislature should allow voters and others to return mail-in ballots at One-Stop Early Voting sites during the early voting period and at precinct polling places on Election Day.  8. Count every mail-in ballot submitted by Election Day. At present, ballots mailed by the Election Day deadline are not counted if they are received after the following Friday. USPS will be likely be inundated with mail-in ballots this fall. Given that even under normal circumstances domestic mail often takes more than three days to be delivered, many voters will be disenfranchised even if they mail their ballot by Election Day. The legislature should relax this stringent requirement and allow for the counting of any ballot mailed by Election Day that is received prior to the final canvass.
			9. Establish a one-step process for registering to vote and requesting a mail-in ballot. At present, voters must submit separate forms when registering to vote and requesting a mail-in ballot. There is already significant overlap in the information required on the voter registration and mail-in ballot request forms. In order to lessen voter confusion and make requesting a mail-in ballot easier, the Board should create a single form, compliant with the existing statutes, that allows voters to register to vote and request a ballot in one step.  10. Establish a robust and uniform system for notifying voters when the Board determines their ballot request or application is invalid. At present, there is no uniform process that County Boards must follow when they deem a ballot request or ballot application to be invalid. As a result, voters often

Dear Chairpersons and Members of the House Select Committee on COVID-19,

At the federal level, policy makers and the Centers for Medicare and Medicaid Services (CMS) are making sweeping changes to immediately expand the healthcare workforce. We understand the need to make similar changes in North Carolina. In this vein, the North Carolina Association of Naturopathic Physicians (NCANP) is grateful for the inclusion in Executive Order 121 which designates Naturopathic Doctors (NDs) as essential healthcare workers in North Carolina. Naturopathic Doctors are trained in 4-year, accredited Naturopathic Medical programs as doctoral level general practice healthcare providers and, with your approval, can be immediately engaged in the COVID-19 response to the full extent of their training and education.

With the anticipation of COVID-19 reaching its peak over the coming weeks, the NCANP would like to express the strong desire of our Naturopathic Doctors to help provide safe and effective healthcare for the residents of North Carolina. The full utilization of Naturopathic Doctors in North Carolina would help provide relief to our overburdened health care system and help reduce the morbidity and mortality that COVID-19 will bring to our communities. There are three primary areas where your committee could facilitate this relief:

- 1. Allow current Naturopathic Doctors Licensure legislation that is pending in the NC House of Representatives (H993/S573) to be passed so that more healthcare providers are immediately deployed in North Carolina. This pending legislation was drafted consistent with the recommendations set forth in the NCDHHS Recommendations for Appropriate Oversight and Regulation of the Practice of Naturopathic Medicine in North Carolina Report to the Joint Legislative Oversight Committee on Health and Human Services on January 15, 2018. The work group was convened under the direction of Dr. Mandy Cohen and Walker Wilson, and included representatives from the NC Medical Society, NC Medical Board, and NCANP. It was the "position of the work group that the passage of licensure legislation will benefit the citizens of North Carolina by allowing them to enjoy the full benefit of healthcare options provided by qualified Naturopathic Doctors." It is important to note that in states where Naturopathic Doctors are currently licensed, they are providing triage and testing for suspected COVID-19 cases, palliative care for mild COVID-19 cases, and close monitoring so as to engage EMS and emergency department care rapidly when needed.
- 2. Include Naturopathic Doctors with out-of-state licensure to be included in the waiver of NC licensure requirements referred to in Section 16 of Executive Order 116. Currently, Naturopathic Doctors are licensed in 22 states, the District of Columbia, the US Virgin Islands, and Puerto Rico. Naturopathic Doctors are already in place in North Carolina who are licensed in other states and jurisdictions and are trained as general practice healthcare providers. With a temporary waiver of NC licensure requirements and recognition of out-of-state licenses, these Naturopathic Doctors can be immediately engaged to help patients follow public health recommendations and abide by stay-at-home orders, assist with phone triage and order appropriate testing, help patients manage mild COVID-19 symptoms safely at home, and provide ongoing care to patients with other acute and

	<i>3</i> ,		chronic illnesses that still occur during a pandemic and are best kept out of urgent care facilities. Including NDs in the waiver will also allow mobilization of out-of-state Naturopathic Doctors as part of the healthcare workforce if the situation escalates to that level in our state.
			3. Issue guidelines or orders for out-of-sate licensed Naturopathic Doctors, including those with temporary emergency licensure, to be able to register with the State Medical Response System (SMRS) as clinical providers. This would allow for assignment to the COVID-19 Medical Response Team and other teams such as the Capitol Medical Reserve Corps. Several of our NDs in NC have already registered with SMRS, but are limited in their capacity to serve due to a lack of recognition of their out-of-state licenses.
			To summarize, the NCANP asks you to utilize Naturopathic Doctors to the full extent of our education and training so that we can best serve our communities during the COVID-19 crisis. With our expertise in preventive medicine and patient-centered care, NDs are an essential component of a comprehensive healthcare system. Our Naturopathic Doctors are trained healthcare professionals who can be immediately engaged to assist the healthcare workforce in combating the COVID-19 pandemic. We ask you to please support Naturopathic Doctors in helping to save lives in our state.

If I had chosen to work 40 hours a week so we could have health insurance instead of taking them to speech therapy, occupational therapy, play therapy, psychological therapy, social groups, and anything I could find to help them. My oldest son was nonverbal at two years old bashing his head on the floor because of sensory processing disorder every day. I had no idea what Autism was then and I didn't know how to help him. Could you turn away from your son at two years old and just go to work instead of helping his needs? I had to give up so much to help him! Early intervention therapies changed our lives and helped him get where he is today! Because of my efforts and the unwaivering support of my husband, our son is nine years old, speaking, and he made a 5.0 on his math EOG last year. He still needs so much help to continue to succeed in life and therefore I continue to help him. Employers do not care about their employees health and well being they care about the well being of their pockets! My husband's boss is able to drive an expensive luxury car, has a beautiful house (several of them), and he goes hunting with Senator Jim Perry and Representative John Bell. It must be nice having political friends to keep you rich and have them vote the way you want them to! Perhaps I should take up hunting to help special needs families gain political advantage in my county? Do you really think my husband's boss cares about his health? He only cares about the profit my husband makes him by being able to do twenty hours of labor in ten hours or less. That's what he cares about. If you can make millions of dollars each quarter off of your employees hard working hands than they should have health insurance AND a liveable wage.... Right? They should not be living paycheck to paycheck and struggling while you enjoy the fruits of their labor! Lives do not matter in NC, but business always does.
