This finding is based on flu data from the CDC that is not always reported, whereas every death involving a positive COVID-19 test or that doesn't involve a COVID-19 test but looks like it may be COVID-19 is rigorously reported. The reported data suggests that the coronavirus rarely or barely causes symptoms for young healthy people while having a much more serious impact on the elderly and those with multiple comorbidity factors. Social distancing may lessen the load on hospitals, but it has not been proven to save lives. Instead, it delays and prolongs the spread, slowing down herd immunity. Our hospitals and COVID-19 triage tents have been mostly empty while many nurses and doctors are working fewer hours due to low patient load. Necessary surgeries and therapies keep getting postponed. People are too afraid to go see doctors for conditions that will only grow worse if not treated. The predictive models were grossly wrong, and NC has fared far better than other states. The numbers simply do not justify obliteration of the economy. Corrective action must be taken ASAP, and this precedent must not be allowed to stand. We can't willingly choose to bring about a Great Depression , destroying half of the nation's small businesses, sending 14 million (nationwide) into unemployment every 3-4 weeks, and expect the federal government to dole out 3 trillion dollars every month that it simply cannot afford (especially when GDP and taxable income are tanking) whenever there is a new virus outbreak. Such a response would destroy our country. We cannot wait for a vaccine. Like the flu, the coronavirus is changing, so any vaccine that is developed will likely have similar effective rates which have ranged from minus 20% to around 60% for the flu vaccine according to the CDC, with the much lower effectiveness rates applying to the most at risk population (age 65+).
