As a hygienist I can not social distance from my patients and of course they will not have a mask on at all. Almost everything I do causes aerosols which allows the virus to float in the air for 3 hours AFTER the patient has left. Now keep in mind I work in a pediatric office where most of my patient population will not show symptoms AND this is important. WE WORK IN AN OPEN BAY. I do not know if you have been to a pediatric dental office but the cleanings are done in a large room with 6 or more dental chairs next to each other all treating different patients from different families with their family members all there with the child all at the same time. So envision 6 chairs going at one time every 30 min. a new patient comes to that chair. In 3 hours you have 36 different patient's aerosols floating around just from those patients not to mention usually they will have at least one parent with them and often a younger sibling playing in this same room. I know that the CDC just did a study in Boston on a homeless shelter where they tested the entire population and a crazy number of them showed no signs but were in fact contagious and sick at that moment. Please Please help me by making some mandates (NOT RECOMMENDATIONS- people like my Friday dentist just ignore those and say they are comfortable risking it and are making a judgement call - but they are risking MY life(and all the patients lives) not just theirs) Is there an antibody test or some type of quick response test that we could literally test all people coming in the door prior to working on them?? AND PLEASE update the recommendation for dentistry on PPE - surgical mask and face shield will not keep out aerosols.THIS UPDATE IS IMPERATIVE SOONER THAN LATER. I want us to all get back to work quickly and I know there are TONS of jobs and stores that could open safely today BUT ELECTIVE DENTISTRY IS NOT READY BY A LONG SHOT PLEASE HELP ME NOT DIE! I am a single mom who has done everything alone - no child support - no weekends or Wednesdays off-100% me the whole time the only income is mine.
