We offer the below recognizing that this is a fluid situation, and also that every stakeholder engaged in election administration is at the outset of their engagement on this issue. As plans develop, it will be critical for election officials to account for safety, access, and the needs of all North Carolina voters—especially those most affected by the current crisis, and those who face chronic and systemic barriers to the ballot. We expect to continue developing and refining these and other ideas, and welcome the opportunity to engage further on these issues moving forward.  I. Background   COVID-19 requires immediate emergency action by government agencies in order to protect voters and elections staff.  As North Carolina faces unprecedented challenges due to the novel coronavirus, we are urging government agencies at all levels to take decisive, necessary action to ensure that upcoming elections are accessible, safe, and secure for all voters. As of March 18, there were 4,275 of confirmed cases and 75 deaths in the United States1 and 63 cases in North Carolina alone.2 Governor Cooper has declared a State of Emergency and all major gatherings in the state are being suspended based on the Centers for Disease Control's (CDC) guidance.3

The problem with that action is that a plain reading of the language is that there has to be an imminent, widespread threat, but that didn't exist. We didn't have an imminent, widespread threat. We had models that, based on a finite amount of data, said the threat MIGHT be there.
			While it's fair to have differing opinions on whether particular epidemiological models are correct, there can be little doubt—especially by now—that the models that influenced the governor to make the decision were grossly incorrect. The models used didn't take in to account differences in population density, age distribution, geography, climate, lifestyle, hospital capacity, ventilator availability, etc. Building models and not controlling for

			Even now, we're being told that the stay at home orders are "working," but there's no factual basis for that. It seems to be a logical conclusion, but it would be impossible to make a factual analysis given how little data there still is about the state of the virus' spread in NC and its actual impact on the health, life, and death rates.
			What IS clear, though, is that we have an economic crisis on our hands. Hundreds of thousands of North Carolinians are out of work, thousands of businesses are closed—many to never reopen—and the economic impact is obvious. It doesn't need to be this way. We have plenty of capacity in our hospitals to deal with what may come, and as a state, country, and people we are so much more equipped—with knowledge about social distancing, methods of treatment for those who do get sick, etc.—to handle what is likely to turn out to be not significantly different that a host of other airborne respiratory diseases that widely affect North Carolina each year.
			We need to let North Carolina return to being North Carolina. We need to start the process of letting our economy wake back up and take the first steps on what will be a long journey to healing. We need to find a way to supportthrough targeted regulatory relief, tax cuts, and other incentives—the recovery of our small business community. They have been the hardest hit by what has been a largely arbitrary approach to shut down, and they are the backbone of our economy.
			Please quickly work to get North Carolina out of the pit in to which these Executive Orders—not the virus—have thrown our state.

			Dear Chairman Moore, The Washington Post dated 4/13/2020 reported that due to Covid-19, millions of students will suffer from school closures. Based on the experience from Covid-19, we are requesting that the NCGA fund a major investment in NC students by funding a supportive technology infrastructure for schools and students to develop a remote Distance – Learning Model. This model would make available a continuum of learning opportunities and services for students regardless of location, and socio-economic status, as part of NC's disaster preparation. With the possibility that occurances like the COVID 19 can occur again, wouldn't it make sense to develop and implement a system for all schools to use that would provide a continuation of education and related services for students, should the need arise? Continuity of education and related services for students should be a priority, as these young people are our future.
			Right now, as in many cities and communities throughout the US, not every child has access to a computer and / or the internet at home to be able to access distance-learning education. This needs to change, and can be by creating partnerships between the school system(s) and telecommunication. For example, MCPS in Maryland and FCPS in Virginia, school systems are partnering with telecommunication companies (Verizon, AT &T, etc) to provide basic internet access in student homes that have no internet. School systems are loaning chromebooks (Acer computers) that are signed out to each student to be used during this remote distance learning period. The New York Times, and other businesses are offering support, access, and monies to communities that need help in setting up these distance-learning systems. MCPS and FCPS have been very creative in developing / presenting online curriculum using different programs and platforms, some of which include, but are not limited to Google Classroom, Zoom, MY MCPSPortal (MCPS), Blackboard, etc Challenging times call for creativity, resourcefulness, and partnering to set up programs by which ALL students from pre-K through grade 12, have the opportunity to learn – albeit in a nontraditional way. By ensuring every student has these basic technological tools, it also ensures every family is connected to school and resources.
