DATE: February 25, 2016

Pursuant to G.S. 120-12.1, The Judicial Department, the Department of Justice, and the Department of Public Safety shall each report by February 1 of each year to the Chairs of the House and Senate Appropriations Committees and the Chairs of the House and Senate Appropriations Subcommittees on Justice and Public Safety on all positions within that department that have remained vacant for 12 months or more. The report shall include the original position vacancy dates, the dates of any postings or repostings of the positions, and an explanation for the length of the vacancies. (1998-212, s. 16.23; 2011-145, s. 19.1(g), (h); 2012-83, s. 42.)

As the State's largest governmental agency, employing approximately 35,000, the Department of Public Safety (DPS) has worked vigorously to reform and expedite the hiring process, thereby reducing its vacant positions. **DPS has reduced the number of positions which have been vacant for a period of 12 months or more to 237 FTEs, which is roughly one half of one percent of DPS's positions.**

As noted in the comment section of the attachment, most positions have not been filled due to recruitment difficulties, which includes a majority of the vacant medical positions within the Division of Adult Correction and Juvenile Justice. The Department continues to work with OSBM and OSHR to reclassify or consolidate certain positions to ensure these critical positions are filled in a timely manner, and the Department will continue its efforts to reduce the number of vacant positions.

Attached is a breakdown of all DPS Positions that have been vacant for 12 months or more.
