2. CUSTOMER/ TARGET POPULATION

RTI provides research, development, and technical services to government and industry in the U.S. and worldwide. RTI's Energy R&D program, which benefits from support received by the State of NC, attracts \$8.53 for every \$1 in state funding, to develop technologies that lead to larger-scale projects with Federal and industry funding.

3. ORGANIZATION INCEPTION

RTI was established by universities, industry, and government in December 1958 to be the first scientific organization in, and centerpiece of, the Research Triangle Park. During its history, RTI has not received a state appropriation until 2010 when the state invested \$500,000 to allow RTI to draw down federal energy grants. Now in its third year, this cumulative investment of \$1.5 million has allowed RTI to draw down more than \$11 million in federal energy grants or about \$8.53 for every \$1 invested.

5. BUDGET

RTI International

Worldwide, RTI conducted \$734 million of contracted services in its 2012 fiscal year, 99.9% of which was derived from competitively won contracts and grants, and more than 95% of which came from out-of-state clients, bringing dollars and jobs into the NC economy.

7. RTI complies with Federal and state limitations on salaries, as confirmed by annual audits and reporting.

11. BUDGETARY IMPACT

RTI's appropriation from the State of NC, of \$500,000, has been leveraged 8 to 1, with dollars from out of state, to fund the early stage development of energy-related intellectual property. RTI controls this IP in NC, and develops it through a series of larger and larger scale projects in North Carolina.
