orth Carolina's Ports in Wilmington and Morehead City, plus inland terminals in Charlotte and the Piedmont Triad in Greensboro, link the State's consumers, businesses and industry to world markets and serve as magnets to attract new business and industry.

ort expansion projects in Morehead City and Wilmington will make North Carolina a key player in international trade, and multiply related jobs and economic impact in the state.

n partnership with multiple state agencies and economic development groups across the State, the Authority works to enhance international trade in North Carolina. Global Distribution Centers and Advanced Manufacturing Facilities – key recruitment targets – depend on proximity to ports, good highways and intermodal connections.

op trading partners are China, India, Great Britain, Brazil, Belgium, So. Korea, Turkey, Taiwan, Canada, Russia, Honduras, Venezuela & Indonesia.

Primary exports are phosphate, forest products, woodchips, woodpulp, general merchandise, food products, and scrap metal.

Top imports are chemicals, grains, urea, ore, mica, & schist, sulfur products, rubber, machinery parts, scrap metal, metal products & tools.

argo moving through North Carolina's Ports represents critical access to the global marketplace for such major North Carolina businesses as retailers QVC, Lowe's, and Variety Wholesalers; manufacturers PCS Phosphate, Nucor Steel, Goodyear Tire and Rubber, the companies of Furniture Brands International and other major furniture manufacturers; agribusiness like Smithfield Foods; and International Paper and other forest product producers.


**Statewide, activities at North Carolina's Ports** generate 65,000 jobs and \$500 million annually in state and local tax revenues. Much of this economic impact occurs away from the Ports, in the interior regions of the state where the cargo is originated or destined.

## PORT OF WILMINGTON

#### **Facilities**

- 26 miles from the open sea on the Cape Fear River
- Channel is 42 ft., M.L.L.W.
- Nine berths with 6,768 ft. of wharf frontage
- Berths with contiguous open apron areas up to 300 ft. wide
- Open storage dry bulk facilities which can transfer up to 800 tons per hour
- Covered dry bulk facilities with import conveyor systems for grain and other bulk cargo capable of handling up to 1,000 tons per hour
- Well-lighted terminal and 24-hour security provided by North Carolina State Port Police
- C-TPAT Certification # 4770579 I
- Concrete pile wharf and deck construction with berth fronted by rubber fender system
- Berth deck heights average 12 ft. above M.L.L.W.
- 150 additional acres available for development

## PORT OF MOREHEAD CITY

#### **Facilities**

- 4 miles from the open sea, just south of the Outer Banks
- Channel is 45 ft., M.L.L.W.
- Nine berths with 5.500 ft. of wharf frontage
- Berths with contiguous open apron areas from 35 ft. to unlimited width
- Two berths served by modern shiploader with maximum loadout rate of 3,000 tons per hour of dry bulk cargo
- Open storage dry bulk facilities which can transfer up to 800 tons per hour
- Covered dry bulk facilities with export conveyor systems capable of handling up to I,000 tons per hour
- Well-lighted terminal and 24-hour security provided by North Carolina State Port Police
- C-TPAT Certification # 47705791
- Concrete pile wharf and deck construction with berth fronted by rubber fender system
- Berth deck heights average 10 ft. above MTTW
- 150 additional acres available for development

- East turning basin depth of 45 ft. M.L.L.W. and diameter of 1,350 ft.; West turning basin depth of 35 ft. M.L.L.W. and 1,100 ft.
- Depth of 45 ft. M.L.L.W. at berths 1, 2 and 3; 35 ft. M. L. L.W. at Berths 4 through 9
- · No air draft restriction in channel
