Current DMV IT Systems

- <u>State Automated Driver License System</u> utilized in issuance of NC driver licenses and identification cards. System is made up of Capture solution implemented in Next Generation Secure Driver Licenses and mainframe legacy system.
- <u>State Titling and Registration System</u> utilized in titling and registration of NC motor vehicles. Mainframe legacy system which includes the collection of county vehicle property taxes for registered vehicles at the time of registration.
- <u>Liability Insurance Tracking and Enforcement System</u> utilized to assure registered vehicles in NC maintain proper level of liability insurance coverage, manages correspondence between customers and DMV, hearings and supports collection of penalties.
- International Registration Plans//Motor Carrier system registers fleets of vehicles that travel in two
 of members jurisdictions, motor carrier liability insurance and collection of Unified Carrier
 Registration fees.
- <u>Motor Vehicle Inspection and Law Enforcement System</u> utilized for vehicle safety and emissions inspection program and enforcement of licensed stations and inspectors and provides results to vehicle registration system prior to allowing vehicle registrations or renewals.
- <u>MyDMV Portal</u> is online applications allowing customers to access their records for DMV driver licenses, vehicles and vehicle property tax paid in prior years. It provides access to all the DMV online services from a single entry.
- <u>Crash Reporting System</u> is utilized to gather NC law enforcement agencies accident reports for which the data is then used for local, state and federal reporting and interfacing with Highway systems.
- <u>Fuel Tax Compliance System</u> is a collaborative effort between NCDOT, Department of Revenue and State Highway Patrol to detect motor carrier evasion of taxes due to the state.

SADLS Modernization

The SADLS Modernization has implemented the front end solution (Capture) with NGSDL project. This provided a new interface to the driver license agents for processing credentials and provided new secure driver and identification cards. It will also enable NC to be fully Real ID compliant in 2nd Quarter of 2017.

The next phase will be to conduct a gap analysis of the Morpho Trust Driver 360 product against NCDMV requirements followed by Go/No Go decision. This effort is currently awaiting procurement approval.

Crash Reporting Replacement

In accordance with S.L. 2016-94 35.35.25.d; we will replace the legacy Crash Reporting System with vendor supported and maintained Crash Reporting Solution. The Request For Proposal was issued on August 31, 2016 and four vendors responded. One was disqualified by procurement. Two were disqualified during the evaluation phase and one remains under evaluation.

Virtual Hearings & Hearing Fees

Allow option for DMV Hearings to be performed remotely between petitioners and DMV Hearing Officer to reduce travel expense and increase efficiencies in scheduling. Also to implement new hearing fees by July 1, 2017 requirement.

Ignition Interlock Management System

Project to replace manual receipt and updating of Ignition Interlock device data from vendors to drivers' records. As devices are installed, deactivated, customer move from one vendor to another, drivers' records must be updated and recalculate required dates driver must have device.

State Titling and Registration System Modernization

Project to modernize the legacy system has been prioritized and is dependent on resource availability and completion of Strategy and Modernization Roadmap which is currently being reviewed by procurement. This will determine the best way to continue to provide DMV services while replacing and/or modernizing the legacy DMV applications which share common database and processes.

National Motor Vehicle Title Information System

Proposed project to integrate the American Association of Motor Vehicle Admistrators (AAMVA) utility to validate title application data. This will allow titling system to validate titles presented to DMV for transfer to new owner or new resident of NC at the time of request. Validation will include confirmation vehicle is not stolen, salvaged or reported as flood damaged.

Real Time Insurance Verification

Proposed project to integrate with national database for insurance carriers to provide real time verification of liability insurance at the time of registration and renewals. This will allow registration system to validate insurance presented to DMV for registration of new vehicle or renewal of registrations at the time of request.
