RE: Non-Revenue and Non-Appropriations Bills Crossover List
UPDATED to reflect Senate Rule suspension May 16, 2013

House Rules for Senate Bills:

House Rule 31.1 (h) requires that, in order to be eligible for consideration by the House during the rest of the 2013 first Regular Session, a Senate bill or resolution must have been received and read on the floor of the House as a message from the Senate no later than Thursday, May 16, 2013. ([H. 54](#))

The following legislation is excepted from this House crossover deadline:

1. Adjournment resolutions;
2. A measure that:
 - a. must be referred to the House Appropriations or Finance committees under Rule 38; or
 - b. establishes districts for Congress or State or local entities (Rule 31.1(j)); or
 - c. ratifies an amendment or amendments to the U.S. Constitution (Rule 31.1(j)).

Senate Rules for House Bills:

Senate Rule 41 requires that, in order to be eligible for consideration by the Senate during the rest of the 2013 and 2014 Regular Sessions, any House bill or resolution must pass third reading in the House no later than Thursday, May 16, 2013 and be received by the Senate no later than Monday, May 20, 2013. ([S. 1, as amended by S. 110](#); as suspended on the floor of the Senate Thursday, May 16, 2013)

The following legislation is excepted from this Senate crossover deadline:

1. Bills required to be referred to the Committee on Finance or the Committee on Appropriations/Base Budget by Rule 42; or
2. Bills establishing districts for Congress or State or local entities (Rule 41); or
3. Adjournment resolutions (Rule 41).

Attached is a list prepared by the legislative Information Systems Division containing those measures that no later than May 16, 2013 passed one chamber and were received by or ordered sent to the

other chamber. You may view the current status of these and other bills on the General Assembly web page at www.ncleg.net.

This list does not include appropriations, revenue and other measures exempt from the crossover deadline, unless such a measure has passed from one chamber to the other by the applicable deadline. Individual analysis of the particular measure not "crossing over" is necessary to determine whether it is subject to the crossover deadline. This list also does not include ratified legislation as of the applicable deadline which, if vetoed, would be constitutionally eligible for continued consideration.
