FIRST DAY

Senate Chamber Tuesday, July 24, 2018

In accordance with law, as set forth in the Constitution of the State of North Carolina, and pursuant to the Joint Proclamation issued on July 23, 2018, upon the receipt of written requests of three-fifths of all the members of the Senate and the House of Representatives, the Senate of the 2017 General Assembly convenes in Extra Session 2018 at the hour of 12:00 p.m. in the Senate Chamber of the Legislative Building in the City of Raleigh.

The Honorable Phil Berger, President *Pro Tempore*, presides and calls the Senate to order.

Prayer is offered by The Honorable Norman W. Sanderson, Senator from Pamlico County, as follows:

Whosoever shall say unto this mountain, be thou removed and be thou cast into the sea and shall not doubt in his heart, but shall believe that those things which he saith shall come to pass, he shall have whatsoever he saith. The Joint Proclamation issued on July 23, 2018, by the President of the Senate and the Speaker of the House of Representatives reads as follows:

JOINT PROCLAMATION TO CONVENE THE GENERAL ASSEMBLY OF NORTH CAROLINA IN EXTRA SESSION

WHEREAS, Article II, Section 11(2) of the Constitution of North Carolina authorizes and requires the Speaker of the House of Representatives and the President of the Senate to convene the General Assembly in extra session by joint proclamation upon receipt of written requests signed by three-fifths of all members of the House of Representatives and the Senate, and

WHEREAS, the President of the Senate and the Speaker of the House of Representatives has each received written requests from three-fifths of all the members of the House of Representatives and the Senate,

NOW, THEREFORE, the Speaker of the House of Representatives and the President of the Senate do hereby proclaim that the General Assembly of North Carolina shall convene in extra session in the City of Raleigh, North Carolina, in the State Legislative Building at 12:00 o'clock p.m. on Tuesday, July 24, 2018, to consider bills concerning any matters the General Assembly elects to consider.

A copy of the Proclamation shall be delivered to each member of the House of Representatives, and the Senate, and a copy to the Governor of North Carolina and the Secretary of State.

Senator Pate, Deputy President *Pro Tempore*, announces the President *Pro Tempore's* appointment of Senator Brown as Vice-Chair of the **Rules and Operations of the Senate Committee** for the 2018 Extra Session.

ADOPTION OF RULES

Senator Brown submits a resolution for filing, introduction, and immediate consideration. The resolution is presented to the Senate, read the first time, and disposed of as follows:

By Senator Brown:

S.R. 1, A SENATE RESOLUTION ADOPTING THE PERMANENT RULES OF THE SENATE FOR THE 2018 FIRST EXTRA SESSION OF THE GENERAL ASSEMBLY.

The resolution is read a second time and is placed before the Senate for adoption.

The text of the resolution reads as follows:

S.R. 1, A SENATE RESOLUTION ADOPTING THE PERMANENT RULES OF THE SENATE FOR THE 2018 FIRST EXTRA SESSION OF THE GENERAL ASSEMBLY.

Be it resolved by the Senate:

SECTION 1. The permanent rules of the 2017 Regular Session, with the following amendments, are the rules governing the 2018 First Extra Session of the General Assembly:

RULE 10. **Points of order.** – (a) The Presiding Officer shall preserve order and decorum and proceed with the business of the Senate according to the rules adopted. The Presiding Officer shall decide all questions of order, subject to an appeal to the Chairman of the Committee on Rules and Operations of the Senate or in the Chair's absence the Vice-Chair of the Committee on Rules and Operations of the Senate, whose decision may be appealed to the Senate by any member, on which appeal no member shall speak more than once unless by leave of the Senate. A two-thirds vote of the membership of the Senate present and voting is necessary to sustain any appeal from the ruling of the Chairman of the Committee on Rules and Operations of the Senate, or in the Chair's absence, the ruling of the Vice-Chair of the Committee on Rules and Operations of the Senate.

- (b) In the event the Senate Rules do not provide for or cover any point of order raised by any Senator, the rules of the United States House of Representatives shall govern.
- (c) When a Senator is called to order, that Senator shall take the assigned seat until the Presiding Officer determines whether that Senator was in order or not; if decided to be out of order, that Senator shall not proceed without the permission of the Senate; and every question of order shall be decided by the Presiding Officer, subject to an appeal to the Chairman of the Committee on Rules and Operations of the Senate or in the Chair's absence the Vice-Chair of the Committee on Rules and Operations of the Senate, whose decision may be appealed to the Senate by any Senator; and if a Senator is called to order for words spoken, the words to which an exception is made shall be immediately preserved by the Principal Clerk, so that the Presiding Officer, the Chairman or Vice-Chair of the Committee on Rules and Operations of the Senate, or the Senate may be better able to judge the matter.

RULE 32. **List of standing/select committees.** – The standing committees shall be:

Senate Select Committee on Elections Rules and Operations of the Senate

All committees shall be comprised of the members who were appointed to those committees during the 2017 Regular Session.

RULE 40. **Introduction of bills.** – Every bill introduced shall contain on the Senate e-jacket the title of the document and the name of the Senator or Senators presenting it. The Principal Clerk of the Senate shall receive, number, and present each bill to the Senate for first reading on the day it is filed.

RULE 40.1. Limitation on introduction and consideration of resolutions and bills. – The only resolutions that may be introduced or considered in the Senate are resolutions establishing the rules governing the First Extra Session and adjourning the First Extra Session sine die. The only bills, parts of bills, or amendments to bills that may be introduced or considered in the Senate are bills, parts of bills, or amendments to bills considering election laws.

RULE 41. (Reserved).

RULE 43. **First reading; reference to committee.** – All bills introduced and all House bills received upon a message from the House of Representatives, upon presentation to the Senate, shall be read in the regular order of business by their number and title which shall constitute the first reading of the bill on the day on which they are received. The Chair of the Committee on Rules and Operations of the Senate or, in the Chair's absence, the Vice-Chair of the Committee, or the President Pro Tempore may refer to a Senate committee all bills introduced in the Senate or received from the House of Representatives. Upon the referral being made, the Chair of the Committee on Rules and Operations of the Senate shall notify the Principal Clerk of the Senate of the referral, and the Reading Clerk shall announce the referral of the bill. The Principal Clerk shall inform the Presiding Officer of the referral. The title and referral shall be entered upon the Journal. Bills may be referred to more than one committee serially.

RULE 43.1. **Second reading.** – All bills reported by committee shall be placed before the Senate for second reading and immediate consideration upon passage.

RULE 45.1. Action on amendment or committee substitute. – If any committee recommends adoption of an amendment or committee substitute of a bill or resolution, the amendment or committee substitute shall be considered adopted upon the reading of the committee report. The bill or resolution, as amended, or its adopted committee substitute may be placed on the calendar for the same legislative day or re-referred if the bill or resolution was serially referred. The committee substitute's original bill or resolution shall lie on the table.

RULE 50. **Third reading requirements.** – When a bill or resolution has passed its second reading, it shall be placed on the calendar for immediate consideration on its third reading, unless prohibited by Section 23 of Article II of the North Carolina Constitution.

RULE 56.1. Amendments and committee substitutes adopted by the House to bills originating in the Senate. – (a) Whenever the House has adopted an amendment or a committee substitute for a bill originating in the Senate and has returned the bill to the Senate for concurrence in that amendment or committee substitute, the Senate may concur in that amendment or committee substitute on the same legislative day.

RULE 59. (Reserved).

RULE 59.2. **Vetoed bills.** – (a) The Principal Clerk, or in the Clerk's absence an employee designated by the Principal Clerk, is designated the Senate Officer to receive bills vetoed by the Governor. If the veto message is received on a day when the Senate is in session, it may be read in the Senate on the day of its receipt. If the veto message is received on a day when the Senate is not in session, or if was not read on the legislative day when it was received, it shall be read on the next legislative day.

(b) Upon a veto message's being read in the Senate, the Chair of the Committee on Rules and Operations of the Senate, or in the absence of the Chair, the President Pro Tempore of the Senate shall either refer the bill and the Governor's objections and veto message to committee or place the bill on the calendar for a day certain.

SECTION 2. This resolution is effective upon adoption.

HONORING ATTORNEY J. KENNETH LEE

Submitted by Senator Robinson on July 24, 2018

WHEREAS, J. Kenneth Lee, a Civil rights lawyer who fought to integrate Greensboro schools, passed away on Sunday, July 22, 2018; and

WHEREAS, Attorney Lee, after earning a degree in electrical engineering from North Carolina A&T State University, decided to go to law school to fight Jim Crow laws; and

WHEREAS, Attorney Lee represented five black children who sued Greensboro City Schools so they could attend an all-white elementary school — among the first students in the South to do so successfully; and

WHEREAS, over a lifetime, Attorney Lee fought for equality not only for schools open to all children but also in economic opportunity that he knew could be life changing; and

WHEREAS, Attorney Lee was a plaintiff in a case argued by Thurgood Marshall, then chief legal counselor with the NAACP's Legal Defense Fund, to desegregate the University of North Carolina at Chapel Hill's law school, opening the university's doors for entry to other black students; and

WHEREAS, Attorney Lee represented the majority of the 1,700 civil disobedience cases in North Carolina that started with the Woolworth sit-ins of 1960; and

WHEREAS, Attorney Lee also founded American Federal, the first black federally-chartered savings and loan bank in the State;

NOW, THEREFORE, Attorney J. Kenneth Lee deserves applause for his lifetime commitment to civil rights. He brought education, equality, and economic empowerment to all children and citizens of Greensboro and the State of North Carolina.
