



MINUTES NORTH CAROLINA HOUSE OF REPRESENTATIVES UNIVERSITY BOARD OF GOVERNORS NOMINATING COMMITTEE

March 2, 1999

The North Carolina House of Representatives, University Board of Governors Nominating Committee met on Tuesday, March 2, 1999, at 1:00 pm in Room 421 of the Legislative Office Building.

The following members were present: Representative Warren Oldham, Chair; Representative Phillip Haire, Vice-Chair; Representatives Barbee, Boyd-McIntyre, Bridgeman, Grady, Hardaway, Hurley and McMahan.

Chairman Oldham called the meeting to order and introduced the members of the Board, the Research Staff, the House Pages, the Sgt. At Arms staff, the Doctor of the Day, and the Committee Assistant.

Chairman Oldham: The purpose of this meeting is to: (1) get a favorable report on the draft copy of House Resolution 166, (2) get approval of the nomination form, and (3) get approval of the proposed questions for the nominees.

Kory Goldsmith, Research Staff, gave an overview of the draft copy of House Resolution 166 and a copy of GS 116-6, which governs the election and terms of the members of the Board of Governors. She stated that the House must elect four (4) at-large members, two (2) minority members, two (2) women members, and one (1) member to fill an at-large vacancy seat.

Chairman Oldham opened the floor for questions from the members.

Rep. Grady: Are we required to have the at-large vacancy category as a separate nominating and voting block? If there are four at-large seats, who would choose to run for the two-year term? Would it possible to say that we would have four at-large and one at-large, and then the one with the fifth highest vote would get the two-year term, or do we need to ask the nominees to file for the two-year term? If I was going to run, I certainly would not file for the two-year term, I would file for the four-year term.

Chairman Oldham: As the Resolution points out, the nominees would apply for a particular category, whether it is for one of the four four-year terms or the two-year term category. There might be someone who would choose to serve a two-year term as a way to get in and later file for a four-year term.

Rep. Grady: Could we just have an at-large term and have the nominee with the fifth highest total pick up the shorter term rather than asking the nominee to vote or run for a junior term. Also, would the limit of serving three consecutive terms be included in the two-year term for the nominee getting that position?

Chairman Oldham: No, this will not be counted towards the statute's limit of three consecutive terms.

Rep. Hurley stated that he would like to explore the possibility of voting under the terms that Rep. Grady suggested. He noted that the nominee in fifth place should automatically take the unexpired term. It would also make things less confusing.

Chairman Oldham: How would this effect the next sequence of elections since this is an unexpired term in this category?

Kory Goldsmith: The Resolution could be drafted in such a manner that the fifth highest vote getter should also have the majority of the votes from the members present and voting. Or, would you want the fifth highest vote getter alone?

Chairman Oldham: So, am I to understand that this person would have to also have the majority votes or the fifth highest number, which might not be the majority?

Kory Goldsmith: I think that you would have to be very clear in how this is written. Do you want that nominee with the fifth highest vote getter to also be required to have gotten the majority of the votes? This would be a procedural matter and it would mean that there would be five seats in the at-large and up to ten nominees for that position. The members of the board would have to make this decision.

Chairman Oldham: Would this make it more difficult to get the majority of votes in this category in order to get the number of positions that we have to elect?

Kory Goldsmith: It could potentially increase the chance or likelihood of having to do a run-off election.

Rep. Hardaway: How many candidates have expressed an interest in the four- or two-year terms at this time?

Chairman Oldham: We do not have a number. We can only speculate based on the people who have called or made some kind of contact with us personally, and other members of the House who have shown some interest.

Rep. Hardaway: To date, has anyone expressed any interest in the two-year slot?

Chairman Oldham: The only questions I have received concerns the categories from which we would be selecting.

Rep. Hurley: If I was a candidate, I would have to make ten or fifteen phone calls to find out from the other candidates what they were running for in order for me to know what to run for. It would simpler for the candidates to know that if they ran at-large, there are five openings rather than having them talk among themselves to find out the best position to run for.

Chairman Oldham: There is another way of looking at this too. If the candidate files in the at-large category, he/she might possibly not accept it if he/she chooses not to run for the two-year term. That candidate might not accept a two-year commitment.

Rep. McMahan: I agree with Representatives Grady and Hurley. It would eliminate a lot of confusion. Why can't we simply say that the fifth one is the fifth vote getter. Anyone who applies for this job would anticipate the possibility of finishing fifth when only serving two years. That would be understood going in. This would be a lot simpler.

Rep. Grady: Carteret County, my adjoining county, recently went to staggered terms. They simply said that the top four vote getters get a four-year term and the bottom three get a two-year term, then after that, they are back on a four-year rotation. The results worked out very well.

Rep. Boyd-McIntyre: I am inclined to agree with Rep. Grady. It really does make a lot of sense to simplify what might be a very sticky problem for us later.

Rep. Barbee: If we have eight people at-large, would we have to have two more people for the fifth position?

Rep. Haire: You would have to have the same number.

Rep. Hurley moved that House Resolution 166 be amended to include wording that all candidates running for at-large positions be declared an at-large classification, and that the fifth top vote getter would take the two-year unexpired term and with a majority of the votes.

The meeting adjourned at 1:50 pm in order to amend the Resolution with instructions to reconvene after session.

The North Carolina House of Representatives, University Board of Governors Nominating Committee reconvened on Tuesday, March 2, 1999, at 4:50 pm in Room 421 of the Legislative Office Building.

The following members were present: Representative Warren Oldham, Chair; Representative Phillip Haire, Vice-Chair; Representatives Barbee, Bridgeman, Gibson, and Hurley.

The meeting was called to order by Chairman Oldham. Rep. Barbee made a motion to bring the proposed committee substitute to House Resolution 166 to the meeting floor. Kory Goldsmith reviewed the proposed changes to the Resolution with the members present.

Rep. Haire made a motion to amend the proposed committee substitute to omit, on page 4, beginning on line 9, the language that says "If there is an open position or positions for a four-year term, then the nominee..." Simply make the sentence read "The nominee..." The members present voted orally to accept the amendment as read by Rep. Haire.

A motion was made to adopt the proposed committee substitute as amended, to report it directly to the House floor, and to give an unfavorable report to the original Resolution. The members present voted orally to adopt the proposed committee substitute as read.

Chairman Oldham noted that the nomination form was changed to reflect the changes in the proposed committee substitute. He opened the floor for questions concerning the form. No questions were asked.

Rep. Gibson made a motion to adopt the nomination form as it now appears. The nomination form was adopted, as written, by the members present and voting.

Chairman Oldham reviewed the nominee questionnaire form and asked for a motion to adopt the questionnaire as written.

Rep. Hurley made a motion to adopt the questionnaire. The members present voted orally in favor of the questionnaire.

Rep. Gibson asked that a written summary of the voting process on the House floor be given to each member for reference. Chairman Oldham agreed to the request.

With no other business to address, the meeting was adjourned at 5:15 pm.

A summary of the 1999 House election of the UNC Board of Governors procedures is attached. A copy of House Resolution 166, GS 116-6, the BOG Nomination Form, the BOG Questionnaire, and the Visitor Registration Sheet are also attached and made a part of these minutes.

Re: Summary HR166 - 1999 House Election of UNC Board of Governors

The Board of Governors of The University of North Carolina has thirty-two elected members serving staggered four-year terms. During each odd numbered year, the General Assembly elects sixteen individuals to the Board of Governors - eight by the Senate and eight by the House. Each chamber separately prepares a resolution governing its nomination and election procedure. The chambers alternate electing members from among four categories: at-large, minority political party, minority race, and woman. In 1999, the House must fill four seats in the at-large category; two seats in the minority race category, and two seats in the woman category. There is also a vacant seat in the House elected atlarge category. The term of the vacant position will expire June 30, 2001. No member of the General Assembly, no officer or employee of the State, no officer or employee of a constituent institution, and no spouse of any of those persons is eligible to serve.

If adopted, HR 166 provides the following procedure:

- 1. The House University Board of Governors Nominating Committee ("Committee") is responsible for receiving proposed suggestions for Board of Governors nominees.
- 2. The nomination process closes on **Monday, March 15, 1999**. Only nominations submitted on a form provided by the Committee chair and received by 7 p.m. in the Office of the House Principal Clerk shall be eligible for consideration. Nominations may be received via facsimile transmission.
 - 3. Members of the House may nominate persons only in the following categories:
 - (a) at-large category (4 seats, four year terms);
 - (b) minority race category (2 seats, four-year terms);
 - c) woman category (2 seats, four-year terms); and
 - (d) at-large category vacancy (1 seat, term expires June 30, 2001).

Each Representative may nominate up to 2 individuals. Individuals who were nominated, but not elected to the Board of Governors by the Senate during the 1999 session are not eligible for nomination in the House.

- 4. On or after **Thursday, March 18, 1999**, the Committee shall screen the nominees as to their qualifications, experience, opinions, and statutory suitability. The Committee shall then vote on the nominees. The final slate of candidates shall include no more than twice the number of candidates in each category as there are seats to fill in each category.
- 5. The House must hold its election no later than the beginning of the daily session on **Tuesday, March 23, 1999**. The Speaker of the House will explain the voting procedure as provided in HR 166. No floor nominations may be accepted. The ballot shall list the nominees alphabetically within each category. In order to be counted, a ballot must be

signed by the Representative casting it. In order to be elected, a candidate must receive the votes of a majority of the Representatives present and voting.

- 6. The chair of the Committee is responsible for canvassing the ballots and may designate members of the Committee to assist him. After the ballots have been counted, the chair will declare the results. All ballots are retained by the House Principal Clerk's Office and are public documents open to public inspection.
- 7. After the House finishes the election, the chair will forward the results to the Secretary of the Board of Governors.

HR 166 is effective upon adoption. Because it is a simple resolution, it only requires two readings.

TO **ESTABLISH** THE PROCEDURE FOR HOUSE RESOLUTION ·1 A ELECTING **MEMBERS** OF THE BOARD OF NOMINATING AND GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA. 3

4 Be it resolved by the House of Representatives:

Section 1. The following procedures for nominating and electing nine 6 members of the Board of Governors of The University of North Carolina (hereinafter 7 the "Board of Governors") are adopted:

I. COMMITTEE RESPONSIBILITIES.

- It is the duty of the University Board of Governors Nominating 10 Committee of the House of Representatives (hereinafter the "Committee") to conduct 11 a process for nominating and electing persons for each opening in each category of 12 seats on the Board of Governors to which the House of Representatives is to elect 13 members.
- 2. The Committee shall receive nominations for election to the Board of 14 15 Governors through March 15, 1999. Each Representative may nominate up to two 16 persons. In order for a person to have standing as a nominee, that person must be 17 formally nominated by a member of the House of Representatives. Only a written 18 nomination that includes all the requested information, which is submitted on a form 19 provided by the Chair of the Committee for that purpose, and that is received in the 20 Office of the House Principal Clerk no later than 7:00 p.m. on March 15, 1999, shall 21 constitute a formal nomination. Delivery by facsimile transmission shall constitute 22 valid receipt if the communication or submission is in fact received. An individual 23 cannot be a nominee or be nominated in more than one category. An individual is 24 not eligible for nomination if he or she was nominated and not elected to the Board 25 of Governors by the Senate during the 1999 Session.



 - 3. A Representative may nominate persons only for the categories available for election by the House of Representatives. In the 1999 Session, the House of Representatives will elect:
 - (a) Four persons in the at-large category, for four-year terms;
 - (b) Two persons in the minority race category, for four-year terms;
 - (c) Two persons in the woman category, for four-year terms; and
 - (d) Due to a vacancy, one person in the at-large category, for the remainder of the unexpired term that ends on June 30, 2001.
 - 4. On or after March 18, 1999, the Committee shall list all nominees by category. The Committee shall screen the nominees as to their qualifications, experience, opinions, and statutory suitability. The Committee may screen nominees by interviewing, or by soliciting written information, or by both means. On completion of the screening process, the Committee shall conduct a vote to ensure that the slate of legally qualified candidates lists no more than twice the number of candidates for the total seats open in each category.
 - 5. Each nominee shall confirm his or her willingness to serve if elected.
 Any nominee may withdraw without the approval of the sponsor.

II. ELECTIONS IN THE HOUSE OF REPRESENTATIVES.

- 1. A ballot shall be prepared under the supervision of the Chair of the 20 Committee for the use of the House of Representatives. The ballot shall include no 21 more than twice the number of legally qualified candidates for the total seats open in 22 each category.
- 23 2. The names of the nominees shall be arranged on the ballot (a) by 24 category and (b) within each category by alphabetical order.
- 3. The House of Representatives shall hold its election no later than the beginning of the daily session on March 23, 1999. Before the voting begins, the Speaker of the House shall explain the voting rules, which are:
 - (a) No nomination shall be received from the floor.
 - (b) In order to be elected, a nominee must receive the votes of a majority of all members present and voting in the nominee's category.
 - (c) Each member present and voting shall vote for as many nominees as there are positions to be filled in each category.
 - (d) If there is a tie between the two nominees for the at-large category to fill the vacancy that expires on June 30, 2001, there shall be another election until one of the nominees receives the votes of a majority of the members present and voting in that category.
 - (e) When fewer than two nominees in the minority race or the woman categories, or fewer than four nominees in the at-large category, receive the votes of a majority of all members present and voting for positions in those categories, a runoff to fill the open position or positions shall be conducted among the nominees who were not elected but who received the highest number of votes cast in each

- 4. The members of the House of Representatives shall proceed to mark 16 their ballots for the following:
 - Four persons in the at-large category, for four-year terms; (a)
 - Two persons in the minority race category, for four-year terms; (b)
 - Two persons in the woman category, for four-year terms; and (c)
 - One person in the at-large category, for the remainder of the (d) unexpired term that ends on June 30, 2001.

Every ballot shall be signed by the member of the House of 23 Representatives casting it, and no unsigned ballots shall be counted.

- 5. The Chair of the Committee is responsible for canvassing the vote and 25 declaring the results and may designate members of the Committee to assist. All 26 ballots shall be retained by the Principal Clerk as part of the permanent records of 27 the House of Representatives and shall be open for immediate public inspection.
- 6. When the Chair of the Committee has determined that the House of 29 Representatives has elected two members from the minority race category, two 30 members from the woman category, four members from the at-large category to the 31 Board of Governors for terms of four years, and one member from the at-large 32 category to the Board of Governors for the remainder of the unexpired term, the 33 Speaker of the House of Representatives shall declare those nine persons to have 34 been elected by the House of Representatives to the indicated positions and for the 35 indicated terms.
- 7. The results of the election in the House of Representatives shall then 37 be sent by Special Messenger to the Senate.

III. NOTIFICATION OF ELECTION RESULTS.

When the election process is complete, the Chair of the Committee shall 40 notify the Secretary of the Board of Governors of the names of the persons elected by the House of Representatives and the category and term for which each person was 42 elected.

Section 2. This resolution is effective upon adoption.

§ 116-6. Election and terms of members of Board of Governors.

- (a) As the terms of members of the Board of Governors provided for in G.S. 116-5 expire, their successors shall be elected by the Senate and House of Representatives. Sixteen members shall be elected at the regular legislative session in 1993 and every two years thereafter. The Senate and the House of Representatives shall each elect one-half of the persons necessary to fill the vacancies on the Board of Governors. Of the 16 members elected every two years beginning in 1993, at least two shall be women, at least two other members shall be members of a minority race, and at least two other members shall be members of the political party to which the largest minority of the members of the General Assembly belongs.
- (b) In 1993 and every four years thereafter the Senate shall elect at least two women and two members of a minority race, and the House of Representatives shall elect at least two members of the political party to which the largest minority of the members of the General Assembly belongs. In 1995 and every four years thereafter the Senate shall elect at least two members of the political party to which the largest minority of the members of the General Assembly belongs, and the House of Representatives shall elect at least two women and two members of a minority race.
- (c) In electing members to the Board of Governors, the Senate and the House of Representatives shall select from a slate of candidates made in each house. The slate shall be prepared as provided by resolution of each house. If a sufficient number of nominees who are legally qualified are submitted in a category for which members of the Board of Governors are to be elected, then the slate of candidates shall list at least twice the number of candidates for the total seats open in a category. All qualified candidates in a category shall compete against all other qualified candidates in a category. In 1993 and biennially thereafter, each house shall hold their elections within 30 legislative days after appointments to their education committees are complete.
- (d) All terms shall commence on July 1 of odd-numbered years and all members shall serve for four-year overlapping terms.
- (e) No person may be elected to:
 - (1) More than three full four-year terms in succession;
 - (2) A four-year term if preceded immediately by election to two full eight-year terms in succession; or
 - (3) A four-year term if preceded immediately by election to an eight-year term and a four-year term in succession.

Resignation from a term of office does not constitute a break in service for the purpose of this subsection. Service prior to the beginning of those terms in 1989 shall be included in the limitations.

- (f) Any person who has served at least one full term as chairman of the Board of Governors shall be a member emeritus of the Board of Governors for one four-year term beginning at the expiration of that member's regular elected term. Any person already serving as an emeritus member may serve an additional four-year term beginning July 1, 1991. Members emeriti have all the rights and privileges of membership except they do not have a vote.
- (g) Effective July 1, 1991, and thereafter, any person who has served at least one term as a member of the Board of Governors after having served as Governor of North Carolina

shall be a member emeritus of the Board of Governors, with all the rights and privileges of membership as in G.S. 116-6(f).

§ 116-7. General provisions concerning members of the Board of Governors.

- (a) All members of the Board of Governors shall be selected for their interest in, and their ability to contribute to the fulfillment of, the purposes of the Board of Governors, and all members shall be deemed members-at-large, charged with the responsibility of serving the best interests of the whole State. In electing members, the objective shall be to obtain the services of the best qualified citizens of the State, taking into consideration the need for representation on the Board by the different races, sexes and political parties. (b) From and after July 1, 1973, no member of the General Assembly or officer or employee of the State or of any constituent institution or spouse of any such member, officer or employee may be a member of the Board of Governors. Any member of the
- employee of the State or of any constituent institution or spouse of any such member, officer or employee may be a member of the Board of Governors. Any member of the Board of Governors who is elected or appointed to the General Assembly or who becomes an officer or employee of the State or of any constituent institution or whose spouse is elected or appointed to the General Assembly or becomes such officer or employee shall be deemed thereupon to resign from his membership on the Board of Governors.
- (c) Whenever any vacancy shall occur in the elected membership of the Board of Governors, it shall be the duty of the Board to inform the Speaker of the House of Representatives and the President of the Senate of the vacancy. The chamber that originally elected the vacating member shall elect a person to fill the vacancy. The vacancy shall remain unfilled until the appropriate chamber of the General Assembly elects a person to fill the vacancy.

The vacancy shall be filled not later than the adjournment sine die of the next regular session of the General Assembly. The election shall be for the remainder of the unexpired term. Whenever a member shall fail, for any reason other than ill health or service in the interest of the State or nation, to be present for four successive regular meetings of the Board, his place as a member shall be deemed vacant.



- 4. The members of the House of Representatives shall proceed to mark 16 their ballots for the following:
 - Four persons in the at-large category, for four-year terms; (a)
 - Two persons in the minority race category, for four-year terms; (b)
 - Two persons in the woman category, for four-year terms; and (c)
 - One person in the at-large category, for the remainder of the (d) unexpired term that ends on June 30, 2001.

Every ballot shall be signed by the member of the House of 23 Representatives casting it, and no unsigned ballots shall be counted.

- 5. The Chair of the Committee is responsible for canvassing the vote and 25 declaring the results and may designate members of the Committee to assist. All 26 ballots shall be retained by the Principal Clerk as part of the permanent records of 27 the House of Representatives and shall be open for immediate public inspection.
- 6. When the Chair of the Committee has determined that the House of 29 Representatives has elected two members from the minority race category, two 30 members from the woman category, four members from the at-large category to the 31 Board of Governors for terms of four years, and one member from the at-large 32 category to the Board of Governors for the remainder of the unexpired term, the 33 Speaker of the House of Representatives shall declare those nine persons to have 34 been elected by the House of Representatives to the indicated positions and for the 35 indicated terms.
- 7. The results of the election in the House of Representatives shall then 37 be sent by Special Messenger to the Senate.

III. NOTIFICATION OF ELECTION RESULTS.

When the election process is complete, the Chair of the Committee shall 40 notify the Secretary of the Board of Governors of the names of the persons elected by 41 the House of Representatives and the category and term for which each person was 42 elected.

Section 2. This resolution is effective upon adoption.

MINUTES NORTH CAROLINA HOUSE OF REPRESENTATIVES UNIVERSITY BOARD OF GOVERNORS NOMINATING COMMITTEE

March 18, 1999 12:00 PM

The North Carolina House of Representatives, University Board of Governors Nominating Committee met on Thursday, March 18, 1999, at 12:00 pm in Room 424 of the Legislative Office Building.

The following members were present: Representative Warren Oldham, Chair; Representative Phillip Haire, Vice-Chair; Representatives Barbee, Bridgeman, Gibson, Grady, Gray, Hardaway, Hurley and McMahan. The following ex-officio members were also present: Representative Joe Hackney, Speaker Pro Tem; Representative Pete Cunningham, Assistant to the Speaker of the House, and Representative Beverly Earle, House Majority Whip.

Chairman Oldham called the meeting to order and recognized the House Pages and the Sgt. At Arms staff.

Chairman Oldham: The purpose of this meeting is to put together a ballot for the purpose of electing House members to the UNC Board of Governors. Rep. Phillip Haire is a former member of the Board of Governors and he has agreed to tell us a little something about the Board of Governors election process.

Vice-Chairman Haire: In 1972, legislation was enacted to set up the original University of North Carolina Board of Governors. Prior to that time, we had an old committee of 100 that governed the UNC Chapel Hill campus. The other campuses in the system sort of ran around doing the best they could. At that time, a rather innovative type of system was instituted to set up a supercommittee or board to set the policy for the whole state system. It was determined that there would be 32 members on the board. The way the original board was constituted was that 16 participatorial universities selected two members to the board. The original terms were for eight years and the names were put in a pot. Names were drawn from this pot and here it was determined whether you had a two-year, four-year, or six-year term. Subsequently, that is how the board has operated (on eight-year terms). After the merger of all the 16 universities in North Carolina, including historically Black colleges and universities (Winston-Salem State, North Carolina A & T, North Carolina Central, Fayetteville State, Elizabeth City State, a school at Pembroke, and a school that was predominately gender oriented, UNC at Greensboro), the General Assembly at that time, to express its desire that there be a total representation on the board, set up certain categories. Those categories had to have enough members to represent gender, the minority party, and the minority race.

The statute under which we have operated has not really changed substantially except, in 1987, when the terms of the board members were reduced from eight years to four years. Under

the old law, you could serve two eight-year terms. Under the current law, a person can serve three four-year terms or a total of 12 years. We also placed a student representative on the board and we qualified some other people as meriti to serve on the board. The whole concept, from the beginning, is that the board be representative of the geographic, gender, and racial makeup of North Carolina. This is the purpose for which the board has worked over the years. The one uniqueness about the university system is that we have a University Board of Governors that sets the overall policy for the system; yet, there is a great delegation of authority back to the board of trustees at each individual university. I don't know of any other state in the nation that has this form of system which allows this type of delegation of authority or two tiers of authority. This is one of the greatest strengths of the university system.

Even though we have a certain number of categories set in the statute, those numbers have never been hard and fast. They have been guidelines for the General Assembly in trying to determine who would serve on the board and that all institutions and all segments in all areas of North Carolina would be represented on the board.

At the current time, we have 31 members on the Board of Governors. As most of you know, there is a vacancy. Of these 31 members, we have 5 black males, 21 white males, 4 white females, and 1 black female. Well, you say what about the quota system? I would submit to you to say that the current chairman of the Board of Governors is from Winston-Salem. He is a racial minority, but he was not elected under any quota system. He was elected in the Senate when the racial minority representation did not apply. He was re-elected this year. The fact that we have these categories has not really held in the makeup of the board over the years.

If someone would try to argue that these are statutory, mandatory formulas that you have to have, I would have to say that it does not hold in this situation. If you had, under the present statute, wanted to call the formula a quota, there would only be four gender seats and four racial minority seats. As presently constituted, there are five in each category for a total of ten. Once again, if comparing the statistics, 25% if working off the hard and fast quota, whereas, these two groups represent 32+% of the total board.

How does it stack up geographically? Under the present board, there are 5 members from the west (three from Asheville, one from Sylva, and one from Shelby). In the Piedmont, there are 11 members currently (one from Winston-Salem, two from High Point, four from Charlotte, one from Burlington, one from Pinehurst, one from Gastonia, and one from Greensboro). There are presently 14 members from the east (one from Rose Hill, three from Raleigh, two from Cary, one from Manteo, one from Fayetteville, one from Durham, one from Jacksonville, one from Kinston, one from Chapel Hill, one from New Bern, and one from Wilmington).

This brings us to where we are today. We have the finest state system in the nation and it is recognized as such. I would like to think of it in terms of making a cake. Over the years, people have brought different attributes to the board like different ingredients to a cake. They are all separate when they go in, but once they are mixed together you come out with a beautiful product.

The Chairman thanked Vice-Chair Haire for his background information on the Board of Governors and introduced Kory Goldsmith, Research Division Staff to the Committee.

Kory Goldsmith presented a memorandum to each Committee member referencing the legal qualifications of nominees for election to the UNC Board of Governors. She also reviewed

the terms in House Resolution 166 governing the election of the UNC Board of Governors members.

Ms. Goldsmith's determinations of statutory disabilities were based solely upon the information provided in the nominees' applications. She explained to the Committee members that except for the current at-large seat, which is a vacancy, all the other eight-seat terms do not begin until July 1, 1999. Some of these nominees are currently on the board of trustees of constituent institutions. If those individual terms expire June 30, 1999, they really don't have a statutory disability because they will no longer hold that position at the time that they take the new position. An asterisk was placed beside their names. In some instances, she was not sure whether or not some of them had statutory disabilities. It was difficult for her to tell from the information provided or from the statutes whether or not the position they hold constitutes an office. In addition, some offices or some positions would be inconsistent with holding a position on the Board of Governors. Ms. Goldsmith tried to indicate this in her memorandum. Any nominee can cure a disability by resigning from the position. So it does not mean that some of the nominees with notations cannot be elected, but they would have to resign their position before taking this office. Ms. Goldsmith noted that Mr. Richard "Dick" S. Jones, Jr. has no current statutory disability because he is on the board of trustees. If that person were elected to the at-large seat to fill the vacancy, that vacancy would start before July 1, 1999. That individual would have to resign from his board of trustees prior to the end of the term.

Chairman Oldham opened the floor for questions. With no questions, the voting ballot was distributed among the Committee and ex-officio members. The Chairman explained that each member make sure he/she voted for the number of candidates indicated on the ballot (atlarge seat should have 10 candidates). He also explained that any ballot that did not have the number of candidates called upon would not be validated and would not be counted in the total. He asked that they be sure to sign their ballots because they would become public record and filed after the meeting adjourned. The Chairman explained that the persons receiving the highest votes would be the ones included on the final ballot. He announced that tabulation of ballots would be made by Research staff, Kory Goldsmith and Sara Kamprath and his assistant, Delta Prince. The Committee recessed until the results of the tabulation were made known.

Rep. Gray: When do you anticipate holding this vote to the full House?

Chairman Oldham: It is currently scheduled for the March 23, 1999. This is well within the time dictated by the statute, which was to hold elections before April 6, 1999.

Rep. Haire made a motion that the Committee offer the names announced as the committee report to be submitted to the House floor as the final ballot upon which members of the full House of Representatives would vote.

The Chairman asked that all who favored the motion to raise their hands. The motion passed and the meeting adjourned at 12:45 pm.

TO ESTABLISH THE PROCEDURE FOR 1 A HOUSE RESOLUTION 2 NOMINATING AND ELECTING **MEMBERS** OF THE BOARD GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA.

4 Be it resolved by the House of Representatives:

Section 1. The following procedures for nominating and electing nine 6 members of the Board of Governors of The University of North Carolina (hereinafter the "Board of Governors") are adopted:

I. COMMITTEE RESPONSIBILITIES.

- It is the duty of the University Board of Governors Nominating 10 Committee of the House of Representatives (hereinafter the "Committee") to conduct 11 a process for nominating and electing persons for each opening in each category of 12 seats on the Board of Governors to which the House of Representatives is to elect 13 members.
- 2. The Committee shall receive nominations for election to the Board of 14 15 Governors through March 15, 1999. Each Representative may nominate up to two 16 persons. In order for a person to have standing as a nominee, that person must be 17 formally nominated by a member of the House of Representatives. Only a written 18 nomination that includes all the requested information, which is submitted on a form 19 provided by the Chair of the Committee for that purpose, and that is received in the 20 Office of the House Principal Clerk no later than 7:00 p.m. on March 15, 1999, shall 21 constitute a formal nomination. Delivery by facsimile transmission shall constitute 22 valid receipt if the communication or submission is in fact received. An individual 23 cannot be a nominee or be nominated in more than one category. An individual is 24 not eligible for nomination if he or she was nominated and not elected to the Board 25 of Governors by the Senate during the 1999 Session.

- 3. A Representative may nominate persons only for the categories available for election by the House of Representatives. In the 1999 Session, the House of Representatives will elect:
 - (a) Four persons in the at-large category, for four-year terms;
 - (b) Two persons in the minority race category, for four-year terms;
 - (c) Two persons in the woman category, for four-year terms; and
 - (d) Due to a vacancy, one person in the at-large category, for the remainder of the unexpired term that ends on June 30, 2001.
 - 4. On or after March 18, 1999, the Committee shall list all nominees by category. The Committee shall screen the nominees as to their qualifications, experience, opinions, and statutory suitability. The Committee may screen nominees by interviewing, or by soliciting written information, or by both means. On completion of the screening process, the Committee shall conduct a vote to ensure that the slate of legally qualified candidates lists no more than twice the number of candidates for the total seats open in each category.
 - 5. Each nominee shall confirm his or her willingness to serve if elected. Any nominee may withdraw without the approval of the sponsor.

II. ELECTIONS IN THE HOUSE OF REPRESENTATIVES.

- 1. A ballot shall be prepared under the supervision of the Chair of the 20 Committee for the use of the House of Representatives. The ballot shall include no 21 more than twice the number of legally qualified candidates for the total seats open in 22 each category.
 - 2. The names of the nominees shall be arranged on the ballot (a) by category and (b) within each category by alphabetical order.
 - 3. The House of Representatives shall hold its election no later than the beginning of the daily session on March 23, 1999. Before the voting begins, the Speaker of the House shall explain the voting rules, which are:
 - (a) No nomination shall be received from the floor.
 - (b) In order to be elected, a nominee must receive the votes of a majority of all members present and voting in the nominee's category.
 - (c) Each member present and voting shall vote for as many nominees as there are positions to be filled in each category.
 - (d) If there is a tie between the two nominees for the at-large category to fill the vacancy that expires on June 30, 2001, there shall be another election until one of the nominees receives the votes of a majority of the members present and voting in that category.
 - (e) When fewer than two nominees in the minority race or the woman categories, or fewer than four nominees in the at-large category, receive the votes of a majority of all members present and voting for positions in those categories, a runoff to fill the open position or positions shall be conducted among the nominees who were not elected but who received the highest number of votes cast in each

1 A SENATE RESOLUTION TO ESTABLISH THE PROCEDURE FOR 2 NOMINATING AND ELECTING MEMBERS OF THE BOARD OF 3 GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA.

4 Be it resolved by the Senate:

Section 1. The following procedures for nominating and electing 6 members of the Board of Governors of The University of North Carolina are 7 adopted:

I. COMMITTEE RESPONSIBILITIES.

- 1. It is the duty of the Senate Committee on Education/Higher Education (hereinafter referred to as the "Senate Committee") to choose nominees for each opening in each category of seats on the Board of Governors of The University of North Carolina to which the Senate is to elect members.
- 2. The Senate Committee shall receive suggestions of proposed candidates for nomination for election to the Board of Governors of The University of North Carolina through February 16, 1999. A Senator may propose as a candidate for nomination as many persons in a category as there are positions to fill in a category. In 1999 the total number of positions is eight. In order for a person to have standing to be considered as a candidate for nomination by the Senate Committee, that person must be formally proposed as a candidate for nomination by a member of the Senate. Only a written nomination on a form provided by the cochairs of the Senate Committee for that purpose and received in the Office of the Senate Principal Clerk no later than 5:00 p.m. on February 16, 1999, shall constitute

1 formal proposal of a candidate. An individual cannot be a candidate for nomination 2 or be nominated in more than one category. 3

- A Senator may propose candidates for nomination only for the 4 categories available for election by the Senate. In the 1999 Session, the Senate will 5 elect:
 - (a) Two persons in the political minority party, for four-year terms; and
 - Six persons in the at-large category, for four-year terms. (b)
- 4. On or after February 17, 1999, the Senate Committee shall list all 10 proposed candidates for nomination by category. The Senate Committee shall screen 11 the proposed candidates for nomination as to their qualifications and background and 12 may interview each one to make sure that suitable persons are nominated for each 13 category. The Senate Committee shall ascertain that each candidate for nomination 14 is willing and able to serve and has no statutory disability. On completion of the 15 screening process, the Senate Committee shall vote on each candidate proposed for 16 nomination. If a sufficient number of nominees who are legally qualified are 17 submitted in a category, then the slate of candidates shall list at least twice the 18 number of candidates for the total seats open in a category. A candidate for 19 nomination that receives the vote of a majority of those members of the Senate 20 Committee present and voting shall become a nominee on the Senate ballot.
- The cochairs of the Senate Committee shall ascertain whether the 22 nominees for election by the Senate would serve if elected. Any nominee may 23 withdraw without the approval of the sponsor.
- 6. Senate Committee nominees shall be placed before and recommended 25 to the Senate for election.

II. ELECTIONS IN THE SENATE.

- 1. A ballot shall be prepared under the supervision of the cochairs of the 28 Senate Committee for the use of the Senate.
- 2. The ballot shall list only the names of those nominees proposed by the 30 Senate Committee who have consented to run and for whom the Senate is entitled to 31 vote. Their names shall be arranged: (i) by category; and (ii) within each category, 32 alphabetically by surname.
- 3. The Senate shall hold its election no later than the beginning of the 34 daily session on February 18, 1999. Before the voting begins, one of the cochairs of the Senate Committee shall explain the voting rules, which are:
 - No nomination shall be received from the floor. (a)
 - In order to be chosen, a nominee must receive the votes of a (b) majority of all members present and voting in the nominee's category.
 - Each member present and voting shall vote for as many nominees (c) as there are positions to be filled in each category, and any ballot not so marked shall be deemed void as to that category.
 - When fewer than two nominees in the political minority party (d) category, or fewer than six nominees in the at-large category,



7. The results of the election in the Senate shall then be sent by Special Messenger to the House of Representatives.

III. NOTIFICATION OF ELECTION RESULTS.

When the election process is complete, the cochairs of the Senate 39 Committee shall notify the Secretary of the Board of Governors of The University of 40 North Carolina of the names of the persons elected by the Senate and the category 41 and term for which each person was elected.

Section 2. This resolution is effective upon adoption.
