Minutes

The Federal Relations and Indian Affairs Committee met on Wednesday, April 15, 2009, at 2:00 p.m. Co-Chairman, Representative Dan Blue, called the meeting to order and the following members were present: Co-Chairman, Representative Sutton; Representatives Frye, Pierce, Brown, Gillespie, and West. A copy of the agenda and visitor registration is attached.

The Chair welcomed the members and introduced the staff. The Sergeants-at-Arms and Pages were also introduced.

HB 411

Representative Sutton, the bill's sponsor, was recognized to explain HB 411, an act to provide for the designation of interim members to serve on the Commission of Indian Affairs in the event that a tribe or group is temporarily unable to fill a vacancy on the Commission. After a brief discussion Representative West made a motion to give the bill a favorable report. The motion passed.

HB 412

Representative Sutton, the bill's sponsor, explained HB 412, an act to provide for two additional members of the advisory council on Indian Education. He moved to have a proposed committee substitute before the Committee for discussion. All were in favor. Following Representative Sutton's explanation of the proposed committee substitute, Representative Frye made a motion that it be given a favorable report, unfavorable as to the original bill and that the bill be re-referred to the Committee on Appropriations. The motion passed. The proposed committee substitute will change the bill's title to: an act to

provide for two additional members of the advisory council on Indian Education and to broadly include state Indian tribes and communities in the membership.

HB 945

The last bill before the Committee was HB 945, an act requiring that the North Carolina Department of Health and Human Services ensures enforcement of the Federal Indian Child Welfare Act. Representative Sutton, the bill's sponsor, asked that a proposed committee substitute be before the Committee for discussion. All were in favor. After questions and discussion by members, Representative Gillespie moved that the proposed committee substitute be given a favorable report, unfavorable as to the original bill, and be re-referred to the Committee on Health. The motion passed.

There being no further bills before the Committee, the meeting adjourned.

AN ACT TO PROVIDE FOR THE DESIGNATION OF INTERIM MEMBERS TO SERVE ON THE COMMISSION OF INDIAN AFFAIRS IN THE EVENT THAT A TRIBE OR GROUP IS TEMPORARILY UNABLE TO FILL A VACANCY ON THE

A BILL TO BE ENTITLED

COMMISSION.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 143B-407(b) reads as rewritten:

Members serving by virtue of their office within State government shall serve so long as they hold that office. Members representing Indian tribes and groups shall be elected by the tribe or group concerned and shall serve for three-year terms except that at the first election of Commission members by tribes and groups one member from each tribe or group shall be elected to a one-year term, one member from each tribe or group to a two-year term, and one member from the Lumbees to a three-year term. The initial appointment from the Indians of Person County shall expire on June 30, 1999. The initial appointment from the Triangle Native American Society shall expire June 30, 2003. The initial appointment of the Occaneechi Band of the Saponi Nation shall expire June 30, 2005. Thereafter, all Commission members will be elected to three-year terms. All members shall hold their offices until their successors are appointed and qualified. Vacancies occurring on the Commission shall be filled by the tribal council or governing body concerned. Any member appointed to fill a vacancy shall be appointed for the remainder of the term of the member causing the vacancy. The Governor shall appoint a chairman of the Commission from among the Indian members of the Commission, subject to ratification by the full Commission. The initial appointments by the General Assembly shall expire on June 30, 1983. Thereafter, successors shall serve for terms of two years.

In the event that a vacancy occurs among the membership representing Indian tribes and groups and the vacancy temporarily cannot be filled by the tribe or group for any reason, the Commission membership may designate a tribal or group member to serve on the Commission on an interim basis until the tribe or group is able to select a permanent member to fill the vacancy. The service of the interim member shall terminate immediately upon appointment by the tribe or group of a member to fill the vacancy in its membership."

SECTION 2. This act becomes effective July 1, 2009.

SUMMARY: This act provides for the appointment of interim members to the Commission on Indian Affairs in the absence of appointment by the procedure provided by statute. This act becomes effective July 1, 2009.

CURRENT LAW: Members of the Commission on Indian Affairs are appointed by the General Assembly and various State agencies, as well as selected by the tribes or groups designated by statute. The tribes or groups select a total of 21 members.

BILL ANALYSIS: This act provides that if the tribes or groups do not fill a vacant position, or any reason, then the Commission has the authority to appoint a tribe or group member until the position is filled in the normal manner. The interim appointee would serve until the new tribe or group member is selected.

EFFECTIVE DATE: This act becomes effective July 1, 2009.

BACKGROUND: The Commission on Indian Affairs' duties include the following:

- To study, consider, accumulate, compile, assemble and disseminate information on any aspect of Indian affairs.
- To investigate relief needs of Indians of North Carolina and to provide technical assistance in the preparation of plans for the alleviation of such needs.
- To confer with appropriate officials of local, State and federal governments and agencies of these governments, and with such congressional committees that may be concerned with Indian affairs to encourage and implement coordination of applicable resources to meet the needs of Indians in North Carolina.
- To cooperate with and secure the assistance of the local, State and federal governments or any agencies thereof in formulating any such programs, and to coordinate such programs with any programs regarding Indian affairs adopted or planned by the federal government to the end that the State Commission of Indian Affairs secure the full benefit of such programs.
- To act as trustee for any interest in real property that may be transferred to the Commission for the benefit of State-recognized Indian tribes in accordance with a trust agreement approved by the Commission. The Commission shall not hold any interest in real property for the benefit of federally recognized Indian tribes.
- To review all proposed or pending State legislation and amendments to existing State legislation affecting Indians in North Carolina.

SUMMARY: This act adds two members to the State Advisory Council on Indian Education, and provides that the members are to be broadly representative of the same tribes and communities designated for Indian members of the State Commission on Indian Affairs. This act becomes effective July 1, 2009.

BILL ANALYSIS: This act:

- Increases the membership of the State Advisory Council on Indian Education from 15 to 17 members. The number of Indian parents of children in public schools is increased from 8 to 9; the number of Indian educators for public elementary and secondary schools is increased from 2 to 3 members.
- Provides that the Indian members are broadly representative of the Indian tribes and communities set forth for Indian members of the Commission on Indian Affairs.

EFFECTIVE DATE: This act becomes effective July 1, 2009.

BACKGROUND:

State Advisory Council on Indian Education: The duties of the Advisory Council include the following: advise the State Board of Education on ways to meet more effectively the educational needs of Indian students; advocate meaningful programs to reduce and eventually eliminate low achievement and concurrent high attrition rates among American Indian students; prepare an annual report on a fiscal year basis on the status of Indian education, said report to be presented to the State Board of Education and to the various Indian tribal organizations at the statewide Indian Unity Conference; and work closely with the Division of Indian Education in the Department of Public Instruction to improve coordination and communication between and among programs.

Commission on Indian Affairs, Indian membership: The Coharie of Sampson and Harnett Counties; the Eastern Band of Cherokees; the Haliwa Saponi of Halifax, Warren, and adjoining counties; the Lumbees of Robeson, Hoke and Scotland Counties; the Meherrin of Hertford County; the Waccamaw-Siouan from Columbus and Bladen Counties; the Sappony; the Occaneechi Band of the Saponi Nation of Alamance and Orange Counties, and the Native Americans located in Cumberland, Guilford, Johnston, Mecklenburg, Orange, and Wake Counties. The Coharie shall have two members; the Eastern Band of Cherokees, two; the Haliwa Saponi, two; the Lumbees, three; the Meherrin, one; the Waccamaw-Siouan, two; the Sappony, one; the Cumberland County Association for Indian People, two; the Guilford Native Americans, two; the Metrolina Native Americans, two; the Occaneechi Band of the Saponi Nation, one, the Triangle Native American Society, one.

SUMMARY: This act directs the Division of Social Services of the Department of Health and Human Services to take action to ensure that federal policy under the Indian Child Welfare Act is implemented. This act becomes effective July 1, 2009.

BILL ANALYSIS: This act requires the Division of Social Services of the Department of Health and Human Services to ensure that local county departments of social services implement policies pursuant to the federal Indian Child Welfare Act. The policies implemented shall:

- Identifying all children eligible under the Indian Child Welfare Act in any child welfare proceeding, including proceedings related to child custody, foster care, and adoption.
- Ensuring proper application of the federal Indian Child Welfare Act.
- Ensuring that the family and tribe of a child eligible under the Indian Child Welfare Act have adequate notice of any child welfare proceeding throughout the legal process.

EFFECTIVE DATE: This act becomes effective July 1, 2009.

BACKGROUND: The Indian Child Welfare Act (ICWA), passed by Congress in 1978, is a federal law which regulates placement proceedings involving Indian children. The purpose of the legislation was to re-establish tribal authority over the adoption of Native American children, with the goal of strengthening and preserving Native American families and culture. If the child is a member of a federally recognized tribe or eligible for membership in a federally recognized tribe, then the child has the right to protection under the ICWA. These rights apply to any child protective case, adoption, guardianships, termination of parental rights action, runaway/truancy matter, or voluntary placement of your children. The ICWA was created in 1978 by the federal government in order to re-establish tribal authority over the adoption of Native American children. The goal of the act when it passed in 1978 was to strengthen and preserve Native American families and culture. The ICWA sets minimum standards for the removal of Indian children from their homes. The ICWA requires that placement cases involving Indian children be heard in tribal courts if possible, and permits a child's tribe to be involved in state court proceedings. It requires testimony from expert witnesses who are familiar with Indian culture before a child can be removed from his/her home. If a child is removed, either for foster care or adoption, the law requires that Indian children be placed with extended family members, other tribal members, or other Indian families.

Whereas, based on nationwide studies conducted between 1969 and 1974, 25% to 35% of Indian children were removed from their homes and placed in non-Indian foster and adoptive homes by state courts and welfare agencies; and

Whereas, in 1978, the United States Congress heeded the call of the great Lakota leader Sitting Bull by passing the Indian Child Welfare Act, commonly known as ICWA; and

Whereas, ICWA is viewed as a requisite to eliminating the practice of state entities that tended to remove an inordinately large number of Native American children from their homes without full appreciation of traditional Native American culture, custom, and child-rearing practices; and

Whereas, North Carolina should adopt measures to ensure full implementation of ICWA for State-recognized Indian tribes and Indian organizations in relation to the care and custody of Indian children; Now, therefore,

The General Assembly of North Carolina enacts:

SECTION 1. The Division of Social Services of the Department of Health and Human Services shall ensure that local county departments of social services implement policies pursuant to the federal Indian Child Welfare Act. Policies implemented pursuant to this section shall:

- (1) Identify all children eligible under the Indian Child Welfare Act in any child welfare proceeding, including proceedings related to child custody, foster care, and adoption.
- (2) Ensure proper application of the federal Indian Child Welfare Act.
- Ensure the family and tribe of a child eligible under the Indian Child (3) Welfare Act have adequate notice of any child welfare proceeding throughout the legal process.

The Division of Social Services shall collaborate with the American Indian Mothers, Inc., to implement the requirements of this section.


