

More than \$260 Million Awarded in 2022








2022 GREAT Grant Award Details

- Total awards to date: 92
- Total providers awarded: 15
 - 3 telephone membership co-operatives
 - 2 electric membership co-operatives
 - 5 publicly traded corporations
 - 2 multi-state internet service providers
 - 3 small businesses
- Awarded average cost per location: \$4,775.49
- Total awarded locations: 112,112
- Total match amount: \$146,692,467.78
- 2021 county tiers:
 - Tier 1: 34
 - Tier 2: 35
 - Tier 3: 17
- Awards by region:
 - Mountain: 19
 - Piedmont: 32
 - Coastal Plain: 35





How Did We Get to the \$267 Million?

Jan. 31, 2022	Application window opened
May 4, 2022	Application deadline
May 31 - June 20, 2022	Public posting period for protests
June 21 - Aug. 10, 2022	Protest review and decisions
Aug, 12 - 22, 2022	Application revisions (post protest)
July 18, 2022	Rolling award round 1
Aug. 1, 2022	Rolling award round 2
Aug. 31, 2022	Rolling award round 3



Protests of Eligible Locations

- 216 protests received
- More than 200,000 location points
- Protesting internet service provider can only submit a protest if the:
 - Proposed project covers an area that is protected area as defined in our Guidance Document

 OR
 - Proposed project area contains 10% or more of total households with access to broadband service



Protests of Eligible Locations

Protest Analysis

- Each protest is review individually
- Data submitted by protester is analyzed for the following:
 - Granularity of information submitted by the protesters
 - Protected areas
 - 10% threshold
 - "Self-protests"
 - Comparison with FCC Form 477 Data
 - Comparison with Speed Test Data (N.C. Broadband Survey)
- Protest decisions are exempt from the contested case provisions of the Administrative Procedure Act
- Some protest information is deemed confidential per statute



Potential Program Revisions for Future GREAT Grant Rounds

- Adjustments to county partnership process
 - Consider engaging counties after vetting and initial scoring of projects
 - Simplify matching fund calculations
 - (ARPA funds won't be applicable in future years)



Identifying Eligible Areas Moving Forward

- New FCC Broadband Data Collection Process
 - Serviceable Location Fabric September
 - Broadband Availability Data November
 - Challenge Processes
- Collection of availability data directly by the state
- Continuation of N.C. Broadband Survey
- Consider receiving protests/challenges to map prior to future rounds (GREAT grant and Completing Access to Broadband)
