This number reflects the number of applications received during this Fiscal year; however, there may have been applicants pending from the previous year that were issued a license after 07/01/2021.

There were 37 applications received with conviction records, and 35 licenses granted; with two applications pending Board review. There were no applications denied due to conviction.
