On September 16, 2022, the NCBDN adopted its proposed changes to Rule 21 NCAC 17 .0113 Fees. This rule, with technical changes, is scheduled to be considered by the Rules Review Commission on October 20, 2022. On October 17, 2022 the NCBDN adopted the proposed changes to the other rules published in Issue 02 and Issue 04 of Volume 37 of the North Carolina with some

changes, that the NCBDN believes, are non-substantive. Copies of the proposed rules with proposed changes, are attached.
