Subject: FY 22-23 Quarterly Distributions of Domestic Violence Center Grants

In accordance with G.S. 50B-9(c), please see attached the 2022 report on the distribution of grants from the Domestic Violence Center Fund to eligible domestic violence grantees. All eligible programs were sent contracts by September 14, 2022, within 10 business days of the certified budget with some grantees needing additional ongoing technical support.

The initial first quarter disbursement was made on October 11th, 2022. Grant payments will be made by the Department in the first month of the second, third, and fourth quarters. Attached is a list by county, of all grantees that have received first-quarter payments or have been approved for payment this week. Each quarterly payment totals \$12,946.12.
