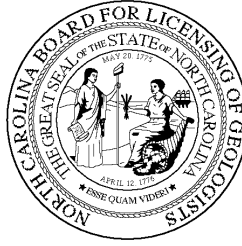

- (1a) The total number of licensees supervised by the Board is 1092.
- (2) The number of persons who applied to the board for examination was 67.
- (3) The number who were refused examination is 0.
- (4) The number who took the exam was 55 - October 2021; 57 - March 2022.
- (5) The number to whom initial licenses were issued was 73.
- (5a) The number who failed the examination is 36.
- (6) The number who applied for license by reciprocity or comity was 23.
- (7) The number who were granted licenses by reciprocity or comity was 26.
- (7a) The number of official complaints received involving licensed and unlicensed activities was 2.
- (7b) The number of disciplinary actions taken against licensees, or other actions taken against non-licensees, including injunctive relief was 0.
- (8) The number of licenses suspended or revoked was 59.

- (9) The number of licenses terminated for any reason other than failure to pay the required renewal fee was 0.
- (9a) The number of applicants for a license and, of that number, the number granted a license. 90/99
