The Board received 22 applications from individuals who were considered active military spouses and all were granted licensure.


(10) The substance of any anticipated request by the occupational licensing board to the General Assembly to amend statutes related to the occupational licensing board.

The North Carolina Audiology Association has filed to amend the statute to update the North Carolina General Statute governing the practice of Audiology to better reflect the changes in education, experience and practice of the profession in order to enhance the health and welfare of North Carolina citizens.

The Board intends to clarify the difference between over-the-counter hearing aids and prescription hearing aids.

There were 289 individuals who had not been previously licensed and were granted a full, unrestricted license by this Board.

416 individuals applied for a license through reciprocity.

416 licenses were issued through reciprocity.

22 official complaints were received.

The Board took 1 disciplinary action against a licensee.

1 licenses were suspended or revoked.

No licenses were terminated for a reason other than failure to pay the required renewal fee.

1020 individuals applied for either a temporary license or a permanent license. Of those, 1020 were granted either a temporary or permanent license. This number includes individuals who moved from a temporary license to a permanent license. Note that application fees are not required for individuals whose temporary year has been approved and are then eligible for a permanent license.

(9b) The number of applicants with a conviction record and, of that number, the number granted a license, denied a license for any reason, and denied a license because of a conviction.

The Board only requests information pertaining to professional violations. No applicants were denied due to conviction records.
