Fiscal 2022 Results

- Sales revenue fiscal 2022 = \$1,726,570,640 versus 2021 = \$1,593,785,865. An 8.3% increase over previous year.
- Mix-beverage revenue 2022 = \$329,071,980 versus 2021 = \$217,188,253. A 51.5% increase over previous year.
- General fund contribution = \$493,381,985.
- Total revenue distribution = \$671,741,587.

ABC OMMISSION NORTH CAROLINA

Fiscal 2023

- Sales revenue YTD 2023 = \$973,556,867 versus 2022 = \$898,625,194. An 8.34% increase over previous period.
- Mix-beverage revenue YTD 2023 = \$182,628,760 versus 2022 = \$158,060,812. A 15.5% increase over previous period.
- Projected 2023 fiscal revenue = \$1,869,835,590.
- Projected general fund contribution = \$540,008,518.
- Projected local distribution = \$193,159,274.

Vendor – LB&B

- Currently shipping an average of 760,000 cases per month with a 95% fill rate.
- Shipped over 7,300 loads of product to local ABC Boards last year.
- The ABC Commission has 3 teammates currently working in the warehouse to manage the contract with LB&B. These teammates are tasked with measuring the KPI's, load approvals and board interaction.



Warehouse Inventory

- Warehouse inventory December 2021 = 60 million dollars and 400,000 cases.
- Warehouse inventory December 2022 = 101 million dollars and 936,000 cases.
- Out of stocks January 2022 = 163,008 cases, January 2023 = 50,199.
- Building partnerships with brokers and suppliers to attain the necessary product to continue our growth path.
- Currently stored in two warehouses State facility and Clayton rental. Transferring half of our case sales monthly from Clayton to Raleigh.

Allocated Bourbon

- Two methods to allocate the bourbon's we receive in NC are "Limited Distribution" and "75%/25%".
- "Limited Distribution" a max order quantity is set by the commission based on the number of cases we have for the month. The boards that order this product first will receive the max cases. Ex. Brand A has 125 cases, and the commission sets the quantity at 1 case, 125 boards will receive brand A.
- "75%/25%" based on sales volume of the state boards. Top 30 boards are 75% of the state's revenue. Example state receives 1,000 cases of Buffalo Trace the top 30 boards receive 750 cases and the rest get 250.
- Suppliers are supporting NC with more bourbon because of these methods and because boards are selling 60% to mix-beverage customers.
- 2022 versus 2021 allocated bourbon shipments are up 17% in volume and 43% in the number of bourbon brands.

Modernization

- Working with DPS/DIT to establish dedicated IT support for the ABC Commission to modernize outdated business systems. The 30+ yearold system will be updated to allow customers to apply for ABC permits online.
- The Commission's Business System Analyst will work closely with DPS IT to develop efficient, easy-to-use systems that meet the needs of both customers and ABC staff.
- Partnering with SAS on technology that is centered around spiritous liquor inventory, shipping, and stock levels. We envision this system will provide local boards and general public transparency on inventory levels within the state warehouse and local ABC boards.



Permitting

- Updated file retention policy to start utilizing internal computer system more effectively and work toward paperless system to maintain applications.
- Updating renewal/registration process for 2023-2024 with assistance from Public Outreach Section.
- Reassigned geographical areas among compliance officers so audit investigations are more evenly distributed.



Special Services

- Working to strengthen the public health, wellness and safety of NC communities through customer service and education.
- Conducted community education outreach programs for over 670 participants in alcohol law enforcement programs and provided training awareness and support to 88 of the 171 ABC boards.
- The efforts of our Talk it Out Ambassadors, as speakers and representatives, furthered our messaging throughout NC by engaging over 6,600 participants in 41 community events.
