Overview & Process

The North Carolina Office of Strategic Partnerships (OSP)

- Was started to increase government-research and government-philanthropy communication, coordination, and partnership.
- Develops, launches, and enhances partnerships between state government and North Carolina's research and philanthropic sectors
- Increases government transparency, demystifies government, opens opportunities for government and NC's colleges, universities, and others to partner
- Is housed within the Office of State Budget and Management

Overview & Process

- Making state government more open and responsive is critical.
- OSP developed and now implements processes for government-research and government-philanthropy engagement
 - Overall framework for engagement
 - Nimble and tailored to government needs and goals
 - Leverages NC's vast and deep capacity in higher education (4- and 2-year institutions) and philanthropy
- Widely attended virtual sessions for partners from across sectors
- 30+ government-research partnership opportunities with ~14 state agencies across Cabinet and Council of State; interest from 350+ researchers at ~50 colleges and universities

Overview & Process

- Capitalizes on expertise across the state and develops and increases state government's internal capacity to generate and use research evidence for decision making
- Provides a unique combination of opportunities for cross-sector facilitation and dialogue, technical assistance, and other resources and support.
- Receives regular requests from state governments and others interested in learning from and/or replicating our processes and approaches (e.g., Alabama, Arkansas, Colorado, Minnesota, Tennessee).

Resources (personnel and funding)

- Staff: Director, Deputy Director, Evidence Advisors, Philanthropy Liaison, Program Manager, Program Support Specialist, Interns
- State and external support/funding
- OSP raises funds in part to support state agencies' need for greater capacity to answer research questions
- In-kind contributions come from partners across sectors government, research, philanthropy in the form of expertise, experience, guidance, and input to OSP about all aspects of the work.

Research Impact: Summary

- Types of impact include
 - Research results that can inform programs, policies, and investments
 - Specific programmatic guidance
 - Improved communication with NC residents through state agency operations
 - Substantial increase in awareness of and opportunities for all of NC's colleges and universities to partner with state agencies
 - Increasing government knowledge and capacity to benefit from research

• OSP prioritizes partnerships that are scalable, sustainable, and that develop public, open-source resources.

Research Impact: Project Examples

Department of Public Instruction & NC Collaboratory

- OSP co-planned and co-hosted with the NC Department of Public Instruction and the NC Policy Collaboratory a researcher interest meeting for the \$6.73M COVID-19 Learning Impact Program 2022 RFP.
- 60+ researchers from nearly 20 colleges and universities attended the meeting
- Researchers submitted 22 proposals for the partnership
- DPI selected and is funding 20 projects with researchers from multiple
 NC colleges and universities

Department of Information Technology & The Duke Endowment

- Led by the OSP Philanthropy Liaison, the NC Office of Digital Equity and Literacy (ODEL) and The Duke Endowment are partnering to support a literature review to learn "what evidence-based digital literacy programs exist and what investments in innovation and research are needed because evidence isn't yet available."
- ODEL and OSP partnered to share the opportunity.
- Results will be shared widely with NCDIT, OSP, and others to highlight learnings about digital literacy and possibilities for partnerships.

OSP Evidence Advisors & Department of Adult Correction

- OSP (primarily the Evidence Advisors) are assisting the Department of Adult Correction with developing a research/learning agenda. This includes identifying research and evaluation priorities.
- This is an area of technical assistance that OSP provides to agencies in a range of ways; can be short- or long-term engagement and related to an entire department or parts of a department.

Lessons that the legislature and state agencies can apply

- There is increasing demand for and growing understanding of the value of research
- Importance of being based *inside* government
- Approaches for developing and implementing partnerships are replicable within and across agencies
- Need dedicated government capacity
- Researchers and government are eager to partner with each other but often don't know how
- Enhancing government's use of evidence can increase government efficiency and save taxpayer dollars
- Nimbleness and adaptability are important
