### Question 5: How much would it cost to make the Longleaf Commitment Program recurring?

Through the 2021 budget, the General Assembly appropriated \$25.5M NR in federal COVID-19 funds to expand need-based aid for community college students who were 2022 high school graduates. This followed a similar program created by the Governor's Office funded with federal COVID-19 funds for 2021 high school graduates. The program is called the "Longleaf Commitment Program."

Based on data the Fiscal Research Division received from the State Education Assistance Authority, it would cost approximately \$20 million recurring to make this an ongoing program for the 2023 high school graduating class and beyond.

### Question 6: What is the breakdown of equipment funding allotted to each community college?

FY 2023-23 total equipment allotments for each college can be found here.

A total of \$48,962,762 was allocated in FY 2022-23 through the Community College Equipment allotment. A college's regular Equipment allocation is determined by the sum of the following components:

Base Allocation: Each college receives a base of \$100,000.

Weighted FTE Allocation: The remaining balance of the Equipment allotment is allocated among colleges based on each college's equipment full-time equivalent (E/FTE). Colleges receive \$276.95 per E/FTE. A college's E/FTE shall be calculated by applying the following ratios to the actual FTE for the preceding year, and adding the products to obtain a sum for each college:

- b) Moderate equipment intensity programs.....0.75 (Occupational Extension)
- c) High equipment intensity programs......1.00 (Technical and Vocational)

## Question 7: What is Economic Development (fund code 1500) at the System Office?

This budget code is comprised of funds for the Community College System's Economic Development Team, which provides education, training, and support services for new, expanding, and existing business and industry in all 100 North Carolina counties through our network of 58 community colleges.

## Question 8: Is it possible to compare faculty pay to the private sector in those same career fields?

There is limited data to view the faculty salary for each subject area, however, the Community College System reports that the average faculty salary for Tier 1A course instructors is \$56,387 for FY 2022-23.

### Question 9: What is the cost of athletics programs at community colleges?

Per G.S. 115D-43: No State funds, student tuition receipts, or student aid funds shall be used to create, support, maintain, or operate an intercollegiate athletics program at a community college.

For that reason, we have limited data at the State-level of community college spending on athletics activities. However, the U.S. Department of Education maintains a tool that compiles spending of athletics programs across higher education.
