## Office of State Budget and Management Establishing Laws

- NC Constitution Article III, Section 5(3)
  - Governor shall prepare and recommend a budget
- G.S. 143C-2-1 The Governor of North Carolina is Director of the Budget but may delegate authority
- G.S. 143C-6-1 The budget shall be administered as enacted by the General Assembly

## Office of State Budget and Management General Responsibilities

- Prepares the Governor's recommended budget and advises the Governor on budgetary matters (G.S. 143C-3-5)
- Leads development of proposed agency base budgets (G.S. 143C-1-1)
- Oversees execution of the budget as enacted by the General Assembly (G.S. 143C-6-4)
- Monitors overall spending and revenue collections to ensure a balanced budget

## Office of State Budget and Management General Responsibilities

- Produces consensus revenue forecast with Fiscal Research Division
- Produces population estimates and projections (State Demographer)
- Develops and monitor State agencies' performance evaluation measures
- Reviews fiscal and regulatory impact of proposed rule changes by State agencies

# Office of State Budget and Management Additional Programs/Responsibilities

- Staffs the Council of Internal Auditing
- Staffs the Council of State
- Conducts studies and reviews as required in the law
- Administers some grants to non-State entities
- Operates Hometown Strong program
- Assists in the coordination of State response to disaster recovery
- Distributes and manages federal COVID relief funds, as directed by the North Carolina General Assembly and the federal government (Pandemic Recovery Office)

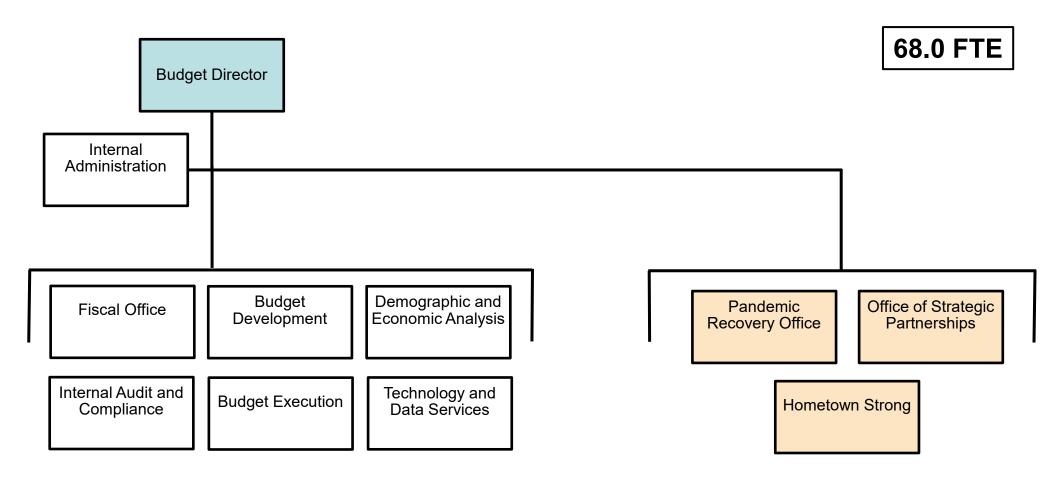

# Office of State Budget and Management NC Pandemic Recovery Office (NCPRO)

- Established by S.L. 2020-4
- Authorized through June 30, 2023 (S.L. 2021-180, Section 23.2)
- Oversees and coordinates disbursement of funds as directed by the North Carolina General Assembly and federal government
- Reports periodically to the Joint Legislative Commission on Government Operations:
  - Quarterly on allocations of coronavirus relief funds (S.L. 2021-1, Sec. 3.1)
  - Monthly on unexpended amounts from those allocations (S.L. 2021-1, Sec. 1.7(b))
  - Monthly on the number of staff hired by NCPRO (S.L. 2021-1, Sec. 4.3.(b))

# Office of State Budget and Management Results First Initiative

- Partnership with Pew Charitable Trusts
- Initiative aims to provide State and local governments with training and resources to assess the effectiveness of existing programs and evaluate costs and benefits
- S.L. 2017-57, Sec. 26.3 directed OSBM to report annually on the status of implementing Results First principles in North Carolina
- Related to broader performance management efforts:
  - Governor's Advisory Committee on Performance Management
  - Performance Management Academy
  - Office of Strategic Partnerships

# Office of State Budget and Management Office of Strategic Partnerships

- 4 receipt-supported FTE funded via grants
- Coordinates partnerships between State agencies, research institutions, and nonprofits organizations on projects meant to improve State agency programs and operations
