REPORT REQUIREMENTS

SUMMARY OF THE LEGISLATION

In accordance with Session Law 2017-57 (SB 257), sec. 8.8 (d), the Advanced Placement/International Baccalaureate/Cambridge International Teacher Bonus Program provides funding to reward teachers of students who achieve successful results on advanced course examinations. The state recognizes Advanced Placement (AP), International Baccalaureate (IB), and Cambridge International Education (CIE) courses as advanced courses. Each Local Education Agency (LEA) and public charter school is entitled to funding based on the exam results of their students. The January 2023 bonus is based on exams taken in the 2021-2022 school year, specified as \$50 per exam at a score of 3 or above on AP exams, 4 or above on IB exams and "C" or higher on CIE exams, with a maximum of \$3,500 per teacher, per year. To be eligible, the teacher must be teaching in the same LEA or public school at least from the school year the data are collected until January 1 of the year that the bonus is paid.

REPORTING REQUIREMENT

The State Board of Education is reporting on advanced course teacher performance and on the bonus amount allotted for advanced course teachers in each LEA and public school in North Carolina. The impact on teacher retention is not able to be determined at this time.

Distribution of Funds

The Department of Public Instruction (DPI) distributed the funds to the LEAs and charter schools based on legislation and SBE policy. The allocations to LEAs and charter schools are based on the number of exams eligible for a bonus as reported by the College Board, International Baccalaureate Organization, and Cambridge International. These allocations are the maximum that could be distributed to teachers. It is anticipated that not all the funds will be dispersed, due to the eligibility requirements regarding the employment status of each advanced course teacher and the maximum cap for allocations.

At the time of the report, exact expenditures by LEAs and charter schools for these bonuses are not available within the current business systems. These funds are among several bonuses allotted to LEAs and charter schools within the same budget code and cannot be specifically determined. There was a \$378,350 increase in funds allocated for the January 2023 bonus compared to January 2022. In addition, anecdotally from conversations in the field, NCDPI continues to believe teachers of advanced courses value the bonus.

Final Allocation Amounts for 2021-2022 school year

NCDPI allocated a total of \$3,921,050 for the Advanced Course Bonus Program for the 2021-2022 school year, including \$3,500,500 for 70,010 AP eligible exams, \$407,650 for 8,153 IB eligible exams, and \$12,900 for 258 CIE eligible exams. These totals do reflect the 1,127 AP eligible scores earned by students enrolled in advanced coursework through NC Virtual Public Schools. The allocations were available by LEA and charter school as shown in Table 1, below.
