#### **Resolution of Incidents**

During calendar year 2022, there were no violations of G.S. 14-34.5(b) or 14-34.7(b) involving an employee or contractor working in a detention facility operated by the state. There were 142 violations of G.S. 14-34.7(c)(2). Out of the 142 violations 21 offenders were convicted, while 104 charges are still pending. The Department of Adult Correction continues to monitor these incidents and to take appropriate action to ensure the utmost safety of our employees, individuals in our custody, and all who enter our facilities.
