I have also had to reach out to Senator Steinberg's office in January of 2022 again to try to get the promised assistance from Rebuild NC. As of this date, I am still homeless. I have had MONTHS where there was zero communication from rebuild. I am medically disabled, unable to sell my property for enough to buy a new home and so very tired of being stuck and homeless. I have not recovered from Hurricane Florence and do not know when I will be in my own home again. I am forced to be squeezed into my mothers home, loving in New Jersey which is completely unaffordable. I had to use my escrow funds to move all of my belongings to new Jersey and continue to pay a mortgage on a home that was destroyed for over a year. I will not get any of those funds back and due to the need to use them I had to wait for Rebuild to change their policy and allow for a promissory note in return for a home comparable in size to the one I lost so I am still stuck again and now waiting for a grant signing . I do not know when that will happen and my file will move into the construction phase which will likely take at minimum another year of fighting with this organization. Is this the way the program is supposed to function??? Wasn't this program created for people in my situation? People with no other options besides asking for help that is NOT BEING given! My flood insurance was not enough to replace my home so the mortgage company forced a payoff of the mortgage. All I had left was the escrow which I needed to use in order to survive. I had issues with not receiving credit for materials and work completed on my home using my Fema grant. No, estimate for work completed was on my award letter. This was another reason for my appeal. This matter has been resolved upon appeal though it took over 6 months to receive a response from my appeal. 3. The damage inspection was not completed properly. She never went into my attic or crawl space or on my roof. This resulted in an incorrect estimate of repairs to be completed. In my award, you will note the repairs of the ceiling without the inclusion of the source of the damage, the roof. You can also note that in rooms that were requiring repair of floors that the application of an microbial agent was to be applied to the ceiling that was not listed as a repair. Many omissions of repairs were listed on the estimate and some unnecessary repairs were included. I requested an additional inspection because the estimate was so inaccurate. I was denied that. I have since been told that at my award signing these issues can be discussed and resolved at that point. I have also been told that the contractor would inspect the home and report any additional repairs required. I do feel that this is just going to prolong my process. Had the inspection been completed properly from the beginning, I would be close to completed properly from the beginning, I would prolong my process and it would be better if I waited. After it taking a year to get my award letter and having to appeal it, I asked for the emergency repair since it was taking so long. Legal aid of NC filed this for me. We had volunters lined up and ready to complete the emergency repair. After months of not getting a response, I consulted my caseworker and she told

I fought for 10 months to supply all of the information that they requested. It was a never-ending process it seemed like. Approximately the end of March 2021 they awarded me a new mobile home. My insurance policy was only for \$10,000 since my mobile home with a 1968 12x60. Hurricane Florence had destroyed it, the insurance company totaled it out. I spent almost two years trying to save my home, which I was unsuccessful at. They claim that I did not spend the \$10,000 on repairs to my home, not only did I spend a \$10,000, I spent another \$5,000 from where the insurance company totaled my vehicle out from the damages from the hurricane Florence. In signing the contract, they stated that if I would make an appeal for the \$5,000 I spent to have the roof put on, that it would take up to 6 months for the appeal. So I declined in appealing their decision on that. And I had to end up paying \$1,974.96 in escrow funds in order to continue on with the program. At that time frame my house was totally unlivable with both black & white molds throughout my house. I was the first applicant to be awarded in Pender county. Once the award was given, I was assigned, I believe, Pender county long-term Outreach team that was supposed to watch after me over rebuild NC. They are the ones who got me to be able to move out on Emergency

						situation because of the mold condition in my home, it was unfit to live in. One of the state inspectors came & looked at it, I assume it was from rebuilt nc, & they condemned my home. They moved me out 3 weeks later I believe approximately the first part of May of 2021. The hotel they moved me into they evicted me less than 3 months later because the state did not pay on time the money owed to them. Not only do they evict me but approximately five of the families were staying there at the time and they were evicted as well. The hotel they tried to send us to, was extremely unsanitary unsafe and I was trying to be forced to stay there. I went above the tra case manager and with the help of Pender county long-term Outreach team they help me to attain a much safer place to stay at, which is Staybridge in Wilmington North Carolina. I signed the final papers to get my home March 30th 2021. I also signed another paperwork stating that I would not sell my house, until at least April of 2022. Through all the stress that I have been through up to this point, September the 5th and the 7th I had two separate stress induced, angina heart attacks and then again another one on October 12th. One lie after another lie after another lie was giving to me as in why my house was never built. Middle part of September of 2021 they offered me a modular home, Whitney-1. They told me the material is already in North Carolina, waiting to be delivered to your property. As for the mobile home we originally offered you, we have no idea as in when those will ever be available to you. So after I look at the plan that they had offered me, it did not fit my property properly to give enough access to go to the backyard, so I told them the situation. They said since I had already signed off for this house there's nothing that they could do at this point. However, the greater horror and damage has been caused by the bureaucratic and ineffective so-called leadership and staff of RebuildNC and NCCORR. This is going to be long, but you all need to fully understand what my cousin and I have experienced over the past four years. I am including our experience with FEMA, RebuildNC/ NCCORR, NC Hope Program, and NC Homeowners Assistance Fund as they are all connected and affect us throughout this long process. This is only a highlight of what all we have experienced at the hands of inept and possibly corrupt government staff and officials. In 2017, my cousin at age 79 suffered a major stroke and was recuperating at home when Hurricane Florence hit on September 13, 2018. I have been her full time caregiver since 2017 once she returned home from rehab. We were not able to evacuate as there was nowhere that could accommodate her special needs and no one knew exactly where the storm would hit. Her family home had never flooded since it was built in the

						1960s. Thank the Good Lord that she had a walkup attic so we weathered the storm up there as the water came into her home. As I have said numerous times since, dealing with FEMA, and later RebuildNC/NCCORR has been way worse than the night and day we were in the attic during the storm. Since 14 September 2018, we have had to move three times before we found somewhere to live. It has been greatly upsetting to my cousin to be out of her familiar surroundings. Thankfully we were able to stay with friends and family for a few months after the storm until we found a place to rent in late November 2018. We were repeatedly told by FEMA from September 2018 until February 2020 that they were going to be there to help her until she got back into her beloved family home of over fifty years by assisting with the costs of temporary housing, storage fees, and the costs of moving her back into her home when it was repaired. I will say that once we got into the FEMA program at the national level after being denied repeatedly, it worked fairly well with receiving the assistance that they promised. I give kudos to the NC Bar Association who came to our town and did a special seminar for those affected by Hurricane Florence who encouraged us all to keep reapplying and challenging the FEMA. We were repeatedly told that FEMA would assist in getting her home repaired through various programs that they had. It never happend. In late February 2020 just as the pandemic began, we were informed by FEMA that the National Emergency Declaration for Hurricane Florence had not been renewed and would expire in the middle of March 2020. There would he no more help with rent, storage, and since the home was not yet repaired, there would not be any assistance to help her move back into her home. We called several of our elected officials at the State and National level, but to no avail as everyone's focus was on the pandemic. The next few months were very challenging financially as we did not have the funds to keep both her flooded home and our r

They said that the funds had been sent to Catholic Charities and the Salvation Army locally. We contacted both immediately. We were told by the local Catholic Charities that they only help people once in a twelve month period for either rent assistance or utility assistance with a cap of \$500.00. We applied for and received the \$500.00 rental assistance just once. We also contacted the local Salvation Army and were treated like we were imposing upon their time and they said that we had to go through their designated local disaster relief agency to get approved for any assistance. We called the local disaster relief agency and they said that we had to completely reapply just like we did for FEMA even though our housing and financial situation had not changed from February to March 2020. We asked why they could not approve us now since we had already been approved by FEMA at the national level. They laughed and said that would make too much sense. We had no other choice so we went through the whole application process again with the local disaster relief agency which is like applying for a mortgage. After several months of going back and forth and waiting, the woman with the local disaster relief agency said that they really did not have any funds to allocate and only helped match people with resources and that they did not have any at the time! They sent us back to the Salvation Army and the woman there was very rude. So I began asking questions as to how much our local Salvation Army and Catholic Charities received from the State of NC specifically for those affected by Hurricane Florence and was told by the woman at the Salvation Army that it was none of my business and that they did not have to provide that information. Catholic Charities also would not reveal how much they had received and said that it was their policy to put the

						every call. The last call we had with them as previously mentioned they said they could not help us! We later found out the local disaster relief agency is not even a real non-profit entity of its own, but was put under United Way as a stop gap measure. We gave our personal and financial information to an entity that should have not been given this info! In about August 2020 or so, we were notified by FEMA that they had overpaid my cousin for storage by about \$2,500.00 or so. We requested to know exactly how this was determined and the many FEMA reps with whom we spoke could not explain it. We asked for written info as to how this was specifically determined and calculated. We never received it. As a side note, every time we called FEMA, we were connected to a different person so we had to explain our whole situation to them every time from September 2018 until present. FEMA should be set up like the insurance industry where you have one person who knows your case so it would be managed more effectively. In December 2020, we were sent a letter that was dated almost a month before we received it stating that unless we started paying them that they would refer the overpayment debt to the U. S. Treasury. We still had not received the info about how and why the overpayment was determined. [It cut off our comment so we will send it to the emails listed.]

I inherited my flood-damaged property in November 2017 in the middle of the early phases of the recovery process from my father, James Dew. He participated in the FEMA assistance program and received funds from FEMA for initial repairs and housing assistance in the estimated amount of \$8,000. He began fixing damages in the home in 2016, directly following Hurricane Matthew. He moved back into the home in February of 2017 with no HVAC system, mold throughout the home, and minimal repairs completed. I have lived in the home since August 2017.
						Meeting in February 2018. Following I completed the application at the local Edgecombe Office. From helping upload documents numerous times, providing a breakdown of the program and application process, and giving updates when visiting the onsite office, the local staff relieved some of the stress that came with the RebuildNC process. If it had not been for the local Edgecombe County staff, I would have never moved through any portion of the Rebuild Application process. My RebuildNC case manager changed several times throughout

I was required to resubmit documents multiple times before they were added into the system, including my father's death certificate – the one constant in my time with the RebuildNC program. Updates were not provided on the application process. It was rare to hear from a case manager or RebuildNC team member about the program or application process. Throughout the process, different things would halt the momentum of the application's 8-step process. One of these was requiring current property taxes, which was not initially stated when applying in 2018. I inherited not only my property but \$6000 of back taxes. I was on a payment plan with Edgecombe County to pay back the delinquent taxes. RebuildNC would not accept proof of good standing on the payment plan but required the taxes to be paid to continue the program. In February 2020, I was able to use savings and, with help from my family, to pay off the remaining back taxes to secure staying in the RebuildNC program. A privilege that others may not have.
						RebuildNC sent a contract appraiser who documented my home to estimate the damage. The appraiser estimated about \$36,000 worth of repairs needed to the home directly related to damages from flooding due to Hurricane Matthew. I also went through the lead paint testing process while in the program. In November 2019, I was issued an award letter through RebuildNC. I initially did not sign the award letter. A new award letter was issued in the Spring of 2020 with adjustments. I signed and returned the award letter. In order to move forward in the process, I had to provide receipts of the work completed on the house by my father. I was able to provide receipts for some of the work, but not in the equivalent of the amount he received. Therefore, I was left with a Duplication of Benefits of roughly \$6000 that needed to be paid to receive assistance from the program. I worked with Legal Aid to address the Duplication of Benefits and was able to receive a grant through Catholic Charities to pay the DOB from my father's FEMA money. I have not received assistance from FEMA or NC agency for disaster relief. In late 2020, October or November, I was told to start looking at floor plans provided through the RebuildNC program.
						In April/May of 2021, after three years of working with RebuildNC I voluntarily withdrew from the RebuildNC program. I received an employment opportunity to take on a second work contract. I alerted the RebuildNC program about this change, which disqualified me from the program. The withdrawal letter

						was the quickest response in communication with RebuildNC that I received in three years. When I applied to RebuildNC and for the following two years, my income was under the requirement. Legal Aid, before closing my account with them due to the raise in income, stated that the funding from Catholic Charities would be returned to them since I was no longer participating in the program. I did not receive a confirmation on whether or not this occurred.
						In closing, the State of North Carolina has implemented the RebuildNC program to assist those needing to rebuild after catastrophic storms, including Hurricane Matthew in 2016, which has not accomplished the goals it set out to accomplish. My story is just one of the hundreds in my community and eastern North Carolina. Not a week goes by that I do not hear of another story where the RebuildNC program has allowed some of our most vulnerable populations to fall to the wayside with the recovery process from Hurricane Matthew. I encourage the Joint Legislative Commission on Governmental Operations, Subcommittee on Hurricane Response and Recovery to look further into RebuildNC.

On Wednesday November 23rd, ONE WEEK before my start date I received notification via Mr. Stiles and Ms. Fuquay that my general contractor has delayed my start date to January 2, 2023. They stated that soil and septic inspections were required before they could begin this is just another delay due to an incompetent contractor and mismanaged program. I don't know if this legislative committee can help but I have been homeless for 4 years. I have heard one excuse after another from rebuild. I am disabled due to medical illness and my ONLY income is my social security. I am single as well. I don't have ANY option to have a home other than dealing with rebuild. I occasionally get a call from the agency stating I am still on the waiting list to begin construction. The callers have been nice but it is all scripted. At one time (about a year ago) I asked if it was a recording or a real person. It was a real person but it is still scripted. If I ask a question the representative will try to answer but they don't seem to have a lot of broad knowledge of the program or are forbidden to answer. I don't know which it is but they do seem nice but lacking basic information. I really would like my project to be assigned to a different builder but I am afraid to ask many questions or make requests because I don't want to be "that person". Rushing flood waters knocked over block pilings under the home and the roof literally split in half all the way down and the rain water poured in our home for the next week. My daughter's and I were in Florida when the storm struck and my husband stayed with his sister in Wilmington and was unable to get back to our home for an entire week due to local flooding and week long rain. When my girls and I were finally able to get back home 2 1/2 wks later, we came home to a home that no one should have to live in, yet we had to. FEMA somehow deemed our home habitable and gave us \$4000 to make repairs and we tried but the black mold just spread like crazy. The damage to our home was estimated at over \$30k. We had no insurance, no savings and every program we applied for, we seemed to fall through the cracks. Long Term Recovery said because we had more than \$17k in damage, they wouldn't help us. Cape Fear Habitat for Humanity said our income of \$60k for a family of 6 was too high and denied us. We were on lists for volunteer muck outs and repairs and no one ever called or came to help. We have a (now 15 year old) daughter with Hypoplastic Left Heart Syndrome (also known as 1/2 a Heart) and we were so terrified for her safety that she actually lived with a neighbor of ours for over 2wks until my boss generously offered for us to rent her elderly mother's home that had been vacant for a few years. We moved into this home on Ct 12th, 2019 with nothing more than a tiny pull behind trailer of boxes. We lost most of our furniture, clothing, belongings and our kids rooms were damaged the most along with majority of their items. Applying for ReBuild NC was our last hope of having our own home again and we were so thrilled when we were approved in 2021. We were told the process would be 6 months to a year and we would have a new home on our property yet we have been stuck in limbo for over 4 years now. My boss let us rent under the pretense that this would

						rental and not in a hotel like some other Florence victims are, but it hit us hard financially to go from no rent or mortgage to paying a monthly rent for 4 years now. I was told that we would be eligible for Temporary Rental Asisstance when we were assigned a contractor. Then I was told we cant get it until the construction has actually started. Ive heard of other applicants who are getting rental assistance and they arent any further in the process than we are. No one gives straight answers and every different person seems to have a different idea of how things work. We just want to go back home. We want to finish raising our kids on our family land where their Grandma lives next door in the peace and quiet of the countryside. Our application process started in August of 2020 and award notification was received 3/29/21. The \$4093.62 for duplication of benefits was paid and it still sits in Escrow. Our original award letter was signed on 5/13/21 for our double wide to be replaced with another doublewide. In June of 2021 I was contacted and told that due to manufacturing issues, the process would be faster if we opted for a modular home instead of a MHU and I gladly agreed. On 10/7/21, we were given the O'Neill floor plans and picked out our colors for paint, flooring, siding, counters etc. and signed and returned the paperwork for it. In December of 2021, ReBuild NC contacted me with a revised award letter with the modulars info and it was signed and returned on 12/23/21. In June of 2022, I was finally told my contract had been awarded to Rescue Construction Solutions and they would contact me for a Pre-Construction walk through. To this date I have not heard a peep from my contractor and the more I hear about them the more terrified that I am that we will NEVER get back in our own home. I have been shuffled around from multiple Case Managers and Construction Liasons, easily 6 different ones or more and no one has any idea when I'll be contacted or when constuction will start. I'm hearing from other applicants

						amount of money that has been wasted by NCORR and ReBuild is insane. I want to know what happens if all the money is depleted yet we are still out here with contracts in hands waiting for our homes to be built. Who is going to build them for us? Will we just be "SOL"? I see entire new neighborhoods pop up in a month or so but we can't even get 20 new homes a month finished in this program. At this point it would be quicker and probably more cost efficient for them to hire contractors to do stick built homes. They've lied about their completion numbers. We need help from this committee, from our government, from our Governor yet the only thing happening is a few stern words of "we are happy with what's going on" and no repercussions. At their current completion rate, the program will have ended before we are all back in our own homes. It is important for your committee to know how delays and a refusal by those at Rebuild NC to communicate and relay to homeowners the answers to the questions they need to know about their properties. Applied the summer of 2020 and have been in construction since Nov. 2021. In July we moved out as the project was going ahead. The asbestos company was at my house the week of July 18th and removed siding and flooring. Rescue put in a permit that week and heard nothing until September when a new case manager looked at my file and said it was on hold due to floor plan issues. After I called my liaison about what the problem that case manager was gone. I asked and asked what the problem was and was told the same and they were working on new plans since early August which I receive mid October. The plans were just two much smaller plans than my current house. I have a nonconforming property and their not let me know what the problem was I have lost my right to have a new house built on the same place my previous house was. The standard property is 70 ft wide, my property is 50 feet wide and with the new setbacks I will only be allowed 30feet width for a home and because they changed to Modular even less. Although, the city said the permit is not complete even though Rebuild is saying that this was not demolition, but when they

						pulled off the siding off my house and left a 100 year old house exposed to the elements, pulled the toilet, sink up, some doors off they have began demolition before having permits and now that they are not able to build the original home under the Grant Agreement and the floor plans that are offered will not work as I need to make accommodations for my son when I am no longer here so he can remain in the house with support they have left my house where I can no longer repair or remodel as water is now coming through the open doors and the outside walls. The house has sat as an eyesore like that since July and I have been told unless I take a plan that will not work they will not demo. Everyone is aware that if they do not demo, the city will and put a lien on the property. This should never have happened if they would not have began demo before permits were approved, had spoken to the homeowner about the real issue before putting on hold and do expediently. What makes this situation even worse, once moved out and after they began the "demo, I no longer have insurance on the property. In a normal case, the property would be covered by the contractor's insurance until completion. With Rebuild NC a NTP (notice to precede) may or may not be issued when the homeowner moves out as the are ready to proceed. I never got one and since they put on hold I think none has been issued. Moved out second week in July and it is December with no NTP. As far as the floor plans that were offered none of them would be available this year and there was no timeline for 2023, so the excuse I now have on hold has nothing to do with the delay.

However, afterwards my parents began to experience plumbing issues that resulted in waste sewage coming up in their sinks and bathtub when the commode would flush. My parents contacted an outside plumber to address the issues and were informed by that plumber that the issue resulted from the previous contractor's work in replacing the shower in the home. In the year of 2020, we contacted the designated agency in Robeson County to address the concerns and have them

We can't get the hvac serviced (for over 3 years) because its in a dangerous area. We live in squalor. Roaches and mice are our roommates and we're expecting the snakes to move in this spring. This mobile home is sitting behind a dilapidated house that's about to collapse and block us in keeping emergency vehicles at bay. This m.h. is tax valued at 3,000\$ and the damage estimate by the environmental inspection is over 7,600\$. That's not mentioning the septic and well which were not inspected. (see manual CDBG-DG 7.0 Sec. 2.40 and 2.41). If rebuild was not affiliated with the government, I would have thought it to be a scam. It took 6 months for them to decide on an appeal and 3 months for them to tell me they didn't get a form, in which I hand delivered to my casework at the time. They never admitted losing it. Over and over I resubmitted ;paperwork and answered the same questions. I think the program is the master of stalling tactics. I've been diagnosed with major depression with severe recurrence among other things years ago. I've spent the better part of 3 years in bed trying to sleep my life away. We noticed vandals had cut holes in the house to remove wiring. I do not know if they were under the house to remove piping. My concern is that the house obviously looks empty, will they be back for other items and since someone just set an empty house on fire will there be arson. As Rebuild NC allowed the asbestos contractor to come in strip the home of siding, removed tile, took off doors/shutters and gutted the bathroom going on 9 months ago and although I requested repeatedly they have not demoed the house (never completed the demo permit which now has expired) that is not surprising. I live in the city, with sidewalks and neighbors about 20 feet on each side. Due to the changing of residency (due to demolition/ construction and the state they have left the house in) I no longer have homeowner's insurance on and only will be able to get a liability policy once they demo the house as the house as is is not insurable. As no NTP was issued the property is uninsured. If anyone gets hurt on the property or someone sets it on fire damaging my neighbor's homes there are major lawsuits there. I am a senior citizen who has a son with special needs who has made great strides in development, but will always need some support to life independently. I applied to the Rebuild NC only because I thought I could get the support to lefe needed to repair the damages done by the hurricanes/tornado (an extension that could have just been removed and damage done to the roof) and thought I could get dependable/supervised contractors to complete. As my house was free and clear, before the hurricane I was looking at remodeling/updating a 1

I have heard nothing substantial from Rebuild NC since January except the cursory calls or emails saying "you are Step 7 construction (case manager) or you are in construction and on hold (construction liaison). I have been in construction with a GC (Rescue) since November of 2021. The last real conversation we had was about negotiations for a new floor plan. Supposedly, the initial reasons for delay was waiting for asbestos paperwork from the state (it seems the removal was done before submitting/approval of the application at least 10 days in advance of beginning work) and a floor plan issue due to "zoning", but that is not true as they had not even completed the demo permit and the fact I was entitle to a variance. The problem that arose from their negligence is now a home can not be more than 30 square feet wide and they will not demo my house unless I accept a plan much smaller than my previous home (in the 900s+ and 1100+ square feet) when my home was almost 1600 sq. ft. The problem with the two plans they have offered is I know that there is a possibility sometime in the near future there may be the need to make accommodations so 4 adults could live in the home and neither of those plans allow the access to the attic needed if I need to add bedrooms upstairs and both have side doors which will not allow me to make an addition without a lot of expenses (my lot is narrow, but it is a double lot so I can build back). The nouse plan I signed a grant agreement on was about 70 square feet larger, but was the same width of my house. If I was offered what I am being offered now, I probably would not have accepted as they would not work for our future needs and proceeded to repair and remodel my house. Many households with disabilities are living on the margins due to lost jobs, underemployment, lack of savings, unstable housing, and gross inequities in health care and other resources. Almost four years after Hurricane Florence, many people with disabilities are still awaiting funding that will assist them with their recovery, and there remains a dire, unacceptable shortage of affordable, accessible housing. When Hurricane Florence slammed into the east coast of NC in September 2018, DRNC used our access authority to monitor the status of people with disabilities in emergency shelters. Within 47 days, DRNC staff visited 26 shelters and communicated directly with more than 300 displaced
						individuals, over 150 shelter staff, and other service providers. DRNC observed significant inconsistencies in the resources available to survivors and found that well-trained, attentive staff provide far better outcomes for individuals with disabilities. DRNC determined that many of the dislocations and traumas observed could be avoided if future disaster plans, responses and recovery efforts were more inclusive and respectful of people with various kinds of disabilities. We published our findings and recommendations in the report, The Storm after the Storm. Findings and recommendations addressed in the report include: * Inaccessible and challenging shelter environments * Unfit medical shelters * Lack of access to important services * Inadequate state and federal assistance As always, we are eager to share our work and are happy to discuss our findings and recommendations with members of the General Assembly. 						2. I signed my award letter December 22, 2022. I was awaiting a quality review completion until February 17, 2023. It was a bit long for such a simple review.
						3. I am currently still in Step 6 pending batch for bidding. 37 days since quality review completion. 94 days since signing award letter. 2 years and 6 months since damage inspection completed. 2 years 4 months since environmental inspection completed. 1 year 7 months since first award letter was completed. 10 months since appeal decision received. Nearly 7 months since promissory note signed. I lost 2 months between signing promissory note and receiving award letter due to me catching up on property taxes. That 2 month delay is my own fault.
						4. My damage inspection was never properly completed. I requested an additional inspection upon appeal in Fall of 2021, which I was denied. I am in contact with Jackie in constituent services in regards to this matter. No repairs of my home will be able to be completed without first adding the missing repairs. No point in repairing anything under a damaged, leaking roof. As it stands I must wait until my home is bid out, a walkthrough has taken place before a change order can happen. This is going to prolong my wait even longer in regards to something that has been known and well documented for 18 months.
						Last week I took photos and documented items missing from my scope of work in hopes that construction services would add these items to my scope pre bidding. Just to save time for myself, rebuild workers and contractors.
						Jackie from constituent services told me that she put them together and turned them into construction. She said they agreed that much was missing from my scope of work. I am also told that I should receive my decision for emergency move out tomorrow. I hope this is the case.

I really want to believe in RebuildNC. I want to believe things have improved. I have seen some improvements in areas previously mentioned.
