2 "(5) Referral to the appropriate local law enforcement agency if the individual is  
3 not a student.";

6 "(c) The governing body of a public school unit shall develop policies for assessment and  
7 intervention by threat assessment teams, including any scale or classification system that will be  
8 used to indicate various levels of threats and the standard response to each level of threat. These  
9 policies shall differentiate between assessment and intervention at the elementary, middle, and  
10 high school level, as appropriate. In developing these policies, the unit shall consult the guidance  
11 issued by the Center for Safer Schools released pursuant to subsection (b) of this section and with  
12 any threat assessment team in the unit. These policies shall not reference or reveal any  
13 information that has been excluded as a public record under G.S. 115C-47(40), Part 2 of Article  
14 8C of this Chapter, or any other relevant statute. A copy of the policies shall be sent to the Center  
15 for Safer Schools.";
