**"PART I. CLARIFY REQUIREMENTS OF CHARTER APPLICATION AND RENEWAL**

**SECTION 1.(a)** If House Bill 618, 2023 Regular Session, does not become law, G.S. 115C-218.5(a) reads as rewritten:

- "(a) The State Board may grant final approval of an application if it finds the following:
- (1) The application meets the requirements set out in this Article and such other requirements as may be adopted by the State Board of Education.
  - (2) The applicant has the ability to operate the school and would be likely to operate the school in an educationally and economically sound manner.
  - (3) Granting the application would achieve one or more of the purposes set out in G.S. 115C-218.

In reviewing applications for the establishment of charter schools within a local school administrative unit, the State Board is encouraged to give preference to applications that demonstrate the capability to provide comprehensive learning experiences to students identified by the applicants as at risk of academic failure. The Board shall not consider any alleged impact on the local school administrative unit or units in the area served by a charter school when deciding whether to grant, renew, amend, or terminate a charter."

**SECTION 1.(b)** If House Bill 618, 2023 Regular Session, becomes law, G.S. 115C-218.5(a), as amended by House Bill 618, 2023 Regular Session, reads as rewritten:

- "(a) The Review Board may grant final approval of an application if it finds the following:
- (1) The application meets the requirements set out in this Article and such other requirements as may be adopted by the State Board of Education.
  - (2) The applicant has the ability to operate the school and would be likely to operate the school in an educationally and economically sound manner.

20          **SECTION 2.(a)** If House Bill 618, 2023 Regular Session, does not become law,  
21 G.S. 115C-218.7 reads as rewritten:

23          (a)     A material revision of the provisions of a charter shall be made only upon the approval  
24 of the State Board of Education.

25          (b)     ~~Enrollment growth of greater than twenty percent (20%) shall be considered a~~  
26 ~~material revision of the charter if the charter is currently identified as low performing. The State~~  
27 ~~Board shall not approve a material revision for enrollment growth of greater than twenty percent~~  
28 ~~(20%) for a charter that is currently identified as low performing. Enrollment growth of greater~~  
29 ~~than thirty percent (30%) shall be considered a material revision of the charter for any charter~~  
30 ~~school that is not identified as low performing. The State Board may approve such additional~~  
31 ~~enrollment growth of greater than thirty percent (30%) only if it finds all of the following:~~If a  
32 charter school has been identified as low-performing under G.S. 115C-218.94, then it shall be  
33 considered a material revision of the school's charter to increase its maximum authorized  
34 enrollment by more than twenty percent (20%) of the previous year's maximum authorized  
35 enrollment. For the purposes of this section, maximum authorized enrollment is as defined in  
36 G.S. 115C-218.8.

33               (1)    Increase its maximum authorized enrollment during the charter school's  
34                   second year of operation and annually ~~thereafter in accordance with~~  
35                   G.S. 115C 218.7(b).thereafter, provided the school is not identified as  
36                   low-performing under G.S. 115C-218.94. The maximum authorized  
37                   enrollment is the target enrollment number identified in a school's charter. The  
38                   maximum authorized enrollment may only be updated once per year and shall  
39                   not decrease based on actual enrollment.

40               (2)    ~~Increase~~ If a school is low-performing under G.S. 115C-105.37A and has

- (3) Expand to offer one grade higher or lower than the charter school currently offers if the charter school has (i) operated for at least three years, (ii) has not been identified as continually low-performing as provided in G.S. 115C-218.94, and (iii) has been in financial compliance as required by the State Board."

**PART III. ALLOW CHARTER SCHOOLS TO ADMIT OUT-OF-STATE STUDENTS AND FOREIGN EXCHANGE STUDENTS**

**SECTION 3.(a)** G.S. 115C-218.45 is amended by adding the following new subsections to read:

"(h1) Any charter school that is unable to fill its current enrollment with students qualified under the laws of this State for admission to a public school may enroll out-of-state students who are domiciliaries of other states. The charter school shall charge the out-of-state students a tuition amount of at least fifty percent (50%) of the total of the per pupil allocation of the local appropriation for the county in which the charter school is located and the per pupil State appropriation for that school year but no more than one hundred percent (100%) of the total of the per pupil allocation of the local appropriation for the county in which the charter school is located and the per pupil State appropriation for that school year. The number of out-of-state students who are domiciliaries of other states who are enrolled in a charter school may not exceed ten percent (10%) of the total number of students enrolled in the charter school.

"(h2) For the purposes of this subsection, a foreign exchange student is a student who is domiciled in a foreign country and has come to the United States on a valid student or exchange visa pursuant to the Immigration and Nationality Act, 8 U.S.C. § 1101, et seq. A charter school may enroll foreign exchange students as follows:

- (1) No more than two foreign exchange students per high school grades nine through 12 shall be enrolled in any given school year at the charter school.
- (2) The charter school may charge the foreign exchange students a tuition amount of at least fifty percent (50%) of the total of the per pupil allocation of the local appropriation for the county in which the charter school is located and the per pupil State appropriation for that school year but no more than one hundred percent (100%) of the total of the per pupil allocation of the local appropriation for the county in which the charter school is located and the per pupil State appropriation for that school year.
- (3) Foreign exchange students shall not count toward the enrollment capacity or cap for any program, class, building, or grade levels for grades nine through 12 and shall not be subject to any lottery process used by the charter school for enrollment."

**SECTION 3.(b)** This section is effective when it becomes law and applies beginning with the admissions process for the 2024-2025 school year.

4           student who was enrolled for at least 75 consecutive days in the prior semester  
5           in a preschool program operated by an entity other than the charter school and  
6           the charter school has a written enrollment articulation agreement with the  
7           program operator to give the program's students enrollment priority.

9           (8) A student whose parent or legal guardian is on active military duty."

11           **PART V. PROHIBIT DISCRIMINATION OF CHARTER SCHOOL STUDENTS**

12           **SECTION 5.** G.S. 115C-47 is amended by adding a new subdivision to read:

13           "(68) To Provide Equal Access to All Residents of the Local School Administrative  
14           Unit. – A local board of education shall not consider a student's current or  
15           prior enrollment in a charter school in any criteria used by the local board for  
16           determination of admissions or eligibility to any school or special program."

17  
18           **PART VI. AUTHORIZE COUNTIES TO PROVIDE CAPITAL FUNDS TO CHARTER**  
19           **SCHOOLS**

20           **SECTION 6.(a)** G.S. 115C-218.100(b) reads as rewritten:

21           "(b) Distribution of Assets. – Upon dissolution of a charter school, all net assets of the  
22 charter school purchased with public funds shall be deemed the property of the local school  
23 administrative unit in which the charter school is ~~located~~ located, except capital-sourced assets.  
24 For purposes of this subsection, capital-sourced assets include (i) capital funds provided to a  
25 charter school by one or more counties pursuant to G.S. 115C-218.105(b1) and (ii) net assets  
26 purchased or improved with such funds, up to the total amount of the funds provided.  
27 Capital-sourced assets shall be deemed the property of the county or counties providing the  
28 funding and, if applicable, divided between the counties in proportion to the funds provided."

29           **SECTION 6.(b)** G.S. 115C-218.105 is amended by adding the following new  
30 subsections to read:

31           "(b1) Counties may provide funds to charter schools by direct appropriation as set forth in  
32 G.S. 153A-461. These funds shall be used only for the following purposes:

33           (1) The acquisition of real property for school purposes, including, but not limited  
34           to, school sites, playgrounds, and athletic fields.

35           (2) The acquisition, construction, reconstruction, enlargement, renovation, or  
36           replacement of buildings and other structures, including, but not limited to,  
37           buildings for classrooms and laboratories, physical and vocational educational  
38           purposes, libraries, auditoriums, and gymnasiums.

39           (3) The acquisition or replacement of furniture and furnishings, instructional  
40           apparatus, technology, data processing equipment, business machines, and  
41           similar items of furnishings and equipment.

42           (b2) If a charter school uses funds provided in subsection (b1) of this section to acquire or  
43 improve property, the amount provided by the county shall be evidenced by a promissory note

1 and secured by a deed of trust on the property acquired or improved by the funds. The county  
2 may subordinate the deed of trust to other liens to facilitate the acquisition or improvement of  
3 the property secured by the deed of trust. In the event that a charter school repays the county in  
4 the amount of the capital funds provided, the county shall, for the property acquired or improved  
5 by the funds, execute and file a deed of release or other documentation of satisfaction showing  
6 the charter school repaid the county in the amount of the capital funds provided."

7 **SECTION 6.(c)** G.S. 153A-149(c) reads as rewritten:

8 "(c) Each county may levy property taxes for one or more of the purposes listed in this  
9 subsection up to a combined rate of one dollar and fifty cents (\$1.50) on the one hundred dollars  
10 (\$100.00) appraised value of property subject to taxation. Authorized purposes subject to the rate  
11 limitation are:

12 ...

13 (38) Charter Schools. – To provide capital funds for charter schools as authorized  
14 by G.S. 153A-461."

15 **SECTION 6.(d)** Article 23 of Chapter 153A of the General Statutes is amended by  
16 adding a new section to read:

17 "**§ 153A-461. Charter schools.**

18 Each county is authorized to appropriate funds and lease real property to schools chartered  
19 under Article 14A of Chapter 115C of the General Statutes. Counties may provide funds only for  
20 the purposes set forth in G.S. 115C-218.105(b1)."

22 **PART VII. ALLOW THE CENTRAL PARK SCHOOL FOR CHILDREN IN DURHAM**  
23 **COUNTY TO CONDUCT A WEIGHTED ADMISSIONS LOTTERY PILOT PROGRAM**

24 **SECTION 7.(a)** The charter school Central Park School for Children in Durham  
25 County may establish a pilot program to expand the school's weighted lottery admission  
26 procedures for a period of up to four years. The pilot program shall preserve existing weighting  
27 factors but may add additional weighting factors that serve the goal of assisting educationally or  
28 economically disadvantaged students, including walk zones.

29 **SECTION 7.(b)** Notwithstanding G.S. 115C-218.7, an admissions lottery pilot  
30 program established under this act shall not be considered a material change of a school's charter.

31 **SECTION 7.(c)** By June 15 of each year in which a pilot program established under  
32 this act is being designed or conducted, the Central Park School for Children shall report to the  
33 Office of Charter Schools the following information:

- 34 (1) A description of the pilot weighted lottery procedures, including the weighted  
35 factors considered and how those factors further the goals of the weighted  
36 lottery system.  
37 (2) How the pilot procedure differed from the existing procedure.  
38 (3) The number of students that were admitted under the pilot program that would  
39 not have otherwise been admitted.

40 **SECTION 7.(d)** This section is effective when it becomes law and applies to  
41 weighted lotteries conducted for the admissions process for the 2024-2025 school year.
