- State Capitol Police's Mobile Field Force is comprised of 35 specially equipped and trained law enforcement officers who have the specific mission of performing crowd management operations during demonstration events and rallies conducted on state property and we have one sergeant who is certified as a tactical medic.
- Training has taken place with our local partner, Raleigh PD, once this year, and the next Mobile Field Force in-service is scheduled for October.
 - Permitted events in 2022 317 / 148
 - Permitted events in 2023 369 / 153
- On average, per year, there are approximately 100+ unpermitted events. In addition, RPD's permitted events have a direct and indirect effect on SCP's staffing requirements.

- State Capitol Police offers Active Assailant training available to all State employees, and conducts Risk Assessments for State-owned properties not in just Wake County, but also across the State upon request.
- State Capitol Police also has 6 Federal Law Enforcement Training Center Active Shooter Threat certified instructors available to any NC agency free of charge.
- State Capitol Police instructors have provided "Active Shooter Run, Hide, Fight" training for nearly 4,000 State employees and civilians.
- All officers have been trained in Active Shooter
 Response and have been issued trauma packs & are first aid & trauma care certified.



- The police department is staffed with a 24-hour Emergency
 Communications Center. In addition to receiving emergency and nonemergency calls, they monitor and dispatch emergency responders to
 fire and Phoenix emergency alarms throughout North Carolina at
 properties owned and leased by the State.
- In 2023, 76,485 Phoenix alarms were received, 4,196 calls for service were answered, 31,930 security checks were completed, and 1,077 school safety checks were performed.
- Our CAD system is now integrated with Raleigh/Wake 911, and other surrounding municipalities for calls for service which gives us situational awareness of all incidents in our area.



 Given the proximity of SCP officer's duty stations, there is a high probability that we will be the first to respond to an active assailant in the downtown governmental complex and will provide back-up to the General Assembly Police should the incident take place in their jurisdiction.





As part of its mission to secure state government operations, the State Capitol Police assigns specially trained law enforcement officers to specific state-owned properties and facilities throughout the State Government Complex. State Capitol Police provides on-site security for 34 buildings in Wake County, 26% of which we staff 24/7 and provides public safety response to 508 State locations/facilities. State Capitol Police also employs 32 civilian security guards for additional support.





The Investigations Section is staffed with two dedicated subject matter experts in investigations. Both investigators are responsible for furthering the investigation of all felony crimes including (but not limited to) murder, rape, robbery, theft and fraud cases. In addition, investigators conduct all criminal investigations at Adult Correction facilities in Wake County. In 2023, we handled 86 felony cases & 620 reports taken.







The Patrol Division has the responsibility to proactively patrol the North Carolina State Government Complex and other state-owned properties in Wake County to prevent crime, solve problems, investigate crimes and vehicle accidents, make arrests pursuant to criminal behavior, provide safety escorts, conduct safety programs and training for employees, and build partnerships within the complex and local community. State Capitol Police officers use various methods to actively patrol the governmental complex such as marked and unmarked patrol vehicles, Polaris ATV vehicles, police bicycles and Segways.





State Capitol Police has a total of 144 positions, making it the 2nd largest stand-alone State Capitol Police agency in the United States. Officers provide 24/7 coverage for the Downtown Governmental Complex and all State facilities in Wake County.



USPCA National Detector Dog Trials – 1st Place



State Capitol Police has two explosive-detection canine teams. Both of these K-9 teams have an Explosive Detector Dog (EDD) trained to detect explosive materials that are location-specific, and they are also vapor-scent canines specifically trained to detect explosive particles in the air. One K9 is personborne, tracking and article search certified.

One K9 officer is a USPCA Level 3 certified trainer. In 2023, State Capitol Police had 142 requests for service that includes requests statewide.



Policy Recommendations

 Prioritize the retention and recruitment of state law enforcement agents, police officers, and troopers with market-value salaries along with a competitive benefits package.

Expand the Body-Worn Camera program to include issuance to all police officers.





5-10 Year Outlook

- A new Records Management System that integrates with our current CAD system and the
 capability to integrate with a future Capitol Complex Camera monitoring system with
 expansion capabilities to include other State-owned properties we monitor across the state
 for improved protection, response, documentation, and prosecution.
- Move all receipt funded positions to appropriated funding. Having all positions appropriated is
 mission and operationally critical moving forward. We checked with multiple State agencies
 on the East coast, and we are the only State Capitol Police agency who uses the receipt
 funded method for sworn officers.
