

Report to the North Carolina General Assembly

Feminine Hygiene Products Grant Program

§ 115C-377. (a) Program; Purpose. – The Department of Public Instruction shall establish the Feminine Hygiene Products Grant Program (Program) to assist public school units participating in the Program in providing students with feminine hygiene products at no charge to the student.

(b) Grants. – To the extent funds are made available for the Program, the Department of Public Instruction shall award public school units grants of up to five thousand dollars (\$5,000) on a first-come, first-served basis, and the Department shall prioritize awarding grants to public school units that did not receive an award pursuant to the Program in the previous fiscal year. No public school unit shall receive more than one grant per fiscal year.

(c) Reporting. – No later than March 15, 2023, and every year thereafter that funds are made available for the Program, the Department shall report to the Joint Legislative Education Oversight Committee on the public school units receiving grants under the Program, the specific feminine hygiene products purchased with the grant funds, and the impact of the Program on student health and well-being. (2022-74, s. 7.10(a).)

INTRODUCTION


The Department of Public Instruction's (DPI) NC Healthy Schools Section of the Office of Academic Standards provided an application to all public school units (PSUs) to apply on a first-come, first-served basis for the Feminine Hygiene Products Grant Program for funding of up to \$5,000 to purchase feminine hygiene products. A total of 149 applications were received, with requests for funding amounts ranging from \$300 to \$5,000. With a funding limit of \$250,000, DPI was able to award a total of 64 PSUs with a Feminine Hygiene Products Grant.

The grant awardees indicated that they would use the funding to purchase products ranging from tampons and pads to underwear and educational materials on puberty. The PSUs also noted that the grants would provide much needed support for students to stay in school during the time of their menstrual cycle; ensure students can maintain good hygiene and reduce unnecessary infections; make products more accessible to students with transportation constraints; provide feminine hygiene supplies for those who cannot afford the expensive products, especially those in rural and low-income areas; reduce embarrassment associated with menstruation and not having necessary supplies; and offset teacher and support staff expenses for such products. Many awardees indicated that some students rely on their school to provide the feminine hygiene products they need, as their families may not have the financial means to purchase the products. Awardees also noted the toll on student mental health that not having access to feminine hygiene products can have, and how that correlates to increased time out of school.

The following sections outline in greater detail the PSUs that received a grant and the amount they received; the types of products that PSUs indicated they would use the funding to purchase; and how the grant would impact student health and well-being. Appendices are also included to provide additional information on each awarded PSU's application responses and feedback on grant impact.

PSU GRANT RECIPIENTS

Within one week, DPI received 149 applications for the Feminine Hygiene Products Grant Program. Of the 149 applications received, DPI was able to award 64 grants to PSUs from each of the eight State Board of Education (SBE) Regions. Grant awards were distributed to 45 LEAs and 19 Charter schools. The following chart outlines the grant distribution by region (please refer to Appendix A for a detailed map of SBE regions):



PRODUCTS PURCHASED

The PSU grantees indicated that they would use the funding to purchase basic feminine hygiene products, including tampons, pads, menstrual cups, reusable pads, and period underwear. Many grantees indicated that in addition to purchasing these feminine hygiene products they would purchase other much needed hygiene products including panty liners, flushable and feminine hygiene wipes, hygiene kits containing products, extra underwear and clothes for accidents, deodorants and soaps, puberty and menstruation education materials, and heating patches for menstrual pain. The following chart outlines which products PSUs said that they would purchase:



IMPACT ON STUDENT HEALTH AND WELL-BEING

Responses to the grant application demonstrated a great need for feminine hygiene products to be available in school, as school may be the only place some students have access to these products. Grant recipients noted that the funding would help to cover costs the district and/or staff and teachers incur to purchase feminine hygiene products; to alleviate reliance on community-based donations; to expand or implement PSU budget for supplies to better meet student needs; and to ensure that all

"Over 10% of the population at Weldon City Schools are identified as homeless and over 94.06% are experiencing poverty. students feel safe, comfortable, and able to learn at school. Many grantees noted that a lack of access to feminine hygiene products resulted in embarrassment, anxiety, and negative mental health outcomes for students. Nearly all grantees indicated that they either have Title I schools in their district, or that many of their students and families are living below the poverty line or in rural or low-income areas. For these students and families, feminine hygiene products are an expense they cannot afford or lack access to because of transportation constraints, and therefore must rely on their school to provide these products.

Several grantees also noted the stigma, shame, anxiety, and embarrassment students experience surrounding menstruation because they do not have access to supplies and therefore are absent

"Students who lack access to needed menstrual products and encounter school-related barriers to menstrual equity may experience: Shame, embarrassment, and stigma. They can experience challenges participating in physical school activities, partly due to fear of menstrual leaks. By being able to provide feminine products we are able to keep more students in school for learning and also to help with their self-confidence/esteem. It is vital for students to feel safe and comfortable at school to be able to learn. By allowing students the opportunity to have these products in school we eliminate a barrier to regular attendance and promote healthy habits." -Pinnacle Classical Academy

from school during their cycles. Most grantees also noted that the reliability of access to hygiene products in school would help students stay in school when they are menstruating and would alleviate negative mental health outcomes. Other grantees highlighted that there has been an increase in the number of younger elementary school age students beginning their period and needing supplies and menstrual health education at school. In addition, grantees commented on the impact the grant would have on students to maintain good hygiene and reduce the number of unnecessary infections from lack of access to feminine hygiene products. The following summary

points outline in greater specificity awardee comments on how the grant would impact student health and well-being:

- Alleviate financial hardship for both schools, educators, and students.
- Give districts, schools, and teachers the ability to genuinely meet the needs of students when it comes to availability of hygiene products in school.
- Provide much needed support for families and communities that already rely on schools to provide feminine hygiene products to students.
- Support the most vulnerable students, including those experiencing homelessness and poverty and those living in low-resource areas.
- Alleviate access barriers, such as transportation to stores to purchase products.
- Decrease instances of multiple absences and continue to support students and families who continue to be impacted by the pandemic.
- Increase educational opportunities and academic growth because students can stay in school when they are menstruating.
- Remove stigma, anxiety, and embarrassment related to menstruation and period poverty.
- Improve student mental health, including reducing anxiety and panic attacks when students do not have needed supplies.
- Reduce instance of poor feminine hygiene and health risks, such as bacterial and urinary tract infections.
- Increase awareness and education on the importance of maintaining good feminine hygiene practices.
- Address needs of younger elementary students who are starting their periods and may not yet understand the changes occurring in their bodies or have hygiene products with them at school.

"As a school nurse I will say we are seeing students enter puberty at a much younger age than in years past. Therefore, the needs for menstrual education and feminine hygiene products reaches a much larger group of students within all of our elementary, middle, and high schools. The availability of such products is not always guaranteed to our students at home due to cost or ability to obtain the products, but being able to meet their health and well-being needs here at school allows them to feel comfortable, confident and also reduces absences related to soiled clothing or not attending due to lack of access to proper hygiene products."



Based on the application responses and needs of the districts, the Feminine Hygiene Products Grant Program provided much needed support for PSUs, staff and teachers, students, families, and communities. As many grantees indicated, there is a direct link between student academic success and the provision of hygiene products in school. When students know that they can access hygiene products at school and do not experience anxiety and fear of not knowing when or where they will have the products they need, they are able to learn better and are more likely to stay at and come to school during their periods. The grant program has not only helped students stay in school during their menstrual cycles but also has helped provide educational opportunities for maintaining good hygiene to reduce instances of infections. The grant program has helped to support PSUs and students by removing financial and transportation barriers to products; decreasing stigma, anxiety, and embarrassment due to lack of access to products, and ensuring health and well-being is maintained so that students can continue their academic growth.

The DPI receives inquiries about the Feminine Hygiene Products Grant Program throughout the year, including inquiries on applying for funding and when or if funding might be available at multiple points during the school year. Since the program's inception, applicants and awardees continue to note the great need for the availability of feminine hygiene supplies in schools. Currently, DPI is only able to cover about thirty percent of the funding requests with the current funding level. Expansion of the program would allow DPI to provide more PSUs across the state with grants for feminine hygiene products. An increase in grants could have the potential to make an even greater impact on chronic absenteeism, academic success and outcomes, and the overall mental and physical health of students across North Carolina.
