

Session Law 2021-180, Section 9D.18.(c) requires the Department of Health and Human Services, Division of Health Benefits (DHB), to submit a final report to the Joint Legislative Oversight Committee on Medicaid and the Fiscal Research Division on the evaluation of needs in the managed care environment as it pertains to the implementation of capitated contracts for standard benefit plans for PHPs. 
