ITEM 1

GRANTOR: Wade E. Vannoy, Sr. Heirs

GRANTEE: State of NC, Department of Environment and Natural Resources,
Division of Parks and Recreation

LOCATION: NC Hwy 88, Jefferson Township, Ashe County

AREA: ±110.809 acres

UNIT COST: \$17,850/acre

CONSIDERATION: ±\$1,977,940

COMMENTS: State Park Addition. Property proposed for acquisition is for inclusion in Mount Jefferson State Natural Area. Acquisition of this property provides protection of natural and scenic resources, water quality, and also provides an additional access point to the State Natural Area. The acquisition of this property will be subject to a Contract and Agreement for Joint Venture (Contract) dated October 1, 2007 between the grantors and Sexton Farms and a Contract dated April 4, 2008 between the grantors and River Ridge Farms, for the harvesting of existing Christmas trees. The Contracts will expire on December 31, 2015, and December 31, 2017, respectively. Funding for this acquisition is provided by the Federal Land and Water Conservation Fund (\$900,613), Parks and Recreation Trust Fund (\$677,327) and private funds (\$400,000).

LOCATION: off St. Mary's Road, Eno Township, Orange County

AREA: ±87.5 acres

UNIT COST: ±\$5,600/acre

CONSIDERATION: \$490,000

COMMENTS: State Park Addition. Property proposed for acquisition is for inclusion in Eno River State Park. Acquisition of this property provides protection of natural resources and water quality in Eno River State Park. Funding for this acquisition is provided by the Clean Water Management Trust Fund (\$311,860) and the Parks and Recreation Trust Fund (\$178,140).

AREA: $\pm 81,022$ sq. ft. or ± 1.86 acres improved with a house containing ± 840 sq. ft. constructed in 1946, a duplex containing $\pm 1,296$ sq. ft. constructed in 1958, a house containing 572 sq. ft. constructed in 1940, a house containing 1,182 sq. ft. constructed in 1946 and a house containing 1,361 sq. ft. constructed in 1960

UNIT COST: $\pm \$3.02$ sq. ft. – land
 $\pm \$45.80$ sq. ft. – improvements

CONSIDERATION: \$485,000

COMMENTS: Campus Expansion. Property proposed for acquisition is contiguous to Western Carolina University and is needed for future expansion in accordance with the campus master plan. Funding for this acquisition is provided by Housing and Parking Revenue.

CONSIDERATION: \$600,000

COMMENTS: Campus Expansion. Property proposed for acquisition is contiguous to Western Carolina University and is needed for future expansion in accordance with the campus master plan. Funding for this acquisition is provided by Housing and Parking Revenue.

GRANTEE: County of Stanly

LOCATION: Guard Road, Badin, Stanly County

AREA: ±21.05 acres

CONSIDERATION: Gift

COMMENTS: Property proposed for disposition was acquired from the grantor by deed of gift for use by the North Carolina National Guard subject to a reversionary interest in the event the property is no longer needed for military purposes. The National Guard has notified this office that it no longer utilizes the property and requests the property revert back to Stanly County.
