

#### 1 A BILL TO BE ENTITLED 2 AN ACT TO PROVIDE FOR APPOINTMENT OF THE COMMISSIONER OF MOTOR VEHICLES BY THE GOVERNOR SUBJECT TO SENATORIAL ADVICE AND 3 4 CONSENT AND TO PROVIDE FLEXIBILITY IN CONTRACTING FOR NEVI 5 FORMULA PROJECTS. 6 The General Assembly of North Carolina enacts: 7 8 **APPOINTMENT OF COMMISSIONER OF MOTOR VEHICLES** 9 SECTION 1. G.S. 20-2 reads as rewritten: 10 "§ 20-2. Commissioner of Motor Vehicles; rules. 11 Commissioner and Assistants.Commissioner. - The Division of Motor Vehicles shall (a) be administered by the Commissioner of Motor Vehicles, who shall be appointed by and serve 12 at the pleasure of the Secretary of the Department of Transportation. Governor. The Governor 13 shall notify the President of the Senate of the name of the person to be appointed, and the 14 appointment shall be subject to senatorial advice and consent in conformance with 15 16 G.S. 143B-9(a). 17 <u>Commissioner salary. – The Commissioner shall be paid an annual salary to be fixed</u> (a1) 18 by the Governor and allowed traveling expenses as allowed by law. Assistants. - In any action, proceeding, or matter of any kind, to which the 19 (a2) Commissioner of Motor Vehicles is a party or in which he may have an interest, all pleadings, 20 21 legal notices, proof of claim, warrants for collection, certificates of tax liability, executions, and other legal documents, may be signed and verified on behalf of the Commissioner of Motor 22 Vehicles by the Assistant Commissioner of Motor Vehicles or by any director or assistant director 23 24 of any section of the Division of Motor Vehicles or by any other agent or employee of the 25 Division so authorized by the Commissioner of Motor Vehicles. Rules. - The Commissioner may adopt rules to implement this Chapter. Chapter 150B 26 (b) 27 of the General Statutes governs the adoption of rules by the Commissioner." 28 29 AUTHORIZE DEPARTMENT TO UTILIZE CONTRACT METHODOLOGY 30 FLEXIBILITY FOR NEVI FORMULA PROGRAM PROJECTS 31 **SECTION 2.** Notwithstanding any other provision of law, the Department of 32 Transportation is authorized to utilize, design-build, indefinite delivery, indefinite quantity, 33 public-private partnership, or any other contracting methodology authorized by applicable federal law to administer the National Electric Vehicle Infrastructure (NEVI) Formula Program. 34
