The War of the Regulation

Listen to "Terror in the Backcountry, 1771," a dramatic telling of the poorly understood events unfolding in the heart of today's North Carolina piedmont in May and June 1771. These events, perpetrated against North Carolinians by other North Carolinians under the leadership of Royal Governor William Tryon brought to a tragic end the efforts of North Carolina colonists in the backcountry to get their government to do the right thing. They simply wanted the elected officials and the royal governor to rein in the corruption and extortion perpetrated by officials of the colonial government on citizens far from the seat of power and influence in New Bern. The end of the War of the Regulation preceded the Mecklenburg Declaration of Independence by four years and the issues were different from those sparking separation from Great Britain, but how the Regulators were treated greatly affected how the American Revolution unfolded in North Carolina. 


