FY 15 REPORT on Rural Division Grant Activity

and Policy Recommendations

GRANT AWARDS AND DISTRIBUTION OF AWARDS:

The attached documents summarize the following for the Building Reuse, Economic Infrastructure, CDBG-ED and Utility Fund grant programs within the Rural Division:

- An Excel spreadsheet displaying total number of grant awards made July 1, 2014 through June 30, 2015. Organized by program (Building Reuse, Economic Infrastructure, Utility Fund, CDBG-ED) and then by date awarded, the excel sheet identifies the county, the applicant, Tier (at time of award), project business, requested amount, award amount and the number of jobs committed by project business.
- Maps of the geographical distribution of the awards by program.
- Map of the cumulative distribution of grant awards.

The Rural Infrastructure Authority (RIA) awarded these grants between July 1, 2014 and June 30, 2015.

POLICY RECOMMENDATIONS:

- 1. The Rural Infrastructure Authority determined at the beginning of the Fiscal Year (FY15) they would revisit current award criteria for the rural grant programs of Building Reuse and Economic Infrastructure. Criteria now established for those two grant categories include a wage standard, health benefit standard, and the State's development priority industries standard. The Utility Fund and CDBG-ED have criteria as established in legislation.
- 2. Beginning in FY15 and as directed by the General Assembly, the RIA began granting Building Reuse funds to rural census tracts of Tier 3 counties. The RIA, also at the direction of the General Assembly, developed a grant program for an "existing business" category of building reuse and a building demolition program.
- 3. The Assistant Secretary engaged the Authority in discussions of the following: How can the Division better inform local governments of available resources? How can the Division assist local government units in meeting the need for preliminary project planning to enable them to apply for grants? In what ways can we better evaluate the effectiveness of our grants into local communities? (NCGS 143B-472.128 (j) (5) (6) (7))

In the attempt to better inform local government units and communities of the programs of the Rural Division, the Assistant Secretary made forty-eight (48) presentations to local communities or groupings in FY15. An additional approximate fifteen (15) presentations were made to communities/groupings by the Assistant Secretary's Manager of Operations. The Division's staff of grant managers made occasional conference presentations explaining grant guidelines, submission and reporting requirements.

In the attempt to better assist local government units in preliminary project planning, the existing community planners (formerly Division of Community Assistance) have reorganized their work and now function as Economic Advancement and Planning. Having lost several planners in this budget year, this reorganization and work has not completely been enacted, but will be within the next several months. A major function of the planners is to assist local government units in planning activities that will enhance their opportunities to create economic advancement.

In evaluating our grant activity, a concerted effort will begin early 2016. Our rural grants are typically two year grants. December 2015 is the period that our first awards will hit their two-year mark. At that time, we can begin to evaluate grant activity as grant cycles close – or are amended – and determine job and investment attainment.






Industrial Development Fund Awards




Community Development Block Grant Awards Rural Infrastructure Authority
