RE: Annual Report

The Annual Report required by G.S. §93B-2(a) requires the Commission to report in item (10) the substance of any anticipated request by the occupational licensing board to the General Assembly to amend statutes related to the occupational licensing board and in item (11) the substance of any anticipated change in rules adopted by the occupational licensing board or the substance of any anticipated adoption of new rules by the occupational licensing board.

Proposed Legislation:

The Commission has not yet considered any potential legislative requests, and there are none known at this time.

Proposed Rule Changes:

The Commission will be considering rule changes that set standards for real estate licensees and educational programs and generally clarify current rules either as proposed by staff, Commission members, the public or licensees. It is anticipated this will be considered later in 2024, so at this time there is nothing to report.
