## **COMMISSION HISTORY**

### **2024**

#### **Background**

North Carolina's share of the Master Settlement Agreement (MSA) was divided into three different parts. Under the terms of the consent decree in North Carolina, 50% of the funds are directed to a non-profit corporation, Golden LEAF, to be used for economic development in tobacco-dependent communities. By statute the remaining 50% is equally divided between two state Commissions. The Health and Wellness Trust Fund Commission uses their portion for health-related needs (HWTFC). The final portion is allocated to the North Carolina Tobacco Trust Fund Commission (TTFC). With the passage of the 2011 budget, the TTFC now receives funding via appropriations and the HWTFC is no longer in existence.

The TTFC was created on August 2, 2000, with the approval of House Bill 1431. The purpose of the Commission is to assist those adversely affected by the MSA, including tobacco farmers, former tobacco quota holders, persons engaged in tobacco-related businesses, individuals displaced from tobacco-related employment, and tobacco product component businesses in this State. Funds can be disbursed through **compensatory programs** and **qualified agricultural programs**.

Membership is made up of 18 people, six appointed by the Governor, six by the Speaker of the House and six by the President Pro Tem of the Senate. The board met for the first time on February 15, 2001, at which the members were given their charges and sworn in.

#### **Since November 1, 2023**

The TTFC met **four times** this past year. During these meetings, board members awarded grant funds, received grantee updates, and acted on grant amendment requests.

In 2024, a total of **37** grant applications were received requesting approximately **\$12 million** in funding. After a very detailed review process, the TTFC approved grants totaling **\$6.7 million** for **26** projects.

The TTFC is very proud of the investments made this past year to help people in North Carolina continue to improve their business and their rural communities. Below are examples of a few of our projects.

- The WNC AgOptions program provides small cost-share demonstration grants to help family farms in Western North Carolina diversify and expand their farming operations. Current and former tobacco farmers are given priority. Farmers utilize these funds to embrace new crops, practices and methodology, new farm products, and new marketing activities. In the process, these projects not only strengthen the farming operation of the grant recipients but contribute to the larger agricultural



community and provide other farmers with the information, local examples, and confidence to pursue similar efforts on their farms, extending the impacts of the program and strengthening farming in NC. This is a three-year project, and the potential impact of this project includes: 370 jobs created or sustained, \$871,874.00 of new income for former tobacco workers, 580 people receiving training, 5,300 acres of farmland impacted, \$5,499,700.00 worth of product sold, and \$818,235.00 in dollars leveraged.

- University of Mount Olive will develop the Shady Grove Educational Livestock Facility (SGELF) that will serve students, agricultural producers, FFA & 4-H members, and the livestock industry through hands-on education, outreach and research. This facility is designed for practical training of students in agricultural degrees at UMO (Ag Education, Animal Science, Veterinary Bioscience, etc.) and secondary students involved in FFA/4-H thus providing the industry with a skilled large animal workforce. The facility will serve as a unique demonstration and training facility for farmers who wish to diversify operations by integrating livestock or improving herd quality through applied training in reproductive techniques (AI, ET), forages, nutrition and animal husbandry practices. The potential impact of this project includes: 530 jobs created or sustained, \$200,000 in new income for farmers, 5,000 people receiving education training, 10,000 people served in total, and \$3,450,000.00 in dollars leveraged.
- Toe River Aggregation Center Training Organization Regional (TRACTOR) seeks to connect their network of farmers from a historically tobacco-led community with new and untapped markets. TRACTOR is experienced in developing novel markets which prioritize local farmers and consumers, including sales through wholesale markets, institutions, CSAs, clinical programs, SNAP/EBT, food pantries, groceries, food banks and local retailers. Through a dedicated Sales and Marketing team, they will leverage these markets to increase small farm revenue, increase access to local foods and further diversify markets to develop a stronger farm economy in WNC. The potential impact of this project includes: 71 jobs created or sustained, 20,000 people served, \$1,250,000.00 worth of product sold, and \$475,054.00 in dollars leveraged.
- ECU-North Carolina Agromedicine Institute will grow the Farm & Ranch Stress Assistance Network-NC to help farm community members manage escalating farm stress associated with agribusiness, adverse health outcomes, and care giving. This will be accomplished by conducting educational sessions at farm-related events, providing free behavioral health sessions to farm community members, assisting farms with the cost of health/safety training, supplies and care giving, and training healthcare professionals on the unique challenges of care giving in the farm environment. The potential impact of this project includes: 5,162 people receiving Education training, 9,000 people served in total, and \$25,000.00 in dollars leveraged.

- NC Cooperative Extension, Harnett County Center will build a farmers market that features 10'x10' stalls, bathrooms, washing stations, and seating areas. This farmers market is phase 1 of a multi-phase agricultural complex that will include a multipurpose training building and commercial kitchen. The market will be built on over 6 acres of land provided by Harnett County Government and will serve the farmers of Harnett County. The farmers market will also complement the Educational Kitchen being added to the Harnett County Center and will serve as the epicenter of agricultural training in Harnett County. The potential impact of this project includes: 85 jobs created or sustained, 2,500 people served, and \$100,000.00 in dollars leveraged.
- Mountain Valleys Resource Conservation and Development, through its Energy Conservation Assistance Program (EnergyCAP), will provide AgEnergy cost-share grants to WNC farmers for energy efficiency or renewable energy projects that will increase farm profitability by reducing overhead costs. The potential impact of this project includes: 80 jobs created or sustained, 2,000 people served, \$48,000.00 in new income for farmers, and \$284,000.00 in dollars leveraged.
- The Wayne County Livestock Development Association will improve the livestock arena at the Wayne County Fairgrounds by renovating and expanding the existing 60' x 100' arena into a modern agriculture and livestock exhibition facility. Key aspects of the renovation include installing a concrete floor, ventilation, a handwashing station and a watering system for penned animals. Additionally, 16' x 100' extensions will be added on each side to increase the total square footage by 3,200 square feet. These upgrades aim to enhance functionality, improve animal welfare, accommodate larger exhibits and audiences, and foster innovation and collaboration within the agricultural community while prioritizing health and safety measures. The potential impact of this project includes: 35 jobs created or sustained, 1,000 people served, and 300 people receiving educational training.

The purpose of the project was to introduce high school students to career, and scholastic opportunities based in agriculture that they can take part in after graduation. Three overnight residential SAE institutes and one daytime modified institute during the COVID-19 pandemic were held. These institutes brought a total of 91 students and 66 teachers from across North Carolina. The Institute allowed student attendees to evaluate various agricultural operations and facilities (agronomic, livestock, processing, natural resources, and power and structural technology systems). FFA members were also exposed to actual hands-on learning experiences through these activities in the fields of horticulture, agronomy, GPS systems and other areas..

Eighteen intensive training sessions focused on proper interview and PR responses, Myers-Briggs leadership personality exercises, management skills, meeting etiquette, leadership development, capitalizing on local work groups, grant proposal writing, conservation easements, employee mentorship, working with non-conventional conservation partners, “selling” conservation to county officials who fund conservation, additional professional development of soft skills, providing quality technical assistance and conservation planning, serving customers with natural resource management concerns and providing effective conservation planning. 180 people serving in NC Soil and Water District positions attended these conferences in person. Online webinars were also held bringing the total number of people served to 789.

The purpose of this project was to expand the North Carolina Agromedicine Institute's Tape & Twine program to help the state's farm community deal with escalating farm stress and improve emotional wellness. This is important because although farming and stress are synonymous, the farm community continues to experience levels of stress not seen for decades. Escalating stress is due to compounding stressors, including depressed market prices, increased production costs, tariffs, foreign trade competition, catastrophic weather, increased labor costs, increased farm-land tax valuation, intergenerational legacy pressure, development encroachment, litigation in the pork industry, environmental mandates, commodity of scale, immigration issues, increased regulations and more. Over the course of the project, more than 12,000 individuals have been served directly through training/outreach and/or behavioral health services. Awareness of and conversations about farm stress and available resources are apparent in all regions of the state and among the diverse groups that make up NC's agricultural community. The Institute has been able to move from simply providing training and increasing awareness about the recognition and management of farm-related stress to providing peer support, suicide intervention/prevention, direct behavioral health services, and improving skills of health/behavioral healthcare providers working to mitigate behavioral health issues in agricultural communities. The Institute's Tape and Twine Program is now the comprehensive Farm and Ranch Stress Assistance of North Carolina (FRSAN-NC) program which also includes a 24/7 NC Farm Help Line.

The grantee worked with county representatives in 33 counties across eastern NC to fund innovative projects through its AgPrime program which supported agricultural profitability and productivity. Each project was funded based on its potential to positively benefit the economic development of the respective local communities, agricultural diversification, farm profitability, and skill and resource development for current and future farmers. The project was administered as a cost share project funding more than 54 farms. AgPrime provided resources directly to farmers to assist in farm diversification and expansion. The project also increased the economic sustainability of farms. 226 jobs were created and 479 jobs sustained in addition to the 22,803 acres of farmland impacted. There has been nearly 1,200 acres of new crop production and a total of over \$2.6 million in products sold. A total of \$775,697 was leveraged from other sources by the funded projects.

The grantee surveyed 26 farms that grow heirloom tomato varieties, and the majority (65%) have gray leaf spot (GLS). Of the farms with GLS, disease severity ranged from 20 to 90% leaf area affected. This is a greater incidence and severity of GLS than they had anticipated and could potentially be affecting even more growers than initially hypothesized. They evaluated 10 spray programs for control of GLS and identified seven conventional spray programs and one organic spray program that effectively reduces this disease for growers. Previously, there were no studies published that evaluated effective fungicides – conventional or organic. Results have been published in Plant Disease Management Reports (Kohutek et al., 2023, PDMR 17: V086), updated in the disease factsheet on GLS on tomato (<https://content.ces.ncsu.edu/gray-leaf-spot-of-tomato>), and results presented at the Winter Vegetable Meeting in 2023 and 2024. Similarly, the grantee has identified three cultivars and 18 breeding lines that are resistant to gray leaf spot that growers can now deploy. The results generated from this project will allow growers to manage gray leaf spot of tomatoes more effectively by 1) selecting a fungicide program that effectively reduces disease and 2) selecting resistant varieties for farms that have a high level of this disease. In addition, the knowledge of breeding lines susceptible or resistant will allow breeders to better select varieties as parental lines for hybrids so that more varieties are available with resistance.

The purchase of both a lime and a manure spreader provide county farmers with a means to improve soil health, soil fertility and water retention as well as the responsible use of animal waste. Lime applications can assist farmers with balancing their pH which helps reduce weed pressure and the lime spreader provides landowners with the ability to utilize the less expensive powdered lime instead of pelletized. The manure spreader helps provide nutrients back into the soil instead of potentially creating a water quality hazard from run off carrying nutrients and pathogens into local waterways. The application of both lime and manure helps plants to better utilize nutrients in the soil and the improved microbiome can increase soil's water holding capacity which in addition to improving growth and plant health, also assists plants in weathering drought. The program is designed to give farmers the ability to better manage their lands, while being protective of their bottom line.

The NCSU Agricultural Institute "Soldier to Agriculture" program is a 6-week intensive introduction to agriculture for transitioning service members, veterans, and spouses interested in a career in agriculture in North Carolina. The program currently serves approximately 75 students per year with a waiting list of over 500 prospective students. Since becoming part of the DOD bridge program, soldiers from all NC bases now have access to the program. With this bigger audience, the grantee intends to recruit more students to become small farmers or employees in the 33 counties designated in the NC Sentinel Landscape Program.

Status: The grantee has provided seven sessions so far of the Soldiers to Agriculture course which included coursework, hands-on experiences, and internships. Approval was obtained to participate in the Career Skills Program and recruit transitioning service members on Ft. Liberty. Its goal is to improve the profitability of farmers who have been financially impacted by tobacco-related policy and social changes by cost-sharing Berkshire pigs using hoop-structure barns. Central Carolina Community College (CCCC) will outfit its new, state-of-the-art, 3,690-square-foot large animal facility with equipment to support the training of Veterinary Medical Technology students on common domestic large animal species. Students will learn basic husbandry and handling of large animal species, while simultaneously understanding the importance of pasture management and the nutritional requirements of livestock species. Completion of the facility will facilitate training of approximately 105 students per year with an estimated 83% of new full-time students receiving credentials within three years. These students will help address the dire need for large-animal veterinary services in rural areas.

The program awards cost-share grants to family farms to diversify, expand, or enhance their agricultural operations. The overall goal is to increase farm profits. Agricultural Education faculty in NCSU's College of Agriculture & Life Sciences (CALS) will provide a 10-day, intensive Curriculum for Agricultural Science Education (CASE) Institute training for North Carolina agriculture teachers. CASE is an inquiry-based, STEM-oriented agriculture curriculum. CASE enhances the rigor and relevance of agriculture, food, and natural resources content and provides purposeful enhancement of science, mathematics, and the English language. Wingate University launched an agricultural food systems concentration in the fall of 2022 to build on Union County's agricultural strength while also addressing pockets of food insecurity. NC State Extension Community and Rural Development will lead and execute the project in partnership with The NC Agricultural Foundation, Inc. The project will provide a menu of training options to farmers, helping them to target farm health and safety needs and assist with mandatory training compliance needed for GAP certification and EPA Worker Protection Standards. The training will be available to be conducted on-farm and multi-farm at the community sites. The project outcomes will include increasing knowledge and preventive behaviors to produce high-quality crops, providing a healthy work environment, and increasing the ease of compliance with mandatory training.

Status: The grantee surveyed farm owners and/or farm managers to learn about mandatory and non-mandatory training needs. The data collection steps included attending annual grower production meetings, tobacco GAP, and sweet potato production meetings in Wilson, Nash, and Edgecombe. The project educator and coordinator also conducted follow-up phone calls, text messages, and in-person farm visits to increase survey participation. Most respondents reported tobacco and sweet potato as the top crops requiring farm labor, 88% and 75%, respectively. Other crops reported to require less than 20% each were cucumber, watermelon, and strawberries. The suggestions included online videos, study guides, providing a training book, and having an intermediary between the farm owner and the employee. The identified training needs supported the development of a preliminary menu, including the training offered by the Extension Farmworker Health and Safety Program. Given that Spanish is the primary language

of most farmworkers, the menu lists training provided in Spanish and is free of charge unless otherwise specified.

CAFE's new commercial kitchen facility at the WNC Farmers Market will serve early-stage food entrepreneurs preparing foods, cosmetics, and natural products. Four County Electric Membership Corporation (FCEMC) will purchase a hydroponic smart farm container. FCEMC Smart Farm will be a controlled-environment shipping container, creating community-centered programs targeting health and wellness, job skills, mental health, and education. In partnership with James Sprunt Community College, the hydroponic smart farm will provide benefits to students, local farmers, and businesses by encouraging hands-on learning and onsite tours. The space allows for a 24/7 controlled environment with irrigation and LED lights

creating an environment for learning and growing. Annual harvest will be between 2-4 tons of fresh, hyper-local produce without pesticides or herbicides.

A dedicated course was created around hydroponic farming practices. The three-week course is named “Hydroponics: Growing without Soil”. It provides students with hands-on experience and practical knowledge of modern agricultural techniques. For the first cycle, the grantee planted 2,016 seeds, and with a 98% germination rate, 1,890 plants should grow to maturity.

# Ribbon-cutting officially ushers in hydroponic farming at JSCC

WARSAW — A crowd gathered on the WestPark campus of James Sprunt Community College (JSCC) Monday at 10 a.m. for a ribbon-cutting ceremony at the school's new Hydroponics Smart Farm, where the first produce has already been harvested.

The Hydroponics Smart Farm — dubbed "Box to Bowl" — is the result of a partnership that includes JSCC, Four County Electric Membership Corporation, North Carolina's Electric Cooperatives, Duplin County, and the **North Carolina Tobacco Trust Fund Commission**.

Box to Bowl consists of a 40-foot-long shipping container that provides growing area equal to two acres of land, in which plants are grown in a controlled environment absent soil and pesticides. Seeds are planted in a medium of coconut husk and peat moss, fed nutrient-rich water, and nurtured under special LED lights; after two to three weeks, mature seedlings are transferred to vertical panels, where they grow for three to four weeks before the plants are harvested.

The container arrived at JSCC in March and Box to Bowl was up and running in April.

At Monday's ceremony, following opening remarks by Duplin County Manager Bryan Miller and an invocation by Warsaw Mayor A.J. Connors, Dr. Jay Carraway, president of JSCC, addressed the crowd. He began by thanking Duplin County commissioners, as well as N.C. Representative Jimmy Dixon and N.C. Senator Brent Jackson, and went on to mention three people whom, he noted, "...were it not for them, we wouldn't be here": Renee Sutton, chief of staff at JSCC; Greg Sager, with Four County EMC; and Carrie Shields, Duplin County assistant manager. "Those folks carried the water with this project," Carraway said. "A lot of folks have chipped in, but without them, we wouldn't be here."

Speaking on behalf of Four County EMC was Chief Executive Officer Don Gatton, who noted that the challenges faced in traditional farming, such as unpredictable weather and water scarcity, bring opportunities for growth, innovation, and resilience. "This Hydroponics Smart Farm embodies the spirit of innovation and resilience," he said, also predicting that its impact will be felt beyond the JSCC campus.

Mark Harrell, with the N.C. Tobacco Trust Fund, praised the passion that both JSCC and Four County EMC brought to the endeavor. "When we first discussed the idea with Four County, we could already see that this project was going to be a success," he said, going on to point out, "The Hydroponics Smart Farm will benefit local farmers, students, and businesses by encouraging hands-on learning and onsite tours."

N.C. Representative Jimmy Dixon addressed the fact that hydroponics is a sustainable farming method, by asserting that traditional farming, as it's been practiced "since Adam was cast out of the Garden of Eden," is also sustainable. "This facility will *never* replace the traditional farmer," he insisted, before stating, "This is just another tool to implement the great sustainability that American farm families have produced over these many years."

N.C. Senator Brent Jackson congratulated those involved with this project for being innovative, encouraging them to "...look and learn and take it to the next generation."

In wrapping up the comments portion of the program, JSCC's Sutton praised the groups that partnered with the school to make Box to Bowl a reality. "I can honestly say, this was a true partnership not just in name only, but all of our partners came to the table and they contributed financially and they also worked," she said.

After the official ribbon-cutting took place, JSCC agriculture instructor and lead faculty member for the project Katlyn Foy led tours of the Box to Bowls operation. Finally, all in attendance were invited to snack on lettuce wraps made with lettuce harvested from the facility.

# Suicides in agriculture industry bring awareness to mental health

In 2023 there were three confirmed suicides of agriculture workers in the state of North Carolina. While this may not seem like a lot, the sad reality is that the real number is likely much higher; in order to protect their families, agriculture workers often make suicides look like accidents.

“There is very limited data on agriculture suicides, especially in recent years (2022, 2023), and that is a problem,” Robin Tutor Marcom, EdD, MPH, Director of the North Carolina Agromedicine Institute, told the Carolina Journal. “The fact that there were three known suicides in 2023 and that level of illness requiring hospitalization, for us to have that many in a year is very concerning. Farming and stress are synonymous.”

According to a [policy brief](#) by the National Rural Health Association the suicide rate among farmers is 3.5 times higher than that of the general population. Male agriculture workers have a significantly higher rate of suicide deaths, at 43.2 per hundred thousand, when compared to the average of 27.4 per hundred thousand across all other populations, according to the brief.

Major contributing factors to mental health struggles include financial struggles, social pressure, and reduced access. Many farmers are reluctant to seek out mental health care as it can be difficult to keep personal affairs private in the small rural communities in which they live. Fear of stigma and discrimination is also a contributing factor.

Even for those who want to seek help, mental health services are often limited, if available at all, in rural communities.

“...those resources are out there in North Carolina, and I know the North Carolina Agromedicine Institute at East Carolina University has worked on this issue,” said North Carolina Commissioner of Agriculture Steve Troxler. “What I can tell you is that one farmer suicide is too many. We need to make sure that people get the help that they need and make sure that they’re not ashamed of it. Farming is a stressful, stressful, stressful business. There is so much money involved in it and the risks are so high that you know that’s the big problem. We saw the massive increase in inputs and agriculture over the past several years and what that means is you’ve got much more invested in a crop and if you do have a disaster, you’ve lost much more money.”

“We don’t do any farm session without talking about mental health,” said Marcom. “We are not going to interface with any farmer or farm family member without having this conversation. It really is about starting the conversation and reducing the stigma so that people aren’t suffering in silence. It’s okay to have those conversations and understand that conversation is not weakness.”

The work being done by the Institute and the systems put in place are working.

“We have this happen all the time where someone has recognized an individual in need of help and called themselves or helped that person connect, so we can save lives with the work we do,” said Marcom.

As with other industries, financial stressors are one of the biggest contributing factors to the state of mental health among agricultural workers. As Commissioner Troxler explained, farmers are investing more money along with a growing list of uncontrollable factors such as: weather, inflation, and [the pandemic](#) disruptions. While farmers are investing more money, profits have been squeezed in recent years.

“Some, like dairy farmers, are getting paid less than they ever did before for their milk, so there’s so many different factors and it is a hard job because they don’t get vacation days or sick days. It’s like a 24/7 type job,” said Troxler. “They’re providing food and other things for people you know in the state and across the country, it is hard absolutely...There’s a difference in what a farmer does and working, you know, a job somewhere else.”

The North Carolina Agromedicine Institute is working hard to remove the stigma and make mental health services available to agriculture workers and their families. The Institute is the flagship in North Carolina for work related to farm stress.

The Institute encourages education and awareness to start the conversation and make people aware of the signs and symptoms of depression and anxiety. They offer certified training in mental health first aid, QPR (Question, Persuade, Refer) and CALM (Counseling on Access to Lethal Means). All training is free and available across all 100 North Carolina counties.

“We also have NC Farm Helpline available 24/7, anyone can call, and we can get them linked to services,” said Marcom. “This helpline is not restricted to mental health issues but is available for any farm related issue including production, legal issues etc.”

The Institute also offers mental health services at no cost to farmers, families, workers and anyone working or living in the farming environment.

“Individuals can call the farm helpline or me (Robin Marcom) directly and they will be connected to a mental health professional that understands mental health and the farming culture,” said Marcom.

The Institute’s program funding comes from several sources, including **North Carolina Tobacco Trust Fund Commission**; Farm Credits Of North Carolina; the North Carolina Farm Bureau; the Corn Growers Association of NC; and, the NC Department of Agriculture (via USDA).

“Our goal is that if an individual in the community is in need of help, if they are experiencing any kind of mental health issue, that someone in their daily circle would recognize the issue and know where to reach out for help for them,” said Marcom.

In August, Rep. Yadira Caraveo, D-CO 8th, [introduced](#) a [bill](#), known as the National Agricultural Crisis Hotline Act, which would establish through the US Department of Agriculture (USDA) a hotline to provide mental health support for agriculture workers and their families. This bill would amend the Food, Conservation and Energy Act of 2008.

“I think the most important thing is that people need to understand that the mind and the spirit is not separate from the body,” said Marcom. “When we talk about mental health it can affect a person’s overall wellness, our spirit, and our mental health. We aren’t Ichabod Crane, our head and our body are not separate beings, they go together.”

# Boutique Meat

The traditional butchery is coming back as an offshoot of the farm-to-table movement

Agriculture and agribusiness drive the North Carolina economy. It is the number one industry in the state, employing as much as one-fifth of the workforce. NC State University cites the economic impact as topping \$103 billion.

Just one to two generations ago, before the widespread proliferation of big box stores, it was common for people to raise their own livestock in rural areas and go to a butcher for butchering the meat.

In the past decade backyard and boutique farms have sprung up as consumers seek fresher, higher quality foods. Covid caused this movement to surge from the Birkenstock crowd into the country club and boardroom crowd.

As a result, a resurgence in both retail outlets and personal sourcing of freshly butchered meats, from beef to pork to poultry, has occurred. Demand has birthed an increasing number of entrepreneurial producers using online ordering, rapid cold shipping, and social media to create sales.

In Wilmington a newer retail outlet offering freshly cut meats is The Butchers Market, a butcher shop and specialty market opened in March 2022 at Oleander Pointe, the former Toys R Us shopping center.

“We are the only specialty grocery in town that butchers all of our meat,” says general manager Mike Murrill, who has 30 years of retail grocery experience.

The locally owned market purchases beef from just three cattle producers for consistency and quality.

“The big box groceries buy meat based on a price point. We buy our meat for quality,” Murrill says.

The market also offers prepared foods, produce, deli items, and other specialty groceries.

The local owner/partner is Smith Prevost. His parents have lived in Wrightsville Beach for 15 years, but he grew up in Cary and Raleigh. When he graduated from college, he did some catering and meat smoking. That was how he became a customer of The Butchers Market in Raleigh 11 years ago.

“I was a meat snob, I wanted that quality cut of meat,” says Prevost.

He attributes growing up hunting and fishing for his desire to know where the meat came from and where it was butchered.

“I know exactly where it comes from, that’s what got me into the butcher attitude,” Prevost says.

Besides the 55-foot-long fresh counter there’s a bank of freezers that contain some hard-to-find-specialty meats, including ground elk, kangaroo, antelope, chicken feet, alligator tail, crawfish, frog, ostrich, wild venison, wild boar, oxtail and beef tongue.

A second location in Wilmington is slated for the third quarter of 2024 in Porters Neck. There are three locations in Raleigh, and one in Cary, Wake Forest and Holly Springs.

This type of butcher’s market is not new to the area. The Pine Valley Market opened in Wilmington with a 24-foot meat counter more than 20 years ago in what had been a butcher’s market franchise of Wells Pork. This was at a time when it was uncommon to purchase meat outside of the corner grocery store.

In the late 1990s Lauren “Lolo” Shannon expanded beyond the hand-cut meat market in the shop on College Road. In addition to the fresh-cut meats, the shop now offered prepared foods and other goods.

In January 2003 new owners Christie Feretti and Kathy Webb continued the move away from hand-butchered meats.

“It took me all morning to cut the beef, pork and chicken for the case,” Feretti says.

The case is now 6 feet long.

Morphing with the times, including the 2008-09 recession and most recently the hard hit of the pandemic, a café was born.

“In Covid all things came to a head. People started going to local markets again,” Feretti says.

She met the demand with the café, while continuing prepared meals and gourmet items. However now the main thing is the catering and events company.

“As we expanded, the butchery shrunk,” Feretti says. “I don’t cut our steaks to order anymore. We stock them and we still carry full loins for events and they’re also available for sale.”

Feretti and Webb partnered with Matt and Christyanna Durand in May 2022.

A 2017 newcomer in retail catering as well as restaurant outlets is True Blue, which offers aged prime beef, local pork, and chicken at Butcher and Table on Military Cutoff, Butcher and Barrel on Greenfield Street, and Butcher and Baker in Hampstead.

“At these locations, you can walk up to the butcher counter and pick out your meat and say, ‘I want that steak for my meal,’” says Kat Dennett, True Blue business manager.

She says by far the biggest butcher sales they have are in Hampstead. They also offer butcher boxes by subscription and DIY kits as well as catering.

Moving out into the field, raising and breeding the livestock are Wilders, a farm in Turkey, North Carolina, and Northwest Land and Cattle in Leland. There are numerous other smaller operations that sell farm-raised meat at area farmers markets.

Wilders is a farming venture in Sampson County created at Christmas 2021, in the aftermath of the pandemic.

Husband and wife real estate development and construction team Reid and Jaclyn Smith expanded from their six business ventures in Clayton, North Carolina, into converting a 1,200-acre former equestrian estate for raising and breeding livestock.

Reid's father raised Simmental cattle in Clayton as he was growing up and he says he really wanted to get back to it.

During the Covid-imposed shutdown, the couple and their children moved into farming on their 40-acre Clayton farm, buying their first Wagyu cows. Their herd grew to 100 and they were looking for contiguous acreage to have their livestock, grow their own food for them and the livestock, plus add a social aspect to it. They closed on the Sampson County, 1,200-acre former Longhorn Creek Ranch two days before Christmas 2021. The next day they loaded up their cattle and children and celebrated the holiday on the farm in a travel trailer.

Wagyu is literally translated as "Japanese cows." The meat is described as beef with a rich creamy, buttery taste. With strict registration and DNA parentage testing, pure Wagyu is the most expensive beef money can buy.

Reid and Jaclyn are able to trace all their cows back to their original lineage.

“We know dating back four to five generations what their lineage is. We actually use that in our matings, as we are trying to improve our genetics,” says Reid.

In addition to the Wagyu beef herd, now numbering 575 head, Wilders raises Berkshire pigs with 15 breeding sows and 2 boars.

All the cows and hogs are free range. The cows are grass fed and grain finished. Reid says the intent is to not use any hormones or medicines, or even grain, except at the end for flavoring. The Wilders farm also grows crops to feed the animals, including corn, soy and silage.

Wilders meats are sold at farmers markets in the Wilmington and Wrightsville area. There is also a freezer assortment at Motts Channel Seafood.

The new Wilders General Store is open on the farm in Turkey, N.C. A retail shop and parent company RiverWild’s headquarters are on Main Street in Clayton in the former North Carolina Paper Company building. All products ordered online are shipped frozen straight to the consumer’s door. The social media presence is strong.

RiverWild’s 140 plus employees are all encouraged to spend time on the farm.

“We’ve tried to open that up to employees to experience agriculture. A lot of our employees say that’s their only chance to be on a farm, to experience that,” Jaclyn says.

They are creating an agricultural experience for the public through agritourism at the farm.

“Our goal, our message, is support your local farmer, buy from your local farmer,” Reid says.

Founded in 1898, Leland’s Northwest Land and Cattle’s operation is multigenerational on both sides of the family tree. AJ Stanaland is a fifth-generation Brunswick County farmer with a passion for agriculture. Her husband, Wade, is also a fifth-generation farmer. At W & S Farms in Bladenboro, North Carolina, they also farm approximately 4,000 acres with Wade’s father.



Stanaland is carrying on her family's legacy on the same land they have continuously farmed for five generations along Northwest Road NE, Leland in Brunswick County. In addition to her on-the-job training growing up, Stanaland graduated from North Carolina State University with a degree in agricultural business with a concentration in livestock management. Steve McMillan

Together they are raising children, crops, cattle and hogs. Twin sons are competing in goat roping rodeo events.

The Northwest Angus beef cattle herd numbers 650, and along with heritage hogs on 650 acres, they grow haylage of sorghum, ryegrass and oats, along with Bermuda hay and bale peanut hay. Row crops are peanuts, corn and soybeans.

Moving away from the way the family had always sold their meat, AJ started selling direct to the consumer in 2019, with personal deliveries and online sales. Her storefront opened in 2021 with a small grant from the **North Carolina Tobacco Trust Fund Commission**.

Her great-great grandfather Gaylord created the pack house, where the family once packed tobacco to go to market. The family repurposed it. Half of the facility is used to pack and ship meat directly to consumers, while the other half is a storefront open six days a week. The company also offers an after-hours freezer pick up for online orders.

"Our main thing is the farm club subscription, which gives the consumer a discount for beef and pork purchases," AJ says.

The family is also growing an agritourism event space used in the fall with a feed lot and a pumpkin patch, live music, food trucks, vendors, and kids' activities. Everything is updated to the public via social media.

Both Wilders and Northwest Land and Cattle offer seasonal reservations for whole and half cows for bulk purchase.

The group mixed hands-on learning activities with various Farm Tours, focusing on the many diverse options within the field of agriculture. Participants toured The Young Outlaw Ranch, a veteran-owned, first-generation livestock consumption ranch in Dudley, NC. They visited Whitaker Farms, a farm, bakery, and agritourism hotspot in Climax, NC. Veteran-owned Secret Garden Bees in Linden, NC, gave participants a behind-the-scenes look at honey production and marketing. A trip to Bayer Crop Science in Mount Olive gave students a glimpse of agriculture research and innovation.

At the halfway mark of the week, campers volunteered at the Tobacco Farm Life Museum in Kenly and at Howell Woods in Four Oaks. They landscaped, cleared trails, painted cabins, and moved livestock feeders.

Never failing to end each day with a bang, students had the opportunity to visit the NC Zoo in Asheboro, NC; elevate their heights at URBAN AIR Trampoline Park in Fayetteville, NC; and eat their fill at an ice cream social complete with water activities.

Beyond learning about the state's number one industry, students gained life skills at an etiquette dinner designed to show them how to engage with business associates during a meal properly. "I had so much fun at this camp," said Eva Herrera, a sophomore from Millbrook High School in Raleigh. "It has been a great week to build our knowledge in many areas and has given us many good ideas."

"The SAE Camp has allowed me to understand a new perspective for experiential learning outside of the classroom," said UMO alumna Julia Coltrain, an advisor from Bandys High School in Catawba County. "I now feel confident that I can return to my program and teach students how to develop meaningful SAE projects that will prepare them for their future careers."

Shade Wilbanks, a 2023 UMO alumna, has experienced the camp on all levels: as a camper, as a counselor, and this year as a high school FFA advisor from Knightdale High School in Wake County. "I have seen and experienced the value of this camp from many perspectives," she said. "This year, I particularly enjoyed the deep dive into The AET record keeping software."

The **North Carolina Tobacco Trust Fund Commission** funds the SAE camp at UMO through a sponsored program grant. Since its inception in 2017, the camp has helped educate over 200 future agriculturalists to grow their SAE projects through their participation in the National FFA Organization.

"The SAE Camps held at UMO are significant for students because they get hands-on agriculture-related learning experiences that they might not otherwise receive," said Edward Olive, Director of the Lois G. Britt Agribusiness Center at UMO. "The activities provide participants with opportunities to develop leadership and a work ethic that will serve them throughout their college and careers.
